COMMONWEALTH OF PENNSYLVANIA v. VOLODYMYR ROMANOVY BOICHUK

OPINION

Volodymyr Romanovy Boichuk has filed a counseled petition pursuant to the Post Conviction Relief Act (PCRA), 42 Pa.C.S.A. §§ 9541-9546. For the reasons set forth below, this petition will be denied following a hearing.

I. BACKGROUND

The relevant facts and procedural history may be summarized as follows. On August 2, 2018, the police were dispatched to the Manheim Auto Auction in Penn Township, Lancaster County, PA. An employee of the Auction had observed Boichuk entering and exiting multiple luxury vehicles in the sales lot — an area not accessible by the general public and fenced in with attached "authorized access only" signs. Upon inspection of the vehicles, the employee found the navigation chips and key fobs missing. The employee confronted Boichuk and recovered multiple navigation chips and key fobs valued in excess of \$10,000.00 for the vendor. Boichuk neither owned nor had authorized control over either the vehicles entered or the fobs and chips taken. As a result, Boichuk was arrested and charged with theft by unlawful taking — movable property, 18 Pa.C.S.A. §3921(a).

Having been denied admittance to the A.R.D. Program, Boichuk tendered a negotiated guilty plea to the charge on February 27, 2019. After conducting a lengthy on-the-record colloquy, the Court accepted the guilty plea as knowingly and voluntarily given, and sentenced Boichuk in accordance with the plea agreement to three years' probation, a \$100.00 fine, and the costs of prosecution. (Notes of Testimony, Guilty Plea (N.T.) at 6.) No post sentence motion or direct appeal was filed. Boichuk was represented at the guilty plea hearing by privately retained counsel, Christopher A. Sarno, Esquire ("Attorney Sarno" or "trial counsel").

On February 21, 2020, Boichuk filed a timely¹ counseled petition for post conviction relief challenging the effectiveness of his trial counsel. Specifically, Boichuk claims counsel: (1) misadvised him that

¹ For the purposes of the PCRA, "a judgment becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of the United States and the Supreme Court of Pennsylvania, or at the expiration of time for seeking the review." 42 Pa.C.S.A. §9545(b)[3]. Here, Boichuk did not file a direct appeal. Accordingly, pursuant to Section 9545(b), Boichuk had one year from the expiration of his 30-day appeal period, or March 23, 2019, in which to file a timely PCRA petition. Boichuk filed the instant petition on February 21, 2020; therefore, the petition is timely.

he was facing a maximum of seven years incarceration; (2) failed to advise him that his sentencing guidelines were RD-9; and (3) failed to discuss his chances at trial versus the benefits of the plea. See PCRA Petition at ¶¶ 12-17. The Commonwealth replied to the PCRA petition on March 31, 2020, denied the allegations, and requested that the PCRA petition be dismissed.

On June 6, 2020, the Court granted Boichuk an evidentiary hearing "limited to the issues of whether 'prior counsel... discuss[ed] the pros and cons of Defendant's chances at trial versus the benefits of the plea' and whether trial counsel 'explain[ed] the advantages and disadvantages of the offer." On August 8, 2020, the Court entered an Order scheduling the evidentiary hearing for September 23, 2020, and directed Bail Administration to ensure that a Ukrainian language interpreter would be available and present at the hearing. After one continuance, the hearing ultimately occurred on October 14, 2020, as an in-person proceeding, with all parties and the interpreter present, following standard COVID-19 safety protocols, including masking and social distancing.² Attorney Sarno and Defendant Boichuk testified, with Boichuk utilizing a Ukrainian language interpreter. Briefs having been filed by the parties, this matter is now ripe for disposition.

II. ELIGIBILITY FOR PCRA RELIEF

Initially, the Court notes that "[t]he entry of a guilty plea constitutes a waiver of all defenses and defects except claims of lack of jurisdiction, invalid guilty plea, and illegal sentence." *Commonwealth v. Kennedy*, 868 A.2d 582, 593 (Pa. Super. 2005). Boichuk has not challenged the jurisdiction of this Court nor does he challenge the legality of his sentence. Petitioner's pleading does, however, dispute the validity of his plea. Specifically, Boichuk claims his guilty plea was unlawfully induced by trial counsel's ineffectiveness.

"A criminal defendant has the right to effective counsel during a plea process as well as during trial." *Commonwealth v. Hickman*, 799 A.2d 136, 141 (Pa. Super. 2002). The law presumes that counsel rendered effective assistance. *Commonwealth v. Spotz*, 18 A.3d 244, 259-60 (2011). To overcome this presumption, a petitioner must show that (1) the underlying substantive claim is of arguable merit, (2) counsel had no reasonable basis for this conduct, and (3) the ineffectiveness caused the petitioner prejudice. *Id.* at 260. To establish prejudice, a petitioner must demonstrate that "there is a reasonable probability that but for the act of omission in question, the outcome of the proceedings would have been different." *Commonwealth v. Spencer*, 892 A.2d 840, 842 (Pa. Super. 2006).

The petitioner bears the burden of proving all three prongs of this test. *Commonwealth v. Meadows*, 787 A.2d 312, 319-20 (2001). "A failure to satisfy any prong of the ineffectiveness test requires rejection

² On March 17, 2020, the Court issued its first in a series of administrative orders declaring a judicial emergency in response to the COVID-19 pandemic. Since that time, the administrative orders have been continuously extended, allowing the Court to operate under varying degrees of restriction in order to meet the needs of both its employees and the public as safely and efficiently as possible. All participants at the Evidentiary Hearing were required to wear face masks throughout the proceedings except for witnesses while testifying and attorneys while conducting witness examinations.

of the claim of ineffectiveness." *Commonwealth v. Daniels*, 963 A.2d 409, 419 (2009). Thus, where a petitioner has not met the prejudice prong of the ineffectiveness standard, the claim may be dismissed on that basis alone without a determination of whether the arguable merit and client's interest prongs have been met. *Commonwealth v. Wright*, 961 A.2d 119, 148-49 (2008); *Commonwealth v. Zook*, 887 A.2d 1218, 1227 (2005).

III. DISCUSSION

A. Issues Not Addressed at Hearing

The Court will first address the two issues raised in Boichuk's original PCRA filing for which no evidentiary hearing was granted.

i. Maximum Sentence

Boichuk initially claims he was misadvised that he was facing a maximum of seven years incarceration for the offense of theft by unlawful taking — movable property. See PCRA Petition at ¶¶ 12-14. This charge is a felony of the third degree punishable by up to seven years of imprisonment and a \$15,000.00 fine. See 18 Pa.C.S.A. 1103(3). Accordingly, trial counsel's advice was, in fact, accurate. This maximum sentence was also accurately reflected in the written guilty plea colloquy signed by Boichuk (see Guilty Plea Colloquy at ¶¶ 34-35), and accurately covered by the Court in the oral guilty plea colloquy. See N.T., Guilty Plea at 3. Because Boichuk was correctly advised of the seven-year statutory maximum exposure of the charge to which he was pleading guilty, there is no meritorious claim that he was misadvised by his trial counsel.

ii. Guidelines Sentence

Next, Boichuk claims he was not advised by trial counsel that he was facing a guideline sentence of RS-9. *See* PCRA Petition at 5. The Sentencing Guidelines Worksheet that was admitted as part of Boichuk's guilty plea reflects the correct guidelines of RS-9. See Sentencing Guidelines Worksheet. Boichuk signed the Guilty Plea Colloquy in which he admitted reviewing the sentencing guidelines with his attorney.³ See Guilty Plea Colloquy at ¶ 31. The Court further advised Boichuk during his guilty plea colloquy that his sentencing guidelines were RS-9 for the offense charged. N.T., Guilty Plea at 3-4. As the record establishes that Boichuk was advised by both trial counsel and the Court at the time of the guilty plea that the sentencing guidelines were RS-9, this claim lacks merit.

B. Counsel's Advice Regarding Negotiated Plea/Trial

Lastly, Boichuk claims that counsel did not discuss with him "the pros and cons of [Petitioner's] chances at trial versus the benefits of the plea," and that he further failed to "explain the advantages and disadvantages of the offer." See PCRA Petition at $\P\P$ 15-16.4 It was for

³ Testimony at the Evidentiary Hearing necessarily covered this issue, with Attorney Sarno recalling that he "definitely" presented and explained the Sentencing Guidelines Worksheet to Boichuk prior to the guilty plea even though Boichuk failed to sign the paperwork. N.T., Evidentiary Hearing at 12. Boichuk testified that either he did not see the Sentencing Guidelines Worksheet, or if he did see it, he did not understand it. Id. at 35, 37. The Court finds Attorney Sarno's testimony on this point credible and Boichuk's testimony evasive and not credible.

⁴ Importantly, Boichuk's claim here is for ineffective assistance of counsel for failing to discuss the merits of

these limited questions only that the Court heard evidence on October 14, 2020.

The record in this case belies Boichuk's assertion. First, prior to the Guilty Plea hearing, Attorney Sarno and Boichuk utilized the duly sworn interpreter to review together the 78-paragraph Guilty Plea Colloguy, which covered every aspect of Boichuk's rights as a criminal defendant, the consequences of his pleading guilty, his satisfaction with his attorney, and his appellate rights upon entering a guilty plea. See Guilty Plea Colloquy at ¶¶ 10-28, 49-78; N.T., Guilty Plea at 2-3, 5. Second, at the Guilty Plea hearing itself, Boichuk neither protested nor contradicted Attorney Sarno's representation to the Court that he had discussed the case with Boichuk, including the Sentencing Guidelines Worksheet, and that Boichuk was making a knowing and voluntary plea. N.T., Guilty Plea at 5. Boichuk never indicated to the Court any dissatisfaction with the services of his attorney or the interpreter, or any lack of understanding of the charges, proceedings, or consequences of entering into the negotiated guilty plea. During the oral colloquy, Boichuk acknowledged reviewing the written colloquy with counsel through the interpreter and stated he had no questions with regard to the document. N.T., Guilty Plea at 4.

The credible testimony given at the Evidentiary Hearing confirms that Attorney Sarno provided competent and effective advice and assistance throughout his representation of Boichuk. It was Boichuk, initially speaking through friends as interpreters, who expressed to Sarno that his primary concern was getting and staying out of jail. Boichuk maintained this position consistently, and as such, Attorney Sarno focused his representation on negotiating a favorable plea agreement rather than on discussing possible trial strategies with Boichuk. N.T., Evidentiary Hearing at 14-15, 19-20. Attorney Sarno testified that "[w] ith this particular case, it was less about the facts. All [Boichuk] cared about was what he was going to get, so we always continually went back to his offer and what he wanted." N.T., Evidentiary Hearing at 14. Counsel noted "this was one of those cases where [Boichuk] cared less about the question of being guilty or not guilty and more about what he was going to get. He never raised any objection to me about pleading guilty." Boichuk never denied his guilt to Sarno, never offered an alternative narrative to the events alleged by the Commonwealth (whose evidence included eyewitness testimony), and never provided either Sarno or the Court with any information to indicate he was innocent of the charges. Id. at 19-20, 25. Even when Attorney Sarno advised Boichuk there could be immigration consequences resulting from a guilty plea, "[Boichuk] still wanted to move forward." 5 Id. at 26.

S Subsequent to pleading guilty, Boichuk was detained by immigration officials. N.T., Evidentiary Hearing at 45, 53-55. It appears to the Court that these immigration consequences are more the gravamen of Boichuk's complaint than the effectiveness of his counsel's representation. However, Boichuk has alleged neither that Attorney Sarno failed to advise him nor that Sarno incorrectly advised him regarding immigra-

a plea over a trial; the claim is not that Boichuk was induced to enter the guilty plea when he was actually innocent (pursuant to 42 Pa.C.S.A. §9543(a)(2)(ii)). Boichuk claimed at the Evidentiary Hearing for the first time that he did not commit the crime, or that if he did, it was not knowingly done. Viewing the record as a whole, the Court cannot find this claim credible. Boichuk had ample opportunity to declare his innocence throughout the proceedings and on direct appeal. He failed to do so. Instead, Boichuk affirmed as true those facts recited at the Guilty Plea hearing, and he chose to forego both a post sentence motion and a direct appeal. N.T.,Guilty Plea at 4-5.

The Court finds Attorney Sarno's testimony credible. Taking into consideration Boichuk's admissions to Sarno, coupled with his expressed wishes to avoid incarceration, and the Commonwealth's evidence, Attorney Sarno effectively negotiated a plea agreement that was in Boichuk's best interests and also in alignment with his primary goal of avoiding incarceration. Since Attorney Sarno had a reasonable, rational basis for advising Boichuk to accept the negotiated plea agreement and to enter the guilty plea, he rendered effective legal representation. See Commonwealth v. Timchak, 69 A.3d 765, 770 (2013)(guilty plea colloquy, statements made at guilty plea, and defendant's pre-trial desire to enter plea gave counsel reasonable basis for failure to discuss trial strategy). Boichuk has not and cannot meet his burden to overcome the presumption of effectiveness and is not entitled to post conviction collateral relief. Commonwealth v. Wright, 961 A.2d 119, 148-49 (2008); Commonwealth v. Zook, 887 A.2d 1218, 1227 (2005).

Although the Court has found that Attorney Sarno's representation was competent and effective, it would be remiss for the Court not to address Boichuk's claims, raised for the first time in his PCRA, that he "had difficulty understanding the proceedings" of the Guilty Plea because he was provided with a Russian interpreter and he is Ukrainian. See PCRA Petition at ¶ 3. This assertion amounts more to a direct challenge of whether Boichuk entered his plea knowingly than it does to whether trial counsel rendered ineffective assistance. Unfortunately, Boichuk waived any direct challenge to the knowing and intelligent aspects of his plea when he failed to raise the issue on direct appeal. 42 Pa. C.S.A. §9544(b); see also Commonwealth v. McGriff, 638 A.2d 1032, 1036 (Pa. Super. 1994) ("Ordinarily, failure to petition to withdraw a plea, combined with failure to pursue direct appeal will bar consideration of an attack on one's plea in a collateral proceeding.").

Even if Boichuk had not waived the issue, however, the claim lacks credibility. At the Guilty Plea hearing, an interpreter was duly sworn to translate the proceedings from English into Ukrainian and from Ukrainian into English, which he did. N.T., Guilty Plea at 2. Boichuk never protested to trial counsel or the Court that he could not understand the interpreter or the proceedings. In fact, Boichuk and the Guilty Plea interpreter had waited together in the hallway outside the courtroom for over an hour the morning of the Guilty Plea hearing, "and they were talking as well, laughing . . . they had a conversation going on for quite some time." N.T., Evidentiary Hearing at 23-24. Attorney Sarno learned from the Guilty Plea interpreter that the Ukrainian and Russian languages are so closely related that the difference between the two is akin to the difference in dialects of the same language. Id. at 24. The interpreter present at the Evidentiary Hearing confirmed this in the following exchange:

Court: Are there times where – when you are speaking Ukrainian, you also

tion consequences. Moreover, the record clearly establishes that both Attorney Sarno and the Court alerted Boichuk to the possibility of immigration consequences resulting from his guilty plea. N.T., Evidentiary Hearing at 26; see also Guilty Plea Colloquy at \P 9.

use Russian words?

Interpreter: Yes, Your Honor, this is inevitable. These languages are intertwined.

N.T., Evidentiary Hearing at 41. Further undermining Boichuk's claim of not understanding the interpreter is the fact that he completed the 78-paragraph written Guilty Plea Colloquy without once objecting to the services of his interpreter. When questioned at the Evidentiary Hearing about his ability to understand the Guilty Plea interpreter, Boichuk could only answer evasively. N.T., Evidentiary Hearing at 39-41. The Court is satisfied that Boichuk understood the interpreters at both hearings, and that he consequently understood the substance of both the written and oral plea colloquies as well as the Sentencing Guidelines Worksheet. To put a finer point on this issue, the Court finds Boichuk to be totally lacking in credibility. Any suggestion that Mr. Boichuk had any difficulty understanding the interpreter is merely an attempt to avoid responsibility for a decision that was knowing, voluntary, and intelligent.

IV. CONCLUSION

For the reasons set forth above, Volodymyr Boichuk's petition for post conviction collateral relief must be denied.

Accordingly, I enter the following:

ORDER

AND NOW, this 16th day of April, 2021, upon consideration of Volodymyr Romanovy Boichuk's petition for post conviction collateral relief, the briefs filed by the parties, and after a hearing in this matter, it is hereby ORDERED that said petition is DENIED.

Pursuant to Pa. R.Crim.P. 908(E), this Court advises Boichuk that he has the right to appeal from this Order. Boichuk shall have 30 days from the date of this final Order to appeal to the Superior Court of Pennsylvania. Failure to appeal within 30 days will result in the loss of appellate rights.


