COURT OPINION

Starrucca Borough Council, et al

VS.

Gale Reddon, et al

No. 23 – Civil – 2022

Decided by: Matthew Meagher, J.

Summary of the Case

This case came before the Court on a Petition for Preliminary Injunction filed by the Plaintiffs, who are comprised of Starrucca Borough Council and four individual Council members (Darl Haynes, Donaly Haynes Jr., Keith Payne, and Kirk Rhone), against the Defendants, who are comprised of the remaining three individual Council members (Gale Reddon, Jack Downton, and Kristin Potter), purported Council member Theodore Batzel, and Jason Heeman (the Mayor of Starrucca). After a hearing on this Petition, the Court entered an Opinion and Order on February 3, 2022.

This case is about dueling appointments to Starrucca Borough Council to fill the vacancy left when one of its seven members, Mary Ann DeBalko, resigned, and the preliminary injunction sought to resolve the issue of which of these appointments was the lawful one

The groundwork for the controversy was laid on October 15, 2021, when Ms. DeBalko submitted her official resignation from Borough Council via email. Borough Council accepted her resignation at their next regular meeting, held on November 1, 2021. The next regular meeting of Borough Council occurred on December 6, 2021. At this meeting, Borough Council voted to appoint Kirk Rhone to fill the vacant seat left by Ms. DeBalko, and passed a resolution so appointing Mr. Rhone.

Borough Council's next meeting was a reorganizational meeting held on January 3, 2022. During this meeting, Mayor Heeman asked Mr. Rhone to leave, alleging that he was not a duly-appointed Council member. Mr. Rhone then left the meeting, along with the other three Plaintiffs, who walked out in protest. After all four Plaintiffs left, the remaining three Borough Council members voted to appoint Theodore Batzel to fill Ms. DeBalko's vacant seat.

The Court was essentially asked to decide the issue of whether Mr. Rhone or Mr. Batzel was the properly-appointed Borough Council member. The Defendants argued that Mr. Rhone's appointment was invalid because 8 Pa.C.S.A. § 901 requires vacancies in borough offices to be filled within thirty (30) day after the vacancy occurs, and Mr. Rhone was appointed thirty-six (36) days after Ms. DeBalko's resignation became effective on November 1, 2021 (when Council voted to accept it). The Court rejected this argument for several reasons. First, the Court noted that Borough Council acted at the next regularly-scheduled meeting, which happened to be thirty-six (36) days after the

meeting at which they accepted Ms. DeBalko's resignation. Second, the Court found the additional five (5) days to be de minimis, and noted that the primary purpose of the statutory provision is to fill a vacancy within a reasonable time, and that the provisions of a statute requiring public officers to act within a specified period of time are generally regarded as directory as opposed to mandatory, unless time is of the essence. Third, the Court noted that Mr. Rhone was appointed before any Petition was presented to the Court by Defendants (or anyone else). If the Defendants had presented a Petition on the thirty-first day, before Council acted, the Court indicated that it would have then had exclusive jurisdiction over the matter, and Council would not have had the power to appoint anyone to fille the vacancy, but that did not occur. Finally, the Court noted that the Council is entitled to the presumption that it acted properly for the public good. The Court thus concluded that Mr. Rhone had been validly appointed to fill Ms. DeBalko's vacancy.

The Court further concluded that there was a valid reorganizational meeting on January 3, 2022, as all Council members were present initially to establish a quorum. The Court observed that the Mayor's dismissal of Mr. Rhone from the meeting was improper and outside the scope of his duties. The Court accordingly thus also concluded that Mr. Batzel's appointment at the January 3, 2022 meeting was void and invalid.

The Court further indicated that Borough Council could, at its next meeting, review and modify the actions taken at the January 3, 2022 meeting.

The Plaintiffs were represented in this matter by Ronald M. Bugaj, Esq. The Defendants were represented by Sean Logsdon, Esq.




