OPINION

BY: ASHWORTH, P.J. March 19, 2021 This matter is before the Court on the Preliminary Objection of Defendants, Nikelle A. Albright, Tammy L. Zook, and Joel M. Zook (collectively "Defendants") to Count One of Plaintiff Stephanie Wresilo's Complaint, which asserts a cause of action for negligence per se based on criminal statute 3 P.S. §459-502-A. After careful consideration of the briefs of the parties, oral arguments made, and for the reasons set forth below, the preliminary objection will be sustained and Count One will be dismissed.

I. FACTUAL AND PROCEDURAL BACKGROUND

This is a personal injury action arising from a dog bite that occurred at the home of Defendants, Tammy and Joel Zook ("Zooks").¹ The Zooks were hosting a Memorial Day gathering at their home on 12 Southwoods Drive, Elizabethtown, PA, on May 29, 2017.² Their daughter, Defendant Nikelle Albright ("Albright"), is the owner of a pitbull/Labrador mix dog named Mako ("dog"). Albright attended the gathering along with the dog, which was kept inside the house but unrestrained during the gathering. At Albright's invitation, Plaintiff was also in attendance at the Memorial Day gathering and at some point, went inside the Zooks' home to use the restroom. When Plaintiff exited the re-

¹ The factual background is ascertained from Plaintiff's Complaint as the Court, in considering preliminary objections in the nature of a demurrer, must accept as true all material facts set forth in the complaint, as well as all inferences reasonably deducible therefrom. Toney v. Chester County Hospital, 961 A.2d 192, 197 (Pa. Super. 2008).

² A discrepancy appears in the Complaint with respect to the year the incident occurred. Initially, the Complaint alleges the incident occurred on May 29, 2019. Compl. at ¶4. Thereafter, however, the Complaint references May 29, 2017. Compl. at ¶¶5, 8, 9, 18. Because the exact date of the incident is irrelevant to resolution of the preliminary objection before us, the Court will utilize the May 29, 2017 date in this Opinion since the Complaint references 2017 repeatedly and 2019 only once.

stroom, she saw the dog on a bed across the hall and decided to approach him. As Plaintiff moved toward the dog, the dog leapt from the bed, biting Plaintiff in the face and causing multiple facial injuries. According to the Complaint, prior to May 27, 2017, Defendants "were aware of the dog's vicious propensity and/or his propensity to attack human beings" and "were aware that the dog had bit [sic] and/or attacked at least one other person, including a friend of Defendant Albright's brother." Compl. at ¶¶ 18, 9.

Plaintiff filed a Writ of Summons on May 14, 2019, and the instant Complaint on September 10, 2020, alleging one count of negligence per se pursuant to 3 P.S. §459-502-A ("dangerous dog statute")³ and one count of simple common-law negligence. Defendants have filed a preliminary objection in the nature of a demurrer to Count One, the negligence per se claim. Both parties thoroughly briefed the issues, and the Court heard oral argument on March 8, 2021, via teleconference,⁴ rendering this matter ripe for disposition.

II. SUMMARY OF ARGUMENTS

Defendants demur to Count One of the Complaint, arguing that "the Dangerous Dog Statute is inapplicable, because the plain language of the statute reveals that it was not meant to be a basis of a civil lawsuit and cannot be applied to the facts of this case." Def. Br. at 5 (unpaginated). Defendants reason that Plaintiff's failure to allege the dog was previously adjudged by a magisterial district judge to be a "dangerous dog" under the statute renders Count One fatally flawed.

Plaintiff responds that "the overriding purpose of the Dangerous Dog Statute is to protect people from enduring harm caused by dangerous dogs. Pennsylvania law has long allowed use of criminal statutes to impose civil liability." Pl. Br. at 11 (unpaginated). Plaintiff argues the dangerous dog statute allows an injured party to recover from a dog owner in a civil action on a theory of strict liability, even if the dog has not previously been judicially declared a "dangerous dog" under the dangerous dog statute. Plaintiff urges the Court to overrule the objection and allow her to proceed to discovery on Count One, despite the lack of a previous conviction under the statute.

III. DISCUSSION

A. Standard of Review

³ Section 502-A was added to the Dog Law by the Act of May 31, 1990, P.L. 213, No. 46, § 2, as amended by the Act of December 11, 1996, P.L. 943, No. 151, § 13, and as amended again by the Act of October 9, 2008, P.L. 1450, No. 199, § 14. It is commonly referred to as the "dangerous dog statute."

⁴ The global pandemic of the past year has required the Court to utilize alternate means, such as video and telephone conferences, to conduct remote hearings and oral arguments in order to mitigate against the spread of the Covid-19 virus. Both parties consented to holding oral argument on the preliminary objection via telephone conference.

Pennsylvania Rule of Civil Procedure 1028(a)(4) establishes the right of a party to file preliminary objections in the nature of a demurrer to any pleading on the grounds of legal insufficiency. In ruling on such preliminary objections, all wellpled material allegations and all reasonable inferences that can be drawn therefrom must be accepted as true. *Donaldson v. Davidson Bros., Inc.,* 144 A.3d 93, 100 (Pa. Super. 2016) (*citing Yocca v. Pittsburgh Steelers Sports, Inc.,* 578 Pa. 479, 497, 854 A.2d 425, 436 (2004)). Conclusions of law, unwarranted inferences from facts, opinions, or argumentative allegations, however, will not be considered as true. *American Express Bank, FSB v. Martin,* 200 A.3d 87 (Pa. Super. 2018) (*citing Wiernik v. PHH U.S. Mortgage Co.,* 736 A.2d 616, 619 (Pa. Super. 1999)).

A preliminary objection, the effect of which would deny the pleader's claim or dismiss his or her suit, will be sustained only in cases which are clear and free from doubt. *Greenberg v. McGraw*, 161 A.3d 976, 980 (Pa. Super. 2017) (*quoting Richmond v. McHale*, 35 A.3d 779, 783 (Pa. Super. 2012)). "The question presented by the demurrer is whether, on the facts averred, the law says with certainty that no recovery is possible. Where a doubt exists as to whether a demurrer should be sustained, this doubt should be resolved in favor of overruling it." *Id.* (quoting *Price v. Brown*, 545 Pa. 216, 221, 680 A.2d 1149, 1151 (1996)). With these principles in mind, the Court turns to the matter before it.

B. Analysis

The dangerous dog statute, upon which Plaintiff seeks to establish the strict liability claim, provides in pertinent part:

(a) Summary offense of harboring a dangerous dog. - Any person who has been attacked by one or more dogs, or anyone on behalf of the person, a person whose domestic animal, dog or cat has been killed or injured without provocation, the State dog warden or the local police officer may file a complaint before a magisterial district judge, charging the owner or keeper of the dog with harboring a dangerous dog. The owner or keeper of the dog shall be guilty of the summary offense of harboring a dangerous dog if the magisterial *district judge* finds *beyond a reasonable doubt* that the following elements of the offense have been proven:

(1) The dog has done one or more of the following:

(i) Inflicted severe injury on a human being without provocation on public or private property.

(ii) Killed or inflicted severe injury on a domestic animal w i t h o u t provocation while off the owner's property.

(iii) Attacked a human being without provocation.

(iv) Been used in the commission of a crime.

(2) The dog has either or both of the following:

(i) A history of attacking human beings and/or domestic a n i m a l s without provocation.

(ii) A propensity to attack human beings and/or domestic a n i m a l s without provocation. A propensity to attack may be proven by a single incident of the conduct described in paragraph (1)(i), (ii), (iii), or (iv).

(3) The defendant is the owner or keeper of the dog.

(a.1) Effect of conviction – A finding by a magisterial district judge that a person is guilty under subsection (a) of harboring a dangerous dog shall constitute a determination that the dog is a dangerous dog for purposes of this act...

3 P.S. § 459-502-A (emphasis added). Under the statute, if a magisterial district judge adjudicates an animal to be a dangerous dog, then strict *criminal* liability attaches to the owners of that dog for any injuries it may inflict.⁵ In Count One of the Complaint, Plaintiff attempts to utilize this criminal statute's strict liability standard to impose a strict *civil* liability standard on the Defendants in this dog bite case. The Complaint, however, fails to allege that Defendants have been convicted of harboring a dangerous dog under the dangerous dog statute.

It is true that no Pennsylvania appellate court has directly addressed this issue — whether a plaintiff in a civil action may impose strict or absolute liability for a dog bite where there has been no formal finding made by a court under the statute. Trial courts around the Commonwealth, however, have grappled with the question; indeed, this Court analyzed the issue in an opinion granting summary judgment for defendants in a similar factual situation. See Rider v. Lutchkus, (Case CI-05-05391, Lancaster Co., Ashworth, J., Oct. 30, 2009). Although Rider was decided on a motion for summary judgment rather than on preliminary objections, the analysis and principles of law decided therein apply. In *Rider*, the plaintiff sought to recover for a dog bite injury under both common law principles of negligence and the dangerous dog statute's strict liability standard, despite the fact that no criminal complaint had ever been filed against the defendants pursuant to the statute. The Court noted in *Rider* the dearth of appellate court guidance on the issue but found persuasive the reasoning of a notable Common Pleas case in which the trial court declined to allow the advancement of a negligence per se theory based on an alleged yet uncharged violation of the dangerous dog statute. In Kormos v. Urban, 2005 WL 3970805 (Case No. GD 03-25548, Alleghany Co., Baldwin, J., Sept. 15, 2005),6 the trial court concluded:

> [n]othing in the legislative history reveals that the Legislature intended for this amendment of a criminal [dangerous dog] statute to apply to a civil dog bite case. The purpose of the amendment is to ensure that pet owners do not keep dangerous animals and to punish them, if they do. The Legislature sought to provide citizens with greater protection in certain instances by way of this amendment of a criminal

⁵ Even though district attorneys undertake prosecution of dangerous dog violations and complaints filed under the dangerous dog law are criminal complaints, the statute is purely regulatory in nature and not penal. The dangerous dog law is administered and enforced by the Pennsylvania Department of Agriculture and appeals of convictions under the dangerous dog law are heard by the Commonwealth Court of Pennsylvania, and not the Superior Court. See Commonwealth v. Hake, 738 A.2d 46, n.3 (Pa. Cmwlth. 1999) and Commonwealth v. Morgera, 836 A.2d 1070, 1072 n.2 (Pa. Cmwlth. 2003).

⁶ The decision of the trial court was affirmed on appeal by the Pennsylvania Superior Court (Appeal No. 1227 WDA 2005), and a petition for appeal to the Pennsylvania Supreme Court was denied.

statute. In so doing, the Legislature did not repeal the recognized duty of an owner of a domestic animal to exercise ordinary care, nor did it extend a dog owner's civil liability beyond these original parameters. If it was the intent of the Legislature to hold dog owners strictly liable for unprovoked attacks by their animals not known to have a dangerous propensity, the Legislature would have stated so. It is not for this court to change years of common law precedent based on this amendment to a criminal statute.

Id. With *Rider*, this Court adopted the foregoing reasoning in 2009, and there have been no changes or developments in either the statutory or common law since that time which would require or persuade the Court to reject that analysis now.

At oral argument, Plaintiff made a laudable attempt to distinguish its case from the Alleghany and Lancaster County cases, focusing on the Kormos court's language that "[i]f it was the intent of the Legislature to hold dog owners strictly liable for unprovoked attacks by their animals not known to have a dangerous propensity, the Legislature would have stated so." Kormos (emphasis added). Plaintiff argues the instant case differs insofar as the instant Complaint includes an allegation that Defendants knew, prior to the subject incident, that the dog had bitten at least one other individual. Compl. at ¶9. Plaintiff continues that even if the Defendants did not have prior knowledge of the dog's dangerous propensity, they could still be held strictly liable under the dangerous dog statute due to the alleged viciousness of the subject attack. Citing several additional cases for support, Plaintiff argues that under certain circumstances, such as those alleged here, the dangerous dog statute's 1996 amendment allows for imposition of strict criminal liability on a dog owner even for the animal's first unprovoked attack. The Plaintiff relies heavily on a trial court opinion from Lehigh County to argue that strict liability in a civil matter may be imposed based on mere allegations that an animal's behavior would qualify it as a dangerous dog under the dangerous dog statute. Pl. Br. at 5-7 (unpaginated)(citing Rosen v. Tate (Case No. 2001-C-2395, Lehigh Co., Wallitsch, J., Oct. 27, 2003)).

The Court does not disagree that the Commonwealth Court and other trial courts have determined that through the 1996 amendments to the dangerous dog statute, the Pennsylvania Legislature created a law that imposes strict criminal liability on a dog owner for an unprovoked attack — that the prosecution in a *criminal* case need not show evidence of a dog's history in order for criminal liability to attach to the dog owner, when it is clear from the one attack that the dog is dangerous. See Commonwealth v. Hake, 738 A.2d 46, 49 (Pa. Cmwlth. 1999). This does not, however, stand for the proposition that the same standard of liability should or does attach in a civil case. Our Superior Court has clarified Pennsylvania's position with respect to civil liability for dog bites, opining that:

> the Commonwealth does not impose absolute liability on the owner for dog attacks. As we have stated in previous cases: 'we are convinced that proof of negligence, in contrast to holding one absolutely liable, is the vehicle by which accountability for injury sustained because of a dog bite is to be established.' McCloud v. McLaughlin, 837 A.2d 541, 544 (Pa. Super. 2003)(quoting Deardoff v. Burger, 606 A.2d 489, 493 (Pa. Super. 1992), appeal denied 532 Pa. 655, 615 A.2d 1312 (1992)).

Underwood ex rel. Underwood v. Wind, 954 A.2d 1199, 1204 (Pa. Super. 2008)(cited by this Court in Rider at 31). Based in part on the Underwood reasoning, this Court has declined to "allow the advancement of a negligence per se theory [in a civil action] based on an uncharged violation of the dangerous dog statute." *Rider* at 33. This is the factual scenario before the Court in the instant case. The Complaint fails to allege that a magisterial district judge has examined the dog's behavior and adjudged it a dangerous dog, either in connection with the underlying incident or some other prior event. In fact, Plaintiff conceded at oral argument that Defendants were neither charged nor convicted under the dangerous dog statute for the incident at issue, or for any other incident relative to this dog in the past. In other words, the dog has never been adjudicated dangerous by a magisterial district judge as required for conviction under the dangerous dog statute.

Plaintiff fails to answer satisfactorily, either on brief or at oral argument, the question of why the Court should deviate in this case from its prior position in *Ryan*. Plaintiff has not and admittedly cannot show an actual violation of the statute as

would be necessary in order to use the statute in a civil cause of action for negligence per se.⁷ The statute explicitly states it is for the magisterial district judge to determine beyond a reasonable doubt whether a defendant harbored a dangerous animal under the statute. There is no indication in either the dangerous dog statute or its legislative history that a trial court has authority to allow a civil trier of fact to make this determination in the course of a civil trial.⁸ Further, Plaintiff's contention that the Court should allow her to proceed through discovery on the strict liability claim is unavailing as Plaintiff has conceded she cannot show the Defendants have been adjudicated by a magisterial district judge to have harbored a dangerous dog. No amount of discovery will change this fact; thus, the law says with certainty that no recovery is possible and a demurrer is well founded. This Court is simply unwilling to go so far as to allow the Plaintiff to avail herself of a strict liability standard in this civil matter based on an alleged violation of a criminal statute, where the Defendants have been neither charged nor convicted under that statute in the past.

IV. CONCLUSION

For all the reasons set forth above, the Defendants' preliminary objection is therefore sustained and Count One of the Complaint shall be dismissed.

Accordingly, I enter the following:

⁷ Correctly stated by Plaintiff, negligence per se requires a showing of: (1) a governing statute; (2) a violation of that statute causing harm the statute intended to be prevented; and (3) the harm is done to a person covered by the statute. See Br. of Pl. at 2 (unpaginated)(citing McCloud v. McLaughlin, 837 A.2d 541, 545 (Pa. Super. 2003).

⁸ Even setting aside the admitted facts of this case and the clear, unambiguous language of the statute, its use in a civil trial would require the Court to create a means of instructing a civil jury that in order to find Defendants strictly liable of negligence by a preponderance of the evidence, it must first find that the Defendants violated a criminal statute beyond a reasonable doubt.

ORDER

AND NOW, this 19th day of March, 2021, upon consideration of Defendants' Preliminary Objections to Plaintiff's Complaint, the briefs filed by the parties, oral arguments made, and for the reasons stated in the accompanying Opinion, it is hereby ORDERED that Defendants' preliminary objection to Count One of the Complaint is SUSTAINED and Count One of the Complaint shall be DISMISSED.


