### MISCELLANEOUS LEGAL NOTICE

NOTICE IS HEREBY GIVEN that the Board of Supervisors of the Township of Smithfield shall hold a public meeting on November 7, 2023 at 8:00 P.M. to consider adoption of an ordinance to undertake the maintenance of certain abandoned cemeteries within the Township and for any other such action as may come before the Board of Supervisors. Said meeting shall be held at the Smithfield Township Building, 75 Park Lane, East Smithfield, Pennsylvania. All persons with disabilities wishing to attend the public meeting and needing reasonable accommodations should contact the Township Secretary at (570) 596-7770 no later than 72 hours prior to the scheduled meeting. Smithfield Township will make every reasonable effort to provide accommodation.

SOLICITOR'S SUMMARY

Preamble.

Section 1—authorizes the Township to assume maintenance and operation of

abandoned cemeteries within the Township as set forth on Appendix A.

Section 2—the cost for sale of cemetery lots shall be set annually by Resolution and one-half of the proceeds deposited into an escrow account for assisting with maintenance expenses.

Section 3—contains a savings clause. Section 4—contains repealer provisions. Section 5—sets the effective date of the ordinance.
