SUMMARY OF OPINION:

During the discovery deposition of the defendant in this malpractice case, objections were lodged to any questioning concerning a written statement that defendant provided to plaintiff's health insurer as part of its internal quality-of-care review of the medical treatment provided. Although the defense asserted that the statement was protected from discovery as privileged peer review, the insurer's quality-of-care materials were determined to be discoverable. Following plaintiff's receipt of those records, she made no attempt to redepose the defendant concerning that statement prior to certifying the case for trial, and instead belatedly attempted to schedule that deposition after a trial date had already been fixed. Defendant objected to plaintiff's requests to redepose him, and plaintiff filed a motion to compel.

The defendant's statement to the health insurer was clearly relevant, and the defendant did not establish that he would be subject to unreasonable annoyance, burden, or expense if he was required to submit to a supplement deposition limited to the subject of that statement. The defense also failed to identify any prejudice that it would suffer from the additional deposition since the scheduled trial was several months away. While it was true that plaintiff's procrastination in attempting to redepose the defendant should not be countenanced, the request to redepose the defendant regarding his statement was granted.

SUMMARY OF OPINION:

In this premises liability action filed against a commercial landowner by an employee of an independent contractor that was retained by the landowner to provide janitorial services, the owner filed a motion for summary judgment on the basis that it owed no duty of care to the employee since a property owner who retains an independent contractor cannot be vicariously liable for the negligence of an independent contractor or its employee. Under the "retained control" exception to that theory of nonliability, a landowner who entrusts work to an independent contractor remains subject to liability if its contract with the independent contractor grants the premises owner control over the manner, method, and operative details of the independent contractor's work. Based upon the comprehensive terms of the janitorial services contract, the landowner dictated how the contractor's cleaning services were to be performed, what products and equipment were to be used, when designated tasks were to be completed, and the exact manner in which that work was to be accomplished. As a result of that extensive control that the premises owner retained over the operative details of the contractor's work, a triable issue of fact existed as to whether the requisite quantum of control was retained so as to expose the landowner to liability. Therefore, the property owner's motion for summary judgment was denied.
