9/11 Victim Compensation Fund – Pretermitted spouse – Air Transportation Safety and System Stabilization Act – Probate, Estate and Fiduciaries Code - Asset of the estate

- 1. Pursuant to 20 Pa. C.S.A. §2507 (3), if the testator marries after making a will, the surviving spouse shall receive the share of the estate to which he would have been entitled had the testator died intestate, unless the will shall give him a greater share or unless it appears from the will that the will was made in contemplation of marriage to the surviving spouse.
- 2. Pursuant to the provisions of 20 Pa. C.S.A. Section 2102 (2), the share of a surviving spouse would be calculated as follows: if there is no surviving issue of the decedent but he is survived by a parent or parents, the share of surviving spouse is the first \$30,000 plus one-half of the balance of the intestate estate. Notwithstanding the foregoing, in the case of a decedent who died as a result of the terrorist attacks of September 11, 2001, a surviving spouse shall be entitled to 100% of any compensation award paid pursuant to the Air Transportation Safety and System Stabilization Act [ATSSSA] (Public Law 107-42, 115 Stat. 230).
- 3. Section 405 (c)(2)(A)(i)(ii) of Public Law 107-42, September 22, 2011, 115 Stat 230, limits the eligible claimants (an individual or relatives of a deceased individual) as follows: an eligible claimant is an individual who, was present at the World Trade Center, the Pentagon or the site of the aircraft crash at Shanksville, Pennsylvania at the time, or in the immediate aftermath of the terrorist-related aircraft crashes of September 11, 2001, and suffered physical harm or death as a result of such an air crash.
- 4. When engaging in statutory construction, a court's duty is to give effect to the legislature's intent and to give effect to all of a statute's provisions. The best indication of legislative intent is the plain language of the statute. In ascertaining the plain meaning, we consider the statutory language in context and give words and phrases their common and approved usage. When statutory language is clear and unambiguous, courts must give effect to the words of the statute and must not disregard the text to implement its objective. Only if the statute is ambiguous, and not explicit, does a court resort to other means of discerning legislative intent.
- 5. The language of 20 Pa. C.S.A. §2102 (2) is clear and unambiguous that a surviving spouse of a person who died as a result of the 9/11 attacks shall be entitled to 100% of any compensation award paid pursuant to the ATSSSA. That act defined eligible persons as those who were present at the WTC at the time or in the immediate aftermath of the 9/11 aircraft crashes and suffered physical harm or death as a result of the crashes.

Decedent was not at the World Trade Center and he did not suffer physical harm on September 11, 2001. Decedent's cancer was an injury that was not eligible for the award under the ATSSSA. 20 Pa.C.S.A. Section 2102 (2) does not provide for subsequent reauthorizations which changed the eligibility requirements established in the ATSSSA. Thus, the Court <u>Held</u> the Victim Compensation Fund award was not paid pursuant to the ATSSSA. Accordingly, the spouse is not entitled to 100% of the award. The award is properly included as an asset in Decedent's estate.

OPINION

Before me is a request to adjudicate a question raised in Executor/Accountant Michael Chennisi's Statement of Proposed Distribution appended to his First and Interim Account in the referenced estate. Executor/Accountant seeks guidance from the Court as to allocation of \$731,662.58 received by the Estate from the September 11th Victim Compensation Fund: Should it be allocated to Decedent's estate and therefore be administered as an asset of the Estate; or should it be distributed fully to Decedent's surviving spouse?

Background

In September 2001, Richard A. Chennisi (Decedent) lived in New York City near the World Trade Center. On November 5, 2016, Decedent died a resident of Chester County, Pennsylvania. He died of leukemia, thought to be caused by his exposure to pollutants and carcinogens released in the immediate aftermath of the 9/11 terrorist attacks. In August 2020, Decedent's estate received an award from the 9/11 Victim Compensation Fund (the "VCF")¹.

Decedent left a Will dated November 30, 2012 naming his brother, Michael S. Chennisi as Executor ("Michael" or "Executor").² The Will was admitted to probate and Letters Testamentary granted to Michael on November 10, 2016. In addition to his brother, Decedent was survived by his mother Elaine Wenda Chennisi (Elaine), and his wife of four (4) days, Lauren Newman (Lauren).

Decedent's Will provided for Lauren to receive all of Decedent's personal property, except any motorcycles owed by him at his death which were bequeathed to Michael. The Will further specifically devised Decedent's residential real estate, subject to any mortgage, to Lauren if they were still co-habiting at his death, which they apparently were. The residuary estate was placed in trust for the primary benefit of Elaine during her lifetime, with the contingent remainder divided between Lauren (1/3) and Michael (2/3). Michael was named Trustee of the Residuary Trust.

Legal Issues

The marriage between Decedent and Lauren occurred after the execution of the 2012 Will, and no subsequent will was executed. Under these circumstances, Lauren is a "pretermitted spouse", entitled to receive the share of the estate to which she would have been entitled had Decedent died intestate.

Pursuant to 20 Pa. C.S.A. §2507 (3),

If the testator marries after making a will, the surviving spouse shall receive the share of the estate to which he would have been entitled had the testator died intestate, unless the will shall give him a greater share or unless it appears from the will that the will was made in contemplation of marriage to the surviving spouse.

The Will does not contemplate Decedent and Lauren's marriage, and Lauren's share under the Will is smaller than her intestate share, even without regard to the VCF award. Thus, pursuant to the provisions of 20 Pa. C.S.A. Section 2102 (2) Lauren's share as surviving spouse would be calculated as follows:

If there is no surviving issue of the decedent but he is survived by a parent or parents, [the share of surviving spouse is] the first \$30,000 plus one-half of the balance of the intestate estate. Notwithstanding the foregoing, in the case of a decedent who died as a result of the terrorist attacks of September 11, 2001, a surviving spouse shall be entitled to 100% of any compensation award paid pursuant to the Air Transportation Safety and System Stabilization Act (Public Law 107-42, 115 Stat. 230).³

The last sentence of the foregoing statutory section is central to the dispute before me.

On September 8, 2020, Executor filed a First and Interim Account along with two (alternate) Statements of Proposed Distribution. Executor states that he knew there was going to be a dispute regarding the allocation of the VCF award, thus he presented the court with alternate proposed distribution schemes: (1) payment of the award to Decedent's estate and distribution as an asset of the estate, or (2) distributing 100% payment of the award to Lauren. Both Statements allocate a portion of Decedent's debts and the estate's administrative expenses to be paid from the VCF award.

Lauren filed multiple Objections to the Account, Petition for Adjudication and the Statements of Proposed Distribution. Elaine Chennisi and Michael,

individually and as beneficiaries of the Residuary Trust under the Will also filed Objections to the Petition for Adjudication/Statement of Proposed Distribution.

This opinion, however, only addresses those objections regarding the allocation of the VCF award. All other objections are preserved.

Lauren claims that since Decedent married her after he executed his Will, she is entitled to the first \$30,000, plus 50% of the balance of the estate as a pretermitted spouse. She contends that the other half of the estate is to be paid in trust for the benefit of Decedent's mother, per the will. With respect to the VCF award, Lauren claims she is entitled to 100% of any compensation award paid pursuant to the Air Transportation Safety and System Stabilization Act (Public Law 107-42, 115 Stat. 230) ("the ATSSSA"). Elaine, as beneficiary of the Residuary Trust, and Michael, as Trust beneficiary and Trustee argue that the VCF award was not "paid pursuant to" the ATSSSA, within the meaning of 20 Pa. C.S.A. Section 2102 (2), and therefore the award must be distributed to the Estate to be further administered as an asset of the Estate.

More specifically, the issues before me are: (1) Was the VCF payment received by Decedent's estate paid pursuant to the ATSSSA or paid under a fund established by amendments to the ATSSSA [in 2011, 2015-2016 and 2019], and (2) If the award was the result of amendments that expanded the group of individuals who suffered physical harm as a result of the 9/11 attacks, and extended the time period during which eligible claimants could submit claims, is Lauren entitled to 100% of the award under Section 2102 (2) of the Probate, Estate and Fiduciaries Code?

The ATSSSA

Section 405 (c)(2)(A)(i)(ii) of Public Law 107-42, September 22, 2011, 115 Stat 230, limits the eligible claimants (an individual or relatives of a deceased individual) as follows:

An eligible claimant is an individual who,

was present at the World Trade Center, the Pentagon or the site of the aircraft crash at Shanksville, Pennsylvania at the time, or in the immediate aftermath of the terrorist-related aircraft crashes of September 11, 2001, and suffered physical harm or death as a result of such an air crash.

Elaine, and Michael as beneficiary and Trustee, assert the 2001 fund created under the ATSSSA could not have paid an award to persons such as Decedent, who did not suffer physical injury as defined.⁴ At the time Decedent had a risk of a

future injury which did not manifest within the statutory time period for the 2001 VCF. Elaine and Michael claim Decedent's award is and must be regarded as not having been paid pursuant to the ATSSSA. Further, she notes that the ATSSSA had a sunset provision, mandating the filing of claims within 2 years after the date on which regulations are promulgated. The VCF stopped accepting application and expired by its own terms on December 22, 2003. Elaine and Michael contend that claims submitted and awards paid after December 22, 2003 cannot accurately be said to have been paid pursuant to the ATSSSA within the meaning of Section 2102(2).

Elaine and Michael assert that Decedent remained ineligible as a claimant until amendments to the ATSSSA and further administrative rulemaking expanded covered health conditions in 2015-2016, and that it was not until the 2019 VCF Permanent Authorization Act amended the ATSSSA that Decedent qualified as an eligible claimant and there was a fund from which his claim could be paid.

Lauren contends that the VCF was established in 2001 as a mechanism for the beneficiaries of the victims of the 9/11 attacks. The fund was reactivated in 2011 by the James Zadroga 9/11 Health and Compensation Act of 2010, and the 2015-2106 James Zadroga 9/11 Health and Compensation Reauthorization Act. She claims the 2001 ATSSSA was recently amended in 2019 by the "Never Forget the Heroes Act" (the 2019 VCF Permanent Authorization Act, P.L. 116-34, July 20, 2019). Lauren claims that none of the subsequent reauthorizations created a new fund or source of payment of the claims. Any award paid from the fund is an award made under the Air Transportation Safety and System Stabilization Act.

When engaging in statutory construction, a court's duty is to give effect to the legislature's intent and to give effect to all of a statute's provisions. The best indication of legislative intent is the plain language of the statute. In ascertaining the plain meaning, we consider the statutory language in context and give words and phrases their common and approved usage. When statutory language is clear and unambiguous, courts must give effect to the words of the statute and must not disregard the text to implement its objective. Only if the statute is ambiguous, and not explicit, do we resort to other means of discerning legislative intent. *Crown Castle NG East LLC v. Pennsylvania Public Utility Commission*, 234 A.3d 665, 674 (Pa. 2020) (citations omitted).

The language of 20 Pa. C.S.A. §2102 (2) is clear and unambiguous that a surviving spouse of a person who died as a result of the 9/11 attacks shall be entitled to 100% of any compensation award paid pursuant to the <u>Air Transportation Safety and System Stabilization Act</u>. That act defined eligible persons as those who were present at the WTC at the time or in the immediate aftermath of the 9/11 aircraft crashes and suffered physical harm or death as a result of the crashes. Decedent was not at the WTC and he did not suffer physical harm on September 11, 2001. Decedent (or his personal representative) could not have filed a claim for compensation because his latent injury (cancer) did not manifest itself until years after the ATSSSA application deadline to file a claim for the fund expired – the end of December of 2003.

The award to Decedent's estate was paid pursuant to the James Zadroga 9/11 Health and Compensation Act of 2010, the James Zadroga 9/11 Health and Compensation Reauthorization Act (2015-2016) and the 2019 Never Forget the Heroes Act. The Final Rule issued by the Department of Justice on September 2, 2016, permitted claims for injury as a result of rescue and recovery of debris removal at the WTC, and expanded the WTC – Related Physical Health Condition to include an injury that was treated by a medical professional within a reasonable time from the date of discovering such harm. 28 C.F.R. §104.2 (d)(1)(2). Decedent's cancer was an injury that was not eligible for the award under the Air Transportation Safety and System Stabilization Act.

The primary indication of the legislature's intent is the plain language of the statute. *In re Borough of Downingtown*, 161 A.3d 844, 870 (Pa. 2017)(citing *Department of Environmental Protection v. Cumberland Coal Resources*, 102 A.3d 962 (Pa. 2014)). 20 Pa. C.S.A. §2102 (2) states that the award is paid pursuant to the Air Transportation Safety and System Stabilization Act. It does not provide for subsequent reauthorizations which changed the eligibility requirements established in the ATSSSA.

Thus, I find that the VCF award was not paid pursuant to the ATSSSA. Lauren is not entitled to 100% of the award. The award is properly included as an asset in Decedent's estate.

Based on the foregoing, the following Order is hereby entered.
