COMMONWEALTH VS. CARRETO

- 1. A person commits the offense of bad checks if he issues or passes a check or similar sight order for the payment of money, knowing that it will not be honored by the drawee.
- 2. The statute criminalizing the issuance of bad checks requires knowledge, at the time the check was issued, that the check would be dishonored. If the check is post-dated or is given for a debt past due there is no criminal intent, and therefore no crime.
- 3. Even if Defendant's check was not a postdated check, the statute of limitations begins to run once the offense is completed.
- 4. A person need not be given notice and a ten-day grace period to make the check good before the offense is deemed committed. The provisions of 18 Pa. C.S.A.§4105(b) merely create a *presumption* that the defendant knew the check would not be honored.
- 5. The offense is complete when the check was issued. The statute of limitations begins to run from that time.

OPINION

On February 5, 2009, Patrolman Andrew Hansen of the Liberty Township Police Department filed a criminal complaint in the above captioned matter charging Defendant with one count of Bad Checks. The facts as alleged by the Commonwealth are summarized as follows:

Defendant presented a check in the amount of \$7,450.00 to the Gettysburg Auto Exchange on January 17, 2007. The check was dated January 18, 2007. Gettysburg Auto Exchange cashed the check on or about January 29, 2007. On February 5, 2007, the check was returned due to insufficient funds in Defendant's account. On April 7, 2008, Gettysburg Auto Exchange sent a certified letter to Defendant advising him that he had ten business days after receipt of the letter to pay the face amount of the check plus a \$40 bad check fee. A certified mail receipt bearing Defendant's signature is stamped as having been delivered on April 14, 2008. Defendant failed to pay

off the check as directed within the ten days. Gettysburg Auto Exchange contacted Patrolman Hansen of the Liberty Township Police Department on February 5, 2009, and requested that a bad check charge be filed against Defendant. The charge was filed later that date.

Before this Court is Defendant's Motion to Dismiss the Charges.

A person commits the offense of bad checks "if he issues or passes a check or similar sight order for the payment of money, knowing that it will not be honored by the drawee." 18 Pa. C.S.A. § 4105(a)(1). There is a presumption that the issuer of the check or order knew that the check or order (other than a postdated check or order) would not be paid if "payment was refused by the drawee for lack of funds, upon presentation within 30 days after issue, and the issuer failed to make good within ten days after receiving notice of that refusal." 18 Pa. C.S.A. § 4105 (b)(1)(ii).

Defendant claims that the instant bad check charge was brought more than two years after January 18, 2007, the date on which Defendant issued the check. Defendant argues the offense was committed on the day that the check was issued, and thus the statute of limitations has run prohibiting the Commonwealth from prosecuting Defendant for the charged offense of Bad Checks. The Commonwealth asserts that because there is a presumption of knowledge of the issuer after notice, the statute of limitations does not start to run until the issuer fails to make the check good within ten days after receiving notice of that refusal. This Court finds the Commonwealth's assertion as unpersuasive.

First, the check issued by the Defendant was a postdated check. The statute criminalizing the issuance of bad checks requires knowledge, at the time the check was issued, that the check would be dishonored. "If the check is postdated or is given for a debt past due there is no criminal intent, and therefore no crime." See Official Comment to 18 Pa. C.S.A. 4105 (citing *Commonwealth v. Kelinson*, 184 A.2d 374 (Pa. Super. 1962)). "The elements of the offense must be established by the evidence and one of the essential elements is knowing at the time of the making that there is insufficient funds to cover it. This is impossible when the check on its face made it due in the future and the payee in accepting it is looking to the promise of payment in the future and is not then defrauded." *Kelinson*, 184 A.2d

at 376.² The Commonwealth is unable to show that Defendant's actions fall within the statute criminalizing the issuance of bad checks.

Second, even if Defendant's check was not a postdated check, the statute of limitations begins to run once the offense is completed. Pennsylvania law is clear that 18 Pa. C.S.A. 4105 does not impose upon the Commonwealth a requirement to prove an intent to defraud on the part of one accused of passing a bad check. *Commonwealth v. Burruss*, 551 A.2d 580 (Pa. Super. 1988); *Commonwealth v. Mutnik*, 406 A.2d 516 (Pa. 1979). "To prove a violation it is necessary to establish only that the drawer issued a check knowing that there were insufficient funds in his or her account to cover it. *Burruss*, 551 A.2d at 583. Thus, the Commonwealth cannot rely upon a timeliness exception or tolling provision provided for in 42 Pa. C.S. § 5552(c).

Rules of Statutory Construction tell us that the notice provisions found in 18 Pa. C.S.A. § 4105(b)(1) are not an element of the defined offense. The elements are set forth expressly in 18 Pa. C.S.A. § 4105(a). A person need not be given notice and a ten-day grace period to make the check good before the offense is deemed committed. The provisions of 18 Pa. C.S.A. § 4105(b) merely create a pre*sumption* that the defendant knew the check would not be honored. It is merely an evidentiary tool which enables the Commonwealth to prove its case. Notice is not an element of the offense. Moreover, although the presumption of knowledge isn't established until a defendant is given notice and fails to make good on the check within ten days, the presumption that is thereby established goes only to the critical element which is that the defendant knew at the time the check was issued that it would not be honored. Thus, the offense is complete when the check is issued. The statute of limitations begins to run from that time.

The Commonwealth mistakenly relies upon language in *Burruss* for the proposition that the statute of limitations begins to run 10 days after notice was given to the defendant. The Commonwealth quotes: "The statute of limitations began to run, at the latest, when

² The acceptance of a postdated check amounts to delivery on credit. Although Defendant may not be criminally liable, civil remedies may be available to Gettysburg Auto Exchange as set forth in the Uniform Commercial Code. See *Commonwealth v. Kelinson*, 184 A.2d 374 (Pa. Super. 1962).

ten days had expired without the check's having been made good." *Burruss*, 551 A.2d at 584. However, the decision in *Burruss*, only addressed whether the statute of limitations was tolled by the drawer's fraudulent promises to make the check good after the payee learns the check was dishonored. The *Burruss* Court never said that the offense of bad checks was committed ten days after notice of dishonor.³

The Commonwealth acknowledges that pursuant to 42 Pa. C.S. § 5552(d), an offense is committed "when every element occurs, or if a legislative purpose to prohibit a continuing course of conduct plainly appears, at the time when the course of conduct or the complicity of the defendant is terminated. Time starts to run on the day after the offense is committed." Even if the check was not postdated, the Defendant issued the check on January 17, 2007. Based on the plain language of the statue, in order to be guilty of the offense, Defendant would have had to issue the check knowing that the check would not be honored. See 18 P. C.S.A. § 4105 (a)(1). Time therefore started to run on January 18, 2007. Gettysburg Auto Exchange failed to file a complaint until February 5, 2009. Although the charge was filed on the same day that Gettysburg Auto Exchange made the complaint, it was more than two years after the check was issued. Therefore the statute of limitations has run. Accordingly, for the reasons set forth herein, the attached order is entered granting Defendant's Motion to Dismiss the Charges.

<u>ORDER</u>

AND NOW, this 9th day of June, 2010, Defendant's Motion to Dismiss the Charges is granted.

³ In *Burruss*, the check was dated April 15, 1984. Burruss was given notice that the check had been dishonored by the end of April or early May 1984. Charges were not filed until July 30, 1986. Thus, the *Burruss* Court stated that even if the offense was complete either when the check was issued or ten days after notice *at the latest*, the charges were still not timely.
