TAKE NOTICE that the County of Lackawanna Transit System Authority, County of Lackawanna, pursuant to the Municipality Authorities Act, 53 Pa. C.S. §5601 *et seq.*, have adopted a resolution on March 17, 2021 to amend its certificate of incorporation. In compliance with notice requirements of the Act, the Authority hereby advertises such Amendment as follows:

The name and location of the Registered Office is Lackawanna County Transit System Authority 800 North South Road, Scranton, PA 18504.

The Lackawanna County Transit System Authority, was formed under the Municipality Authorities Act of 1945, as amended, pursuant to Certificate of Incorporation approved and filed with the Department of State of the Commonwealth of Pennsylvania on November 1, 1972.

The Lackawanna County Transit System Authority, adopted a Resolution amending the Certificate of Incorporation to extend the life of the Authority to a date not exceeding fifty (50) years from the date of approval of the Articles of Amendment pursuant to 53 Pa. C.S. § 5605, with the Certificate of Incorporation of the Lackawanna County Transit System Authority being amended with the addition of the following paragraph:

1. The authority's existence shall be extended to a date not exceeding fifty (50) years from the date of approval of these articles of amendment.

It is the intention of the Authority that the Amendment of the Certificate of Incorporation and supporting Resolution be filed with the Department of State not less than three (3) days after the date of this Notice.
