

Timothy Yanka and Polly Nessa, h/w v. Leithbridge Co. d/b/a Kurfiss-Sotheby's International Realty and Delaware River Closing Services, Inc.

Plaintiffs appeal to the Pennsylvania Superior Court from the Court's Orders denying Plaintiffs' Motion for Summary Judgment and granting Defendants' Motions for Summary Judgment. The Court held that Plaintiffs failed to provide sufficient evidence to establish a prima facie negligence claim against the Defendants.

Civil law – Motion for summary judgment – Negligent failure to safeguard personal and confidential information – Held, the Court's decisions should be affirmed on appeal.

- 1. When analyzing a motion for summary judgment, the court must view the record in the light most favorable to the nonmoving party, and all doubts as to the existence of a genuine issue of material fact must be resolved against the moving party.
- In responding to a motion for summary judgment, the nonmoving party must identify the genuine issue of material fact from the evidence in the record. Unsupported assertions or conclusory accusations cannot create genuine issues of material fact.
- 3. In <u>Dittman v. UPMC</u>, 196 A.3d 1036 (Pa. 2018), the Pennsylvania Supreme Court held that an employer may be liable for negligence when the employer actively requests sensitive personal information from its employees and fails to collect and store that personal data with reasonable care.
- 4. An email address alone does not contain the same amount of private data as does the totality or private sensitive information compromised in <u>Dittman</u>, which included: social security numbers; tax information; birthdates; full names; home addresses; and personal bank information.
- 5. A personal email address is quasi-public information to the extent it is used by the owner of the address communicating with various persons and entities on the internet.

I. PROCEDURAL HISTORY

On September 5, 2018, Plaintiffs, Timothy Yanka and Polly Nessa ("Plaintiffs"), filed an Amended Complaint.² On March 7, 2019, Defendant, Leithbridge Co. d/b/a Kurfiss-Sotheby's International Realty ("Kurfiss-Sotheby's"), filed an Answer to Plaintiffs' Amended Complaint and a Crossclaim against Co-Defendant, Delaware River Closing Services, Inc. ("Delaware River Closing Services"). On March 8, 2019, Delaware River Closing Services filed an Answer and New Matter to Plaintiffs' Amended Complaint and a Crossclaim against Kurfiss-Sotheby's. On September 23, 2019, Plaintiffs filed an Answer to Delaware River Closing Services' New Matter. On January 22, 2019, the Court sustained Defendants' Preliminary Objections and dismissed Counts II through IV from Plaintiffs' Amended Complaint.³ Thus, Plaintiffs' only surviving claim against Defendants was Count I—Negligent Failure to Safeguard Personal and Confidential Information.

On December 23, 2020, Kurfiss-Sotheby's filed a Motion for Summary Judgment. On December 31, 2020, Delaware River Closing Services also filed a Motion for Summary Judgment. On February 2, 2021, Plaintiffs filed a Response and their own Motion for Summary Judgment.⁴

II. FACTUAL BACKGROUND

In 2017, Plaintiffs contracted Kurfiss-Sotheby's to help find and purchase a residential property. Am. Compl. at 4. Nancy Bousum ("Bousum"), an employee of Kurfiss-Sotheby's, served as Plaintiffs' real estate agent. <u>Id</u>. Plaintiffs eventually found a residential property they wanted to purchase and scheduled a closing date. Kurfiss-Sotheby's instructed Plaintiffs that Delaware River Closing Services would provide intermediary services to properly close on the property. <u>Id</u>. 4-5.

The closing date was set for November 15, 2017 at Delaware River Closing Services' office. Id. at 4. On November 8, 2017, Plaintiffs received an email from a Dorle Friedman asking Plaintiffs to electronically transfer \$390,343.61 to an alleged Delaware River Closing Services trust account prior to the closing date. Am. Compl., Ex. A. Plaintiffs, believing the email was sent by Delaware River Closing Services at the direction of Kurfiss-Sotheby's, transferred the funds into the account. Id. at 5. At the closing, Plaintiffs discovered the email was not sent by either Delaware River Closing Services or Kurfiss-Sotheby's. Id. Plaintiffs would later discover the email soliciting the transfer of funds was sent by an unknown criminal actor purporting to be Delaware River Closing Services. Am. Compl. at 5. The unknown criminal actor successfully induced Plaintiffs to transfer \$390,343.61 into the criminal actor's bank

account. Plaintiffs were able to recover close to \$73,000.00 of the lost funds with the help of the Federal Bureau of Investigation ("FBI"). Def. Delaware River Closing Services' Mot. for Summ. J., Ex. C at 89-91.

Plaintiffs brought this negligence action against Kurfiss-Sotheby's and Delaware River Closing Services ("Defendants") alleging they failed to properly secure Plaintiffs' "confidential personal and transactional information[.]" Am. Compl. at 4. The sole confidential personal information allegedly compromised was Plaintiffs' email address. Am. Compl. at 3. Plaintiffs claimed Defendants' lack of cybersecurity caused Plaintiffs to transfer the funds to the unknown criminal actor. As a result, Plaintiffs sought damages totaling \$317,362.50 based on their allegations of negligence. Pls.' Mot. for Summ. J. at 11.

III. STATEMENT OF ERRORS COMPLAINED OF ON APPEAL

Plaintiffs failed to properly file a Concise Statement of Errors Complained of on Appeal as required by the May 4, 2021 Order and Pennsylvania Rule of Appellate Procedure 1925(b)(1)-(2).⁵ Pursuant to Pennsylvania Rule of Appellate Procedure 1925(b)(4)(vii), Plaintiffs' failure to file a Concise Statement of Errors Complained of on Appeal results in all issues being waived on appeal. Although Plaintiffs failed to specify the errors complained of on appeal, this Opinion will generally address the Court's decisions for the three Motions for Summary Judgment.

IV. DISCUSSION

The Court was simultaneously presented with three separate Motions for Summary Judgment in this matter. One filed by Plaintiffs, and the other two respectively filed by Defendants. Upon careful consideration of the evidence in the record and the legal arguments raised by the parties in their pleadings and responses thereto, the Court ultimately denied Plaintiffs' Motion for Summary Judgment and granted Defendants' respective Motions for Summary Judgment. The Court found that based on the evidence in the record on the Motions for Summary Judgment, or more importantly the lack thereof, clearly showed Defendants were entitled to judgment in their favor. An analysis of the three Motions for Summary Judgment follows.

A. Legal Standard

General Standard for a Motion for Summary Judgment

Under Pennsylvania Rule of Civil Procedure 1035.2, a motion for summary judgment may only be granted when there are no genuine issues of material fact and

the moving party is entitled to judgment as a matter of law. Strine v. Commonwealth Med. Care Availability & Reduction of Error Fund, 894 A.2d 733, 737 (Pa. 2006). Specifically, the rule states a party may file a motion for summary judgment "whenever there is no genuine issue of any material fact as to a necessary element of the cause of action or defense which could be established by additional discovery or expert report[.]" Pa.R.C.P. No. 1035.2. When analyzing a motion for summary judgment, the Court must view the record "in the light most favorable to the nonmoving party, and all doubts as to the existence of a genuine issue of material fact must be resolved against the moving party." Marks v. Tasman, 589 A.2d 205, 206 (Pa. 1991). However, "[b]old unsupported assertions of conclusory accusations cannot create genuine issue[s] of material fact." McCain v. Pennbank, 549 A.2d 1311, 1313-14 (Pa.Super. 1988). In addition, "the adverse party may not rest upon the mere allegations or denials of the pleadings" in response. Pa.R.C.P. No. 1035.3(a). Instead, the nonmoving party must identify the genuine issue of material fact which arises from the evidence in the record. Pa.R.C.P. No. 1035.3(a)(1).

Negligent Collection and/or Storage of Personal Information

Pennsylvania common law requires a plaintiff to prove the following elements to succeed in a negligence claim: "(1) the defendant owed a duty to the plaintiff; (2) the defendant breached that duty; (3) a causal relationship between the breach and the resulting injury suffered by the plaintiff; and (4) actual loss suffered by the plaintiff." Schemberg v. Smicherko, 85 A.3d 1071, 1073-74 (Pa.Super. 2014). Furthermore, this case proceeds under a theory the Supreme Court recently recognized in Dittman v. UPMC, 196 A.3d 1036, 1036 (Pa. 2018), for negligent collection and storage of personal information.

In <u>Dittman</u>, the plaintiffs were employees of the defendant/employer University of Pittsburgh Medical Center ("UPMC"). <u>Id</u>. at 1038. UPMC required its employees to provide it with sensitive personal information as part of their employment. This sensitive personal information included: social security numbers; tax information; birthdates; full names; home addresses; and personal bank account information. <u>Id</u>. UPMC's computer network was subsequently hacked and most of the employees' sensitive personal information was compromised. <u>Id</u>. The employees alleged their stolen personal information was used to file fraudulent tax returns. Ultimately, the Supreme Court of Pennsylvania held that an employer may be liable for negligence when the employer actively requests sensitive personal information from its employees and fails to collect and store that personal data with reasonable care. <u>Id</u>. at 1048.

B. Analysis

1. The March 19, 2021 Order Denying Plaintiffs' Motion for Summary Judgment.

In viewing the record in the light most favorable to Defendants as the nonmoving parties, Plaintiffs failed to provide sufficient evidence to show they 2021 BCBA

were entitled to summary judgment in their favor. Plaintiffs' only surviving count was their negligence claim against Defendants. Plaintiffs argued Defendants were liable for the fraudulent transaction pursuant to the negligence theory recently recognized by the Supreme Court in <u>Dittman</u>. Pls.' Br. in Supp. of Pls.' Mot. for Summ. J. at 6. However, upon considering the evidence in the record and applying the Supreme Court's reasoning to this case, it is clear that Plaintiffs' claim must fail. In <u>Dittman</u>, the Supreme Court held an employer has a duty to use reasonable care in collecting and storing its employees' sensitive personal information including social security numbers and bank account numbers when an employer actively requests the information from its employees. <u>Dittman</u>, 196 A.3d at 1048. Significantly, the Supreme Court limited its decision to cases involving employers and employees. <u>Id</u>.

In this case, Plaintiffs provided no evidence to show either Defendant actively requested any sensitive private financial information from Plaintiffs. Nothing in the record showed Defendants requested Plaintiffs' tax information, social security numbers or other sensitive personal information. Critically, neither Plaintiffs nor Defendants alleged the existence of an employer/employee relationship. Nothing in the record supported even an inference of the existence of an employer/employee relationship. Although the Court could foresee other relationships—in addition to an employer/employee relationship—where the precedent established in <u>Dittman</u> may apply, there is no Pennsylvania statutory or precedential law supporting Plaintiffs' claim of negligence against Defendants. Following careful deliberation and consideration of the record, the Court found Plaintiffs' claim for negligent collection and storage of personal information consisting of an email address failed as a matter of law.

Even assuming, arguendo, that Plaintiffs' claim against Defendants was properly raised under Dittman, Plaintiffs failed to provide sufficient evidence to show they were entitled to summary judgment. First, Plaintiffs provided no evidence to show Defendants owed them a duty of care to safeguard their email address from all potential threats. Plaintiffs argued their allegedly compromised email address was sensitive personal information similar to the information at issue in Dittman. Am. Compl. at 2-3. This Court disagrees. As previously stated, the "sensitive personal information" at issue in Dittman compromised a totality of sensitive personal information which included: social security numbers; tax information; birthdates; full names; home addresses; and personal bank account information. Dittman, 196 A.3d at 1038. Conversely, Plaintiffs' private information allegedly compromised in this case only included Plaintiffs' email address. The Court finds this a significant distinction because an email address alone does not contain the same amount of private data as does the totality of private sensitive information compromised in Dittman. Additionally, Plaintiffs failed to provide any controlling law holding a personal email address constitutes sensitive personal information. Rather, a personal email address is quasi-public information to the extent it is used by the owner of the address communicating with various other persons and entities on the internet. Thus, the Court finds the evidence in the record placed this matter well outside the scope of Dittman.

Plaintiffs also failed to provide any evidence showing Defendants breached a duty of care or that Defendants caused the fraudulent transaction. Although there was evidence showing a criminal actor emailed Plaintiffs purporting to be an agent of Delaware River Closing Services, Plaintiffs failed to identify any evidence in the record which showed Defendants were in any way responsible for the criminal actor ultimately obtaining Plaintiffs' email address. Pls.' Mot. for Summ. J., Ex. A at 5. Plaintiffs heavily relied on an FBI letter as evidence of Defendants' negligence. Pls.' Mot. for Summ. J., Ex. N. In the letter, the FBI stated Plaintiffs fell victim to a fraudulent transaction with an unknown criminal actor. Id. In addition, the FBI stated the fraudulent transaction was likely caused by a compromised business email account. Id.

Based largely on this letter, Plaintiffs made a version of a *res ipsa loquitor* argument in which they alleged the fraudulent transaction itself was prima facie evidence of Defendants' negligence. However, the FBI did not name either Defendant as a culpable party for the fraudulent transaction or compromised email account. In fact, the FBI did not even state whose email address was compromised. Plaintiffs unquestionably provided evidence to show they were victims of a fraudulent scheme and transaction yet failed to provide any evidence to show either Defendant was in any way the cause of the fraudulent transaction or owed a legal duty under Pennsylvania law with respect to their email addresses.

Ultimately, Plaintiffs' Motion for Summary Judgment was largely based on bald assertions, accusations and implications. Upon careful consideration of the record, it is abundantly clear that Plaintiffs failed to provide sufficient evidence to move forward with their claim. Accordingly, the Court denied Plaintiffs' Motion for Summary Judgment.

2. The March 19, 2021 Orders Granting Defendants' Motions for Summary Judgment.

As previously discussed, the Court found Plaintiffs erroneously relied on <u>Dittman</u> in bringing this claim for negligent failure to safeguard personal and confidential information against Defendants. Therefore, for many of the reasons previously discussed, the Court found judgment as a matter of law was warranted in Defendants' favor.

When viewing the record in the light most favorable to Plaintiffs as the nonmoving parties, the evidence—or lack thereof—clearly showed Defendants were entitled to summary judgment. In their Motions for Summary Judgment, Defendants argued Plaintiffs failed to provide any evidence to show they breached any duty allegedly owed to Plaintiffs. See Def. Kurfiss-Sotheby's Memo. in Supp. of Mot. for Summ. J. at 7 and Def. Delaware River Closing Services' Br. in Supp. of Mot. for Summ. J. at 10. Plaintiffs countered by arguing the fraudulent transaction was a result of Defendants' failure to properly secure Plaintiffs' email address. Pl.'s Mot. for

Summ. J. at 12. Plaintiffs broadly argued Defendants' lack of adequate cybersecurity caused Plaintiffs to transfer the funds to the unknown criminal actor.

The parties did not dispute that Plaintiffs contracted Kurfiss-Sotheby's realty services for the purpose of purchasing a residential property. Am. Compl. at 2. Additionally, the evidence showed the criminal actor contacted Plaintiffs via email and that the email contained a mention to Delaware River Closing Services. Pls.' Mot. for Summ. J., Ex. B. In their Amended Complaint, Plaintiffs broadly asserted Kurfiss-Sotheby's negligently maintained and secured Plaintiffs' email address. Am. Compl. at 4. However, Plaintiffs failed to identify any evidence in the record which substantiated these conclusory claims. Nothing was presented to show the criminal actor obtained Plaintiffs' email address from Kurfiss-Sotheby's. Pennsylvania law clearly states that when defending against a motion for summary judgment the nonmoving party cannot succeed by simply making "bold unsupported assertions of conclusory accusations." McCain, 549 A.2d at 1313-14. Here, Plaintiffs failed to provide any evidence to show Kurfiss-Sotheby's computer network was, in fact, breached by the criminal actor or that the email address was obtained therein as opposed to from some other source, such as Plaintiffs' host site i.e., Google, Yahoo or such other business entity. The lack of evidence in the record as well as the controlling Pennsylvania law cited herein compelled the Court to grant Kurfiss-Sotheby's Motion for Summary Judgment and enter judgment in its favor.

Plaintiffs presented even less evidence to show that Delaware River Closing Services' settlement closing agent was in any way involved with the fraudulent transaction or responsible as a party with a duty of care to protect Plaintiffs regarding their email address under the facts of the case. Plaintiffs' negligence claim against Delaware River Closing Services was based entirely on speculation and unsupported conclusory accusations. Plaintiffs failed to identify any evidence in the record which showed Delaware River Closing Services was in possession of their email address or that Delaware River Closing Services' computer system was infiltrated by the unknown criminal actor. Plaintiffs presumed Delaware River Closing Services' involvement in, or responsibility for the alleged fraudulent transaction without providing any evidence for support. Additionally, Plaintiffs presented no evidence showing Delaware River Closing Services required Plaintiffs to provide it with their personal sensitive information, that Delaware River Closing Services was in possession of Plaintiffs' sensitive personal information, nor that Delaware River Closing Services was in any way responsible for the unknown criminal actor gaining access and thereby acquiring knowledge of Plaintiffs' email address. Accordingly, the Court found Plaintiffs failed to provide evidence to establish a prima facie negligence claim against Delaware River Closing Services.

Ultimately, Plaintiffs failed to provide sufficient evidence as well as legal authority to overcome Defendants' Motions for Summary Judgment. As a result, the Court entered judgment in favor of Defendants and against Plaintiffs.
