Petaccio-Baglivio vs. Cross

Fraud or concealment – Toll the running of the statute of limitations – Motion to amend complaint to correct the name of a defendant

1. If through fraud or concealment the defendant causes the plaintiff to relax his vigilance or deviate from his right of inquiry, the defendant is estopped from invoking the bar of limitation of action.
2. The burden of proving the existence of such fraud or concealment is upon the asserting party by evidence that is clear, precise and convincing.
3. Mere negotiations toward an amicable settlement afford no basis for an estoppel, nor do mistakes, misunderstandings or lack of knowledge in themselves toll the running of the statute.
4. Conduct of a defendant's agents that causes the plaintiff to unduly relax her vigilance and delay institution of the present action to a time beyond the statutory limitation period gives rise to an estoppel.
5. Even an unintentional deception will suffice as it is not the intention of the party estopped but the natural effect upon the other party which gives vitality to an estoppel.
6. Plaintiff's Counsel credibly stated that he discussed with Defense Counsel a stipulation to amend the complaint to add Linda Cross as a Defendant; that statement was further bolstered by counsel's email enclosing a stipulation to amend the complaint to add Linda Cross as a Defendant. Plaintiff's counsel represented to the Court that he relied on Defense Counsel's representations that he would enter a stipulation to add Linda Cross as a Defendant in refraining from filing a motion to amend the complaint. Defense Counsel did not respond to the Plaintiff's counsel email until two days after the statute of limitations for a claim against Linda Cross would have expired. Plaintiff filed this Motion the same day. Defense Counsel filed a Motion for Summary Judgment alleging a failure to join an indispensable party, Linda Cross. The Court found Defense Counsel evasive with regard to whether there were ongoing discussions regarding a stipulation to add Linda Cross as a Defendant; the Court was also troubled by Defense Counsel's representation that this defense has worked before. In the present matter the Court finds that the conduct of Defense Counsel caused Plaintiff's counsel to unduly relax his vigilance and delay joinder to a time beyond the statute of limitations, which gave rise to an estoppel. Plaintiff's Motion to Amend the Complaint to Correct the Name of the Defendant was granted and the statute of limitations was tolled.

AND NOW, this 30th day of March, 2026, following a hearing this day on Plaintiff’s Motion to Amend the Complaint to Correct the Name of the Defendant on March 27, 2026, it is ORDERED that the Motion is GRANTED.¹

¹ At the outset of the hearing, both counsel were advised that they would not be placed under oath, but were reminded of their absolute duty of candor to the tribunal as set forth in R.P.C. 3.3. Plaintiff’s counsel credibly stated that he discussed with Defense Counsel a stipulation to amend the complaint to add Linda Cross as a Defendant. Those discussions took place after November 26, 2025. During this time period in January of 2026, Defense Counsel noticed an independent medical exam of the Plaintiff, despite it being beyond the time limits set forth in the Court’s April 15, 2025, Scheduling Order. (Motion Exh. 8, 9). Plaintiff’s counsel’s statements are further bolstered by his February 13, 2026, email enclosing a stipulation to amend the complaint to add Linda Cross as a Defendant. (Motion Exh. 12). Plaintiff’s counsel represented to the Court that he relied on Defense Counsel’s representations that he would enter a stipulation to add Linda Cross as a Defendant in refraining from filing a motion to amend the complaint.

Defense Counsel did not respond the Plaintiff’s counsel email regarding the stipulation until February 16, 2026 (Motion Exh. 12). The response was three days after Plaintiff’s counsel’s email was sent and two days after the statute of limitations for a claim against Linda Cross would have expired. (Motion Exh. 12). Plaintiff filed the instant Motion the same day. Despite telling Plaintiff’s counsel that he had forwarded the stipulation request, Defense Counsel then filed a Cross Motion for Summary Judgment alleging a failure to join an indispensable party, Linda Cross.

Defense Counsel represented that there were no writings regarding the proposed stipulation until February 13, 2026. The Court found him evasive with regard to whether there were ongoing discussions regarding a stipulation to add Linda Cross as a Defendant. The Court was also troubled by Defense Counsel’s representation that this defense, i.e. failure to join an indispensable party, has worked before.

In *Nesbitt v. Erie Coach Co.*, 204 A.2d 473, 476 (Pa. 1964), the plaintiff was injured in a bus accident. Plaintiff instituted a lawsuit and defendant pled expiration of the statute of limitations as a defense. The parties engaged in depositions and the trial court entered judgment in favor of defendant based on its conclusion that the statute of limitations had expired. On appeal, the Supreme Court noted that the insurance carrier’s adjuster told her “not to worry about her claim” and “it would be next to impossible to settle the case at [the present] time.” *Id.* at 475. When the plaintiff inquired about hiring an attorney, the adjuster responded

‘why hire an attorney and pay him when we haven’t refused yet’; that the case was still open and active; that he would write to the home office and ask if interim payments were possible and asked, ‘Do you mind waiting a little while longer for an answer?’ that he (the adjuster) was getting married, but not to worry and he would see her again on his return.

Id. at 475-76.

With this egregious conduct as a backdrop, the Superior Court went on to find that,

if through fraud or concealment the defendant causes the plaintiff to relax his vigilance or deviate from his right of inquiry, the defendant is estopped from invoking the bar of limitation of action. The burden of proving the existence of such fraud or concealment is upon the asserting party by evidence that is clear, precise and convincing. It is also well established that mere negotiations toward an amicable settlement afford no basis for an estoppel, nor do mistakes, misunderstandings or lack of knowledge in themselves toll the running of the statute.

Id. at 475 (citations omitted). The Superior Court concluded that, “the circumstances could reasonably lead to the conclusion that the conduct of the defendant’s agents caused the plaintiff to unduly relax her vigilance and delay institution of the present action to a time beyond the statutory limitation period. This would give rise to an estoppel.” *Id.* at 476. Because plaintiff was “lulled into a false sense of security as to the timely institution of her action,” the Superior Court found that the statute of limitations should be tolled.

It is important to note that Defense Counsel is not accused of having an intent to deceive, but no such intent is required as even an unintentional deception will suffice. “It is not the intention of the party estopped but the natural effect upon the other party which gives vitality to an estoppel.” *Id.* at 476–77. In the present matter the Court finds that the conduct of Defense Counsel caused Plaintiff’s counsel to unduly relax his vigilance and delay joinder to a time beyond the statute of limitations. This gives rise to an estoppel. Therefore, the statute of limitations was tolled, and Linda Cross shall be added to the Complaint as a Defendant.

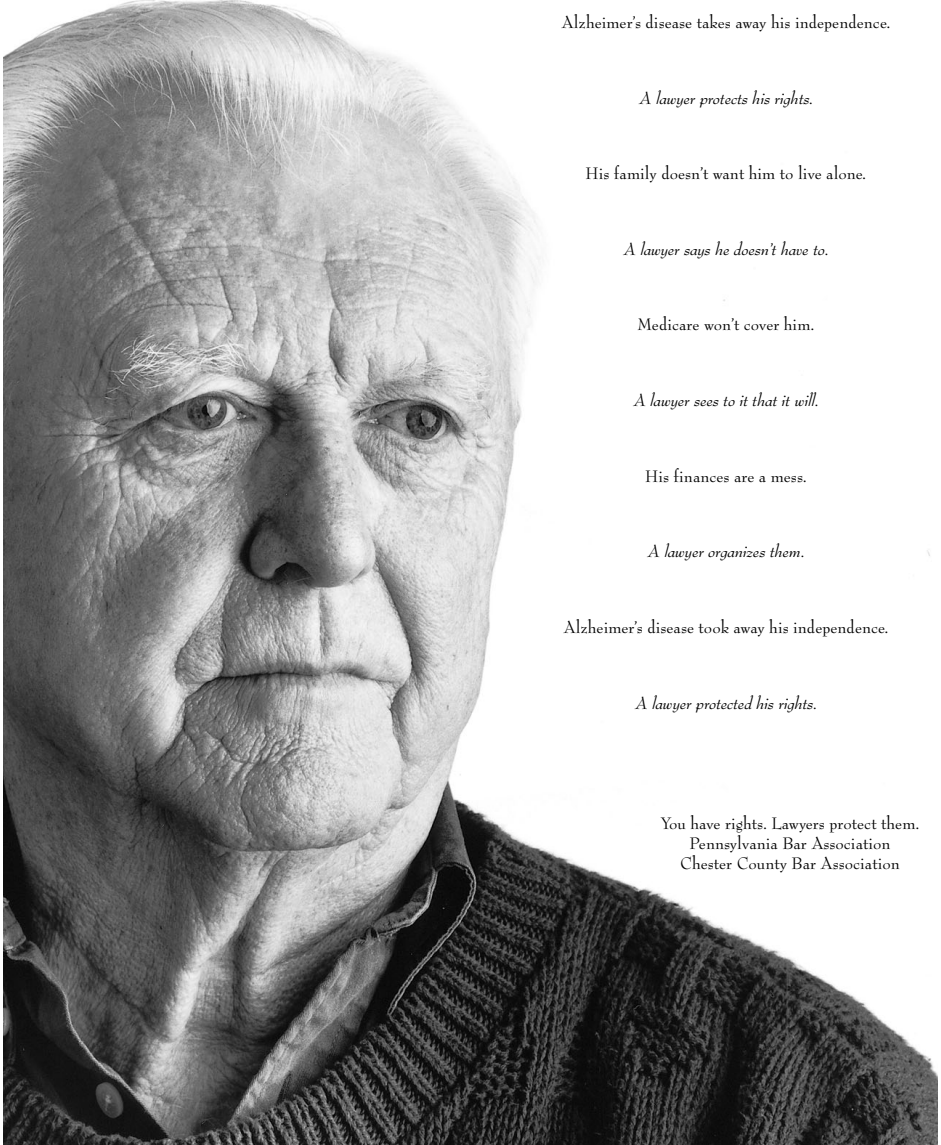

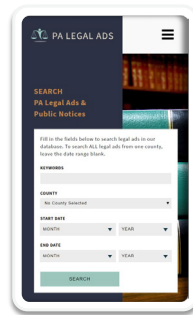
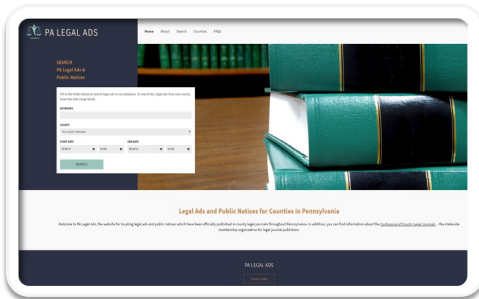
