Obiter Dictum

From the *ABA Journal Daily Newsletter*: [1] The New Jersey Supreme Court has disbarred a lawyer for charging an elderly client about \$120,000.00 for the handling of her late husband's estate in a case where an expert witness said he would have charged no more than \$15,500.00. The Supreme Court found the fee to be "utterly excessive" and the conduct involved dishonest.; [2] More than 450 inmates were recently released in one day in Oklahoma as a result of a law that retroactively applied lower sentences for drug possession and low-level poverty crimes that voters approved in 2016. The mass commutation is believed to be the largest one-day commutation in U.S. history.; [3] The U.S. Supreme Court will decide whether a generic word can be given trademark protection when it is part of a ".com" domain name in connection with an appeal filed by the U.S. Patent and Trademark Office in a case involving Booking.com. The Lanham Act bars trademark registration for generic terms. The U.S. Court of Appeals has sided with Booking.com after concluding that the domain name is not generic because the relevant public would primarily understand the term to be a specific business.; [4] An Iowa inmate who was revived multiple times at the hospital posited a novel claim that his brief death resulted in a determination that he has fulfilled the terms of his life sentence and requested that he be released from prison. Both the trial court as well as the Iowa Court of Appeals rejected the argument.; [5] A Louisiana judge told a convicted rapist that he would consider reducing his sentence, with the approval of the victim, if the defendant paid \$150,000.00 to the victim. The victim declined. In his supplemental reasons for sentencing the judge noted that the defendant had received a wind fall in a trucking accident and it seemed unfair for the defendant to receive a windfall with no compensation to the rape victim.; [6] A federal judge in Los Angeles has certified a class action lawsuit against the U.S. Soccer Federation which alleges that members of the U.S. Women's National Team receive unequal pay and work in unequal conditions compared to player's on the men's team.; [7] One of the first prisoners released under the recently enacted federal First Step Act in February has been charged with murder. The defendant, who was released after serving 14 years in prison for selling crack cocaine, is charged in the stabbing death of a man at a Rhode Island hookah lounge. U.S. Representative Karen Bass, a member of the House Judiciary Committee, views the incident as a tragedy but says that one criminal act should not be used to evaluate the effectiveness of criminal justice reform.

**PRELIMINARY OBJECTIONS—STANDARD FOR DEMURRER—TORTS—
VICARIOUS LIABILITY—THIRD PARTIES—SPECIAL RELATIONSHIPS**

[1] Demurrers are overruled unless, viewing as true all of a complaint's material facts and reasonable inferences deduced therefrom, the law says with certainty that no recovery is possible.

[2] No person has a duty to control the conduct of a third-party actor, unless a special relationship exists between the person and the actor or the person and another whom the actor harmed.

[3] A familial relationship is not, in and of itself, sufficient to create a special-relationship status.

[4] A person is not civilly liable for sexual abuse inflicted by their spouse upon a child where the person is not involved in the abuse, does not have supervision over the child, and is not otherwise responsible for the child's care.

MEMORANDUM ORDER

Before the Court are the Preliminary Objections of the Defendants raised against the Plaintiff's Complaint. The Complaint asserts claims for assault, battery, negligent infliction of emotional distress, and negligence against Defendant Hugh Keating. It asserts one count of negligence against Hugh's wife, Patricia Keating. The Defendants' Preliminary Objections challenge only the negligence claim asserted against Patricia. According to the Complaint, Hugh sexually molested Jane Doe while she was in his custody and while he was babysitting her at the Plaintiff's home.¹ Hugh subsequently pleaded guilty to two counts of corruption of minors.² The Plaintiff contends that Patricia had a duty to protect Jane Doe because she knew of prior instances of sexual assault by Hugh³ and that Patricia breached that duty when she: allowed Hugh to watch minor children; permitted sexual abuse to occur in her home; and failed to report Hugh, notify proper law enforcement, or seek mental health treatment for Hugh.⁴ In response to these allegations against Patricia, the Defendants raise two Preliminary Objections:

[The claim] against Patricia . . . is legally insufficient as no legal duty arises under the circumstances plead[ed] in the Complaint.⁵

[The claim against Patricia] is insufficiently specific⁶

Because the Court sustains the First Preliminary Objection and thereunder dismisses the negligence claim against Patricia, it is unnecessary for the Court to reach the Second Preliminary Objection. The First Preliminary Objection is in the nature of a demurrer and this Court employs the following standard:

[A]ll material facts set forth in the complaint as well as all inferences reasonably deducible therefrom are admitted as true for the purposes of review. The question presented by the demurrer is whether, on the facts averred, the law says with certainty that no recovery is possible.

Where any doubt exists as to whether a demurrer should be sustained, it should be resolved in favor of overruling the demurrer.

Juban v. Schermer, 751 A.2d 1190, 1192 (Pa.Super. 2000) (quotation omitted). The Plaintiff's negligence claim against Patricia is an attempt to impose civil liability on one person for the criminal acts of another. As the Defendants point out, the Restatement (Second) of Torts Section 315 (1965) provides that, generally:

There is no duty so to control the conduct of a third person as to prevent him from causing physical harm to another unless

(a) a special relation exists between the actor and the third person which imposes a duty upon the actor to control the third person's conduct, or

(b) a special relation exists between the actor and the other which gives to the other a right to protection.

The Pennsylvania Superior Court has already applied this section to foreclose negligence claims against a grandmother for the sexual abuse inflicted by her husband upon the couple's grandchildren. *See T.A. v. Allen*, 669 A.2d 360, 364 (Pa.Super. 1995). According to the *Allen* Court, it was of no moment that the grandmother "happened to be a co-owner of the building in which the criminal misconduct occurred." *See id.* Rather, in determining that the grandmother had no duty to control her husband's conduct, the Court found it significant that the children "were the guests of their grandfather," whom "he invited" and whom "he surreptitiously abused." *See id.*

The same is true in the instant case. The Plaintiff does not allege that Patricia had any involvement in the abuse visited upon Jane Doe. The Plaintiff does not even allege that Patricia was a co-caretaker or co-babysitter of Jane Doe or, for that matter, had *any* relationship—let alone a "special relation" conferring a "right to protection" under Section 315—with Jane Doe. Rather, the Complaint indicates that Jane Doe was molested while she was in *Hugh's* custody and while *Hugh* was babysitting her at the Plaintiff's home.⁷ Under these circumstances, Patricia cannot be liable simply for not preventing sexual abuse to occur on premises over which she has supervision (*i.e.*, her home). Likewise, Patricia cannot be liable simply because she is married to the abuser. *See id.* Even viewing all inferences reasonably deduced from the Complaint as true, the Plaintiff has not, as a matter of law, sufficiently alleged that Patricia had a duty to protect Jane Doe from *Hugh*.

Therefore, the Court SUSTAINS the First Preliminary Objection raised on behalf of Patricia Keating, and DISMISSES Patricia Keating from the case.
