# JUDICIAL OPINION

#### IN THE COURT OF COMMON PLEAS OF FAYETTE COUNTY, PENNSYLVANIA MISCELLANEOUS DOCKET

IN RE: CORONER'S INQUEST, JULIE ANN MOORE, DECEASED

#### SUMMARY

Appellant, the Fayette County Coroner, appeals from this Court's August 11, 2023 order quashing three (3) subpoenas issued by the Fayette County Coroner's Office. On August 2, 2023, counsel for White Water Adventures, Inc. (Petitioner) filed the petition to quash. The petition was presented to this Court on August 9, 2023, and this Court granted the petition on August 11, 2023. This timely appeal followed.

#### BACKGROUND

According to Petitioner's exhibits, on or about October 31, 2022, Petitioner received correspondence from the Fayette County Coroner's Office. (Exhibit B) The correspondence reads, in relevant part and verbatim:

Request: Your attendance at a group discussion in the office of the Coroner in the basement of the old post office / Federal building on Peter Street Uniontown (10:30 - 12:30-2 hour max) before December 31,2022 to review safety issues and concerns and a CHECKLIST (enclosed) of points of special interest and attention for a proposed Coroner Inquest Review at a later date (just after Easter) Wed, April 12th, Thurs. April 13th and Friday a.m. April 14th. At this meeting, your attendance and any (your selection) of one or more raft experienced staff, as well as (if available) your company legal counsel. [sic] (emphasis added)

As part of the same exhibit, Petitioner supplied the proposed agenda for the April meeting. Petitioner also supplied a copy of an online news article dated August 14, 2022, titled "Coroner names woman who died in Ohiopyle rafting accident" (Exhibit C). According to the article, the coroner stated that the Ms. Moore's death appeared to be an accidental drowning but that an investigation to reconstruct the incident was not complete.

Nearly a year after publication of the article, on or about July 17, 2023, the Fayette County Coroner's Office issued subpoenas to three (3) of Petitioner's employees. The subpoenas directed the employees to appear at a coroner's inquest on August 23-25, 2023 in order to provide testimony related to the death of Julie Ann Moore. (Exhibit A)

The petition to quash was made on the grounds that the purpose of the coroner's inquest was not to ascertain the cause and manner of death {1} or to determine if someone should be held criminally liable and, since the purpose of the inquest did not fall within the coroner's permitted scope of inquiry as granted under statute, the subpoenas should be quashed.

#### ISSUES ON APPEAL

Appellant raises three (3) issues in the Concise Statement:

1. Whether the Court erred as a matter of law in granting a Motion to Quash Subpoenas issued by the Fayette County Coroner's Office to Ryan Ayers, James Greenbaum and Matthew Cusek for the purpose of appearing at a Coroner's Inquest related to the death of Julie Ann Moore?

2. Whether the Court erred in quashing said Subpoenas when the Commonwealth Court of Pennsylvania has original jurisdiction of all civil actions or proceedings filed against the Commonwealth government, including any officer thereof acting in his official capacity in accordance with 42 Pa.C.S.A. § 761(a)(1)?

3. Whether the Court erred in quashing said Subpoenas when the Coroner has the right to issue Subpoenas to obtain the attendance of an individual who may be necessary to examine as a witness at an Inquest in accordance with 16 Pa. Stat.§ 1227-B(2)?

#### STANDARD OF REVIEW

In questions of statutory interpretation, the appellate standard of review is de novo, and the scope of review is plenary. Metropolitan Edison Company v. City of Reading, 162 A.3d 414 (Pa. 2017).

#### DISCUSSION

As to the first and third issues, the statutes under 16 P.S. § 1211-B et seq set forth the scope of the duties and powers of a coroner. First, a coroner shall investigate certain deaths for the purpose of determining whether or not an autopsy or inquest should be conducted, and the purpose of that investigation shall be to determine the cause and manner of a death and whether the death may have resulted from some criminal act. § 1218-B(a)-(b). Then, if the coroner is unable to determine the cause and manner of death after investigation, he shall perform or order an autopsy.§ 1219-B(a). Finally, if the coroner is unable to determine the cause as to the cause of death as well as whether there is any criminal responsibility. § 1219-B(b).

 $<sup>\{1\}</sup>$  After presentation of the motion on August 9, 2023, counsel for the parties confirmed to the Court through an off-the-record joint telephone call that the cause and manner of death indeed already had been determined an accidental drowning.

The purposes for which a coroner may issue a subpoena also are clearly stated, and these include: for a death investigation; to obtain attendance from a witness to an inquest; to compel attendance by attachment; or to compel production of certain documents. 16 P.S. § 1227-B.

Here, even if the cause and manner of Ms. Moore's death were still in question, the April 2023 meeting agenda as in Petitioner's Exhibit B proposed a far wider scope of inquiry. For example, the agenda included general topics such as (1) advisories that might improve safety and reduction of risk; (2) required review and/or assent to the prelaunch protocols by each customer-rafter before embarking; and (3) Commonwealth Parks Department informal and/or formal reviews. {2} The final point on the agenda is "Coroner follow up - forwarding advisories to the appropriate parties." The purpose of the inquest therefore was not to ascertain the cause and manner of Ms. Moore's death or to determine if there was some criminal action. {3}

Appellant's first and third issues therefore are without merit. This Court did not err as a matter of law in quashing the subpoenas when the statutory authority for a coroner to conduct an inquest and issue subpoenas is clearly limited to ascertaining the cause/ manner of death or potential criminal liability and the inquest here exceeded those limits.

As to Appellant's second issue, the Commonwealth Court does have original jurisdiction of all civil actions or proceedings against the Commonwealth government, including any officer thereof, acting in his official capacity. 42 Pa.C.S.A. § 761(a)(1).

However, here, the coroner's inquest and associated subpoenas exceeded the scope of inquiry allowed by statute, and so Appellant cannot be considered as acting within his official capacity in issuing the subpoenas. Under 42 Pa.C.S.A. § 761(b)

The jurisdiction of the Commonwealth Court under subsection (a) shall be exclusive except as provided in section 721 (relating to original jurisdiction [of the Supreme Court]) and except with respect to actions or proceedings by the Commonwealth government, including any officer thereof, acting in his official capacity, where the jurisdiction of the court shall be concurrent with the several courts of common pleas.

Petitioner's principal address is in Fayette County, and therefore this Court had concurrent jurisdiction to grant the petition.

 $<sup>\{2\}</sup>$  The agenda listed the following as "reviews:" regular park incident/safety reviews, the internal park review of the death event, the state formal review of the death event, and state level advisories or mandates to the local park administration related to the death event.

<sup>{3}</sup> As the petition to quash posits, the lines of inquiry proposed in the agenda are related to possible civil, not criminal, liability.

#### CONCLUSION

Here, the coroner's inquest and the associated subpoenas purported to investigate matters that were not among the specifically enumerated duties and purposes set forth in statute. This Court therefore quashed the subpoenas, having jurisdiction to do so because Appellant was not acting within his official capacity. Therefore, it is respectfully submitted that the findings and conclusions of this Court should be AFFIRMED.


