In Re: 51 ST Judicial District---Request for Emergency Judicial Order

- Michael A. George, President Judge of the 51 st Judicial District, hereby requests the following relief by Order of the Supreme Court:
  - a. Authorize the president judge to declare a judicial emergency in this judicial district and take any actions authorized by Pa.R.J.A. No. 1952(B)(2).
  - b. Suspend or modify statewide procedural or administrative rules in this judicial district as follows:
    - Authorize the expanded use of advanced communication technology to conduct court proceedings as follows:

Suspension of Pa.R.Crim.P. 119 until September 30, 2021.

- The circumstances necessitating this request for an emergency judicial order are as follows:
  - a. A nationwide pandemic involving the Coronavirus disease 2019 (COVID-19);
  - b. The continued judicial emergency in place in the 51st Judicial District, and
  - c. Adams County remaining in the category of "Substantial" level of community transmission of COVID-19 per CDC definition as of the date of this application.
  - d. Adams County experiencing an increase in COVID infection rates including the highly contagious delta variant.
- 3.
