PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

August 27, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Samantha Erin Fredericks, age 27, of Shohola, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had her driver's license suspended for 12 months for the crime of Driving Under the Influence. On October 24, 2019, the state police were dispatched to SR 434 in Shohola Township where Fredericks drove her vehicle into the opposite lane of traffic and struck another vehicle. When contact was made with Fredericks, the trooper observed Fredricks to have glassy, bloodshot eyes and emanating the smell of an alcoholic beverage. Fredericks admitted to drinking alcohol prior to driving. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .224%.

Jose Antonio Fernandez, age 25, of Dingmans Ferry, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence of a Controlled Substance. The state police stopped Fernandez on February 18, 2019, along Milford Road in Delaware Township for an expired registration. While speaking with Fernandez, the trooper detected the smell of Marihuana. Fernandez admitted to smoking Marihuana and provided the trooper with a Marihuana pipe. Field Sobriety Tests showed impairment and a blood test confirmed the presence of THC in his blood.

Zachary Ryann Schock, age 29, of Matamoras, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. Eastern Pike Regional Police were dispatched to Stella Street in Westfall Township where Schock had driven into a fence and hit a car. In speaking with Schock, the officer could smell an alcoholic beverage. Field Sobriety Tests were conducted and showed impairment. Schock refused to submit to a blood test.

Matthew Wagner Rivas, age 24, of Bronx, NY, was sentenced to a fine of \$300.00 for the crime of Possession of a Small Amount of Marihuana. The state police responded to a one vehicle crash at a residence in Lehman Township on March 8, 2019, where Rivas was found in possession of Marihuana.

Sedgrick Derrell Williams, age 29, of Baltimore, MD, was sentenced to 12 days to 6 months in the Pike County Jail, fined \$1,300.00 and had his driver's license suspended for 12 months for the crimes of Driving Under the Influence and Possession of Drug Paraphernalia. Williams was stopped by the state police on June

9, 2019, for weaving across his lane of travel along I-84 in Blooming Grove Township. Upon speaking with Williams, the trooper detected the smell of Marihuana and observed Williams to have glassy, red and bloodshot eyes with dilated pupils. Field Sobriety Tests showed impairment and a blood test confirmed the presence of THC in his blood. Williams was also found in possession of a grinder.

Edward Richard Foy, age 56, of Scranton, PA, was sentenced to 3 months to 12 months in the Pike County Jail, fimed \$2,500.00 and had his driver's license suspended for a duration to be determined by PennDOT for the crimes of Driving Under the Influence, Altered, Forged or Counterfeit Documents and Plates and the Summary Offense of Driving While Operating Privilege is Suspended or Revoked. The state police stopped Foy on September 12, 2019, while traveling along SR 507 in Greene Township for a license plate not fitting the description of the vehicle and for a suspended license. When contact was made with Foy, the trooper detected the smell of an alcoholic beverage and observed Foy to have slurred speech. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .108%.

Lindsey Elizabeth Harrigan, age 18, of Dingmans Ferry, PA, was sentenced to a fine of \$300.00 for the Summary Offense of Disorderly Conduct. Harrigan kicked the door of a vehicle causing damage on November 18, 2019, while it was parked in a parking lot along Route 6 and 20 in Westfall Township.

Kevin James Brennan, age 49, of Milford, PA, was fined \$500.00 for the crime of Possession of a Small Amount of Marihuana. The state police were dispatched to a residence in Dingman Township on October 26, 2018, to conduct a welfare check on Brennan. Brennan was found in possession of Marihuana.


