from mere noise, they say. The dispute could foreshadow other struggles with developers . . . Mr. Perlin, in refusing to allow defense experts to review TrueAllele's 170,000 lines of source code, called them a trade secret. The code, he said, would offer far less insight than the dozens of validation studies conducted on TrueAllele, including seven published in peer-reviewed scientific journals demonstrating the software's effectiveness . . . Courts in at least six states have admitted TrueAllele test results into evidence despite challenges by defense lawyers. The latest quarrel over TrueAllele is playing out in Allegheny County, Pa., where authorities plan to use it in the prosecution of Michael Robinson, who is charged with shooting to death two men and could face the death penalty. Near the scene of the killings, investigators found a black bandana that a witness said was worn by the shooter. They sent it to the county crime lab to see if it bore the DNA of their top suspect, Mr. Robinson. The lab found a mixture of DNA from at least three people on the bandana and deemed it too complex to analyze, according to the January, 2014, lab report. But TrueAllele concluded Mr. Robinson's DNA was on the garment. The report on the findings described the match as '5.7 billion times more probable than a coincidental match to an unrelated black person.' Mr. Robinson's lawyer, **Noah Geary**, said his client is entitled to 'challenge the validity and reliability of the methodology' used by Mr. Perlin's product, including the source code. A Pennsylvania judge is weighing Mr. Geary's request . . . The Federal Bureau of Investigation has acknowledged errors in its DNA database, while in a recent Commerce Department study of over 100 crime labs, only seven could correctly untangle a complex DNA mixture . . .
