PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE CHILDREN'S ADVOCACY CENTER OPENS IN MILFORD

Pike County District Attorney Raymond Tonkin gathered a large crowd to celebrate the opening of the Children's Advocacy Center (CAC) in Milford borough on Wednesday November 4, 2020 with an official ribbon cutting. DA Tonkin unveiled the name of the CAC as "Dickson House".

The CAC is named in honor of Corporal Bryon Dickson, who lost his life in the line of duty at the Pennsylvania State Police Barracks in September 2014. In his remarks, DA Tonkin recited a portion of the Call of Honor pledge of the Pennsylvania State Police. Similar to the pledge Cpl. Dickson upheld in his service to the citizens of Pike County, Tonkin vowed that Dickson House will "be of service to any abused child who is in danger or under distress." Members of Cpl. Dickson's family, including his



wife, children and parents, were present for the announcement and ribbon cutting.

Director of Children's Advocacy Center Services Sarah Wilson said the daily work of the CAC is a collaborative effort for the benefit of abused and neglected children. Wilson indicated that since late September, 26 children who were reported as victims of physical and sexual abuse were seen at Dickson House. Wilson described the facility as a child-friendly setting which allows for trauma-sensitive, neutral fact finding by investigating agencies such as law enforcement and child protective services.

The renovation of the former district court building was made possible through grant funding. Pennsylvania State Senator Lisa Baker was instrumental in securing the funding and spoke to those gathered about the importance of the work on behalf of abused children. Pennsylvania State Representatives Mike Peifer and Rosemary Brown also assisted in obtaining funding for the project.

The Pike County Commissioner's supported the development of children's advocacy center. Chairman of the County Commissioners Matthew Osterberg said, "Having a Children's Advocacy Center in Pike County establishes an integral service for abused children in their own community. Professionals are now able to more swiftly respond to these vulnerable victims and ensure their safety and healing."

The county maintenance department completed the renovation work to the building, creating a state-of-the-art forensic interview room, multidisciplinary team room and fully ADA compliant bathroom and medical room.

PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 29, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Scott Barker Hopkins, age 61, of Hawley, PA, was sentenced to 6 months of the Pike Care Program which will include 30 days of house arrest, a fine of \$1,000.00 and a driver's license suspension of 12 months for the crime of Driving Under the Influence of Alcohol. The state police were dispatched to Hemlock Farms Road in Blooming Grove township where public safety had a vehicle pulled over for erratic driving. When contact was made with the driver, Hopkins, the trooper detected the smell of an alcoholic beverage. Hopkins admitted to consuming alcohol. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .208%.

Christopher S. Plate, age 29, of Milford, PA, was sentenced to 125 days to 23 1/2 months in the Pike County Jail and fined \$1,500.00 for 2 counts of the crime of Criminal Conspiracy and 1 count of Possession of a Controlled Substance. Between August 19, 2019, and August 26, 2019, Plate and his co-defendant conspired to use a credit card to make unauthorized purchases of gift cards from a business in Westfall Township. At another business in Westfall Township, Plate and his co-defendant conspired to purchase gift cards with a credit card for which he did not have permission to use between August 19, 2019, and August 20, 2019. On January 1, 2020, the state police responded to a residence in Milford Township, where Plate was involved in a domestic disturbance and was found in possession of Heroin.

Alec David Edwards, age 27, of Olyphant, PA, was sentenced to 6 months of probation and fined \$1,000.00 for the crime of Selling or Furnishing Liquor or Malt or Brewed Beverages to Minors. Edwards held a party on July 7, 2018, at a residence in Lackawaxen Township where he provided alcohol to several minors knowing that they were under the age of 21 years.

Michael Frederick Phillips, age 28, of Lake Ariel, PA, was sentenced to 12 months of probation and fined \$400.00 for the crimes of Theft by Unlawful Taking and Hindering Apprehension of Prosecution. On June 9, 2019, the state police responded to a residence in Greene Township with an active warrant for an individual. Phillips provided false information to the state police regarding the individual in order to conceal the individual's whereabouts. On August 26, 2019, Phillips took packages from a residence in Greene Township without the owner's permission.

Destiny Marie Conklin, age 25, of Port Jervis, NY, was sentenced to 3 months to 12 months in the Pike County Jail and fined \$600.00 for 2 counts of the crime of Possession of Drug Paraphernalia. Conklin was a passenger in a vehicle stopped for no inspection sticker on February 1, 2020, along SR 739 in Dingman Township. The trooper detected the smell of Marihuana and a probable cause search revealed a Marihuana pipe belonging to Conklin. Eastern Pike Regional Police were dispatched to a motel on May 10, 2020, for a domestic incident involving Conklin. A search of

the room revealed needles, glassine packs and other paraphernalia.

Amiello Joseph Amato, age 34, of Sparrowbush, NY, was sentenced to 11 1/2 months to 23 1/2 months in the Pike County Jail and fined \$1,000.00 for 2 counts of the crime of Retail Theft. On January 17, 2020, Amato took tools with a retail value of \$509.54 from a store in Westfall Township and was stopped when he left the store without paying for them. Later that same day, Amato was observed on the store's security camera taking tools with a total value of \$399.99 without paying for them.

Matthew John Williams, age 27, of Tafton, PA, was sentenced to 6 months and 90 days to 6 years in a state correctional facility, fined \$2,800.00 and had his driver's license suspended for 42 months for 2 counts of the crime of Driving Under the Influence of a Controlled Substance, 1 count of Possession of a Controlled Substance, and Driving While Operating Privilege is Suspended or Revoked. Williams was stopped by the state police on May 4, 2019, for failing to keep his vehicle in its lane while traveling along I-84 in Palmyra Township. Williams had difficulty focusing and speaking with the trooper. A rolled-up dollar bill was observed on the vehicle seat. Field Sobriety Tests showed multiple signs of impairment and a blood test confirmed the presence of Morphine is his blood. Williams was also found in possession of Heroin. Williams was stopped by the state police on July 25, 2019, along Ranch Road in Blooming Grove Township for no brake light. Williams was found driving on a suspended license. The trooper observed Williams displaying numerous signs of impairment. A consent to search the vehicle revealed an empty glassine packet. Williams refused to submit to a blood test.

Dimitri Taranov, age 51, of Manchester, NH, was sentenced to 18 months to 36 months in a state correctional facility and fine \$10,000.00 for the crimes of Possession with Intent to Manufacture or Deliver a Controlled or Counterfeit Substance and Criminal Conspiracy to Commit Possession with Intent to Manufacture or Deliver a Controlled or Counterfeit Substance. Following a drug investigation, the state police executed a search warrant at a residence in Lehman Township on October 28, 2019, where Taranov was conducting a large scale hallucinogenic mushroom operation. Found was large amounts of mushrooms in various stages of process together with shipping materials and scales, printers, labels, U.S. currency and multiple cell phones and computers.

Sean Nicholas Magee, age 33, of Dingmans Ferry, PA, was sentenced to 48 hours to 6 months in the Pike County Jail, fined \$500.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police stopped Magee on May 27, 2019, at the intersection of Myck Road and Fawn Lake Road in Delaware Township for driving haphazardly. When speaking with Magee, the trooper detected the smell of an alcoholic beverage and observed Magee to have red, glassy, bloodshot eyes. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .152%.

Peter Joseph Saunders, age 58, of Greentown, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,200.00 and had his driver's license suspended for 24 months for the crime of Driving Under the Influence of a Controlled or Counterfeit Substance and the Summary Offense of Driving While Operating

Privilege is Suspended or Revoked. The state police were dispatched to SR 507 in Greene Township on September 7, 2019, where Saunders was observed driving carelessly. Saunders was located in a parking lot along SR 507 asleep behind the wheel of the vehicle which was running. Saunders had difficulty maintaining balance and answering basic questions. A blood test confirmed the presence of Clonazepam and Aminoclonazepam in his blood.

Allen David Beck, age 53, of Bushkill, PA, was sentenced to 120 days to 6 months in the Pike County Jail, fined \$1,750.00 and had his driver's license suspended for a duration to be determined by PennDOT for the crime of Driving Under the Influence and the Summary Offense of Driving While Operating Privilege is Suspended or Revoked. The state police were advised by a witness of a vehicle accident involving Beck. The state police located Beck along SR 402 in Blooming Grove Township. Upon making contact with Beck, the trooper detected the smell of an alcoholic beverage. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .125%.

November 6, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Michael Douglas Gardner, age 29, of Matamoras, PA, was sentenced to 4 years to 10 years in a state correctional facility, followed by 3 years of probation and fined \$500.00 for the crime of Involuntary Deviate Sexual Intercourse. Gardner had deviate sexual intercourse with an individual on July 10, 2019, at a residence in Matamoras Borough. Gardner ignored the individual's request to stop. Gardner will be required to register as a sexual offender for the remainder of his lifetime.

Michael Joseph Leone, age 21, of Milford, PA, was sentenced to 11 months to 23 1/2 months in the Pike County Jail followed by 5 years of probation and a fine of \$1,000.00 for the crimes of Unlawful Contact with a Minor and Corruption of a Minor. Leone communicated from his residence in Dingman Township through the use of a cell phone with a minor child between July of 2019 and September of 2019, during which he requested nude photographs of the child and sent the child nude photographs of himself and sought a sexual relationship with a minor child. Leone will be required to register as a Tier I Sexual Offender.

Eric John Goller, age 31, of Greentown, PA, was sentenced to 47 months to 126 months in a state correctional facility and fined \$1,200.00 for 4 counts of the crime of Sexual Abuse of Children. Between May 4, 2018, and December 17, 2018, at his residence in Greene Township, Goller was found in possession of images of child sexual exploitation. Goller will be required to register as a Tier II Sexual Offender.


