## Artisan Builders v. Jang

Quantum meruit

- 1. An action in *quantum meruit* sounds in *quasi* contract or contract implied in law and seeks the equitable remedy of restitution where one person has been unjustly enriched by the services of another.
- 2. Where unjust enrichment is found, the law implies a contract, which requires the defendant to pay to the plaintiff the value of the benefit conferred.
- 3. To prove a *quantum meruit* claim, the plaintiff cannot merely submit its own loss, i.e., the value of labor and materials expended, as the measure of recovery, but must instead demonstrate that the defendant has in fact been benefitted.
- 4. The value of the invoices is not a proper measure of enrichment whereas appraised value is relevant to the question of enrichment.
- Artisan Builders, Inc. (ABI) entered into a series of agreements with Defen-5. dant Jang to perform renovations at Jang's residential property. The scope of the work would eventually comprise 5 base contracts and 18 change orders. Before the work on the house was complete, Defendant Jang fired Plaintiff ABI. Plaintiff instituted a Mechanics' Lien. A trial was held and a compulsory non-suit was granted on the Mechanic's Lien claim, holding that the contracts between Artisan and Jang were invalid, as the contracts did not comply with the terms of the Home Improvement and Consumer Protection Act ("HICPA"). The Court, however, gave Plaintiff leave of court to file an Amended Complaint to seek damages for quantum meruit. An Amended Complaint was filed, seeking damages for quantum meruit. Defendant filed preliminary objections which were sustained in part because the Court determined that the Pennsylvania Contractor and Subcontractor Payment Act ("PCSPA"), did not apply to a single home renovation and struck that claim. The court made it clear it wanted the reasonable value of services that were requested by defendant. ABI produced over 500 pages of receipts, time sheets, invoices, documents signed by Defendant, emails, and other evidence of work ABI performed but that is not what the court was looking for. Appraised value was not submitted by plaintiff. The court found in favor of the Defendant.

## FACTUAL BACKGROUND

This matter is a claim for quantum meruit and other equitable relief by Plaintiff Artisan Builders, Inc. ("ABI") against Defendant So Young Jang ("Jang").

ABI entered into a series of agreements with Defendant Jang to perform renovations at Jang's residential property located at 222 Lenape Drive, Berwyn PA, 19312. ABI is a small, local business based in East Norriton, PA. The principal of ABI, Mr. Scott McClain, has been in the construction business for more than twenty years.

Work on the property began after multiple contracts were signed by Defendant Jang on or about February 2, 2016. The scope of work initially contemplated renovation of the kitchen. However, the scope was changed to include additional work throughout the rest of the house, including rehabilitation and renovation of, inter alia, the first and second floor flooring, the master bathroom, baseboards, lighting, crawlspace insulation, replacement of structurally unsound joists, and multiple doors and door frames. The scope of the work would eventually comprise five (5) base contracts and eighteen (18) change orders. Defendant Jang was aware of the work being performed, and all work was performed with the express permission and authority of Jang.

On or about June 29, 2016, before the work on the house was complete, Defendant Jang fired Plaintiff ABI.

On or about August 1, 2016, Plaintiff Artisan Builders instituted a Mechanics' Lien (the "Claim") in the Court of Common Pleas of Chester County, docketed at No.: 2016-07178.

On or about January 14, 2020, a trial was held before the Honorable Mark L. Tunnell, at which

time both Mr. McClain and Defendant Jang testified. Following the close of Plaintiff's case, on Motion by Defendant Jang, Judge Tunnell granted a compulsory non-suit on the Mechanic's Lien claim, holding that the contracts between Artisan and Jang were invalid, as the contracts did not comply with the terms of the Home Improvement and Consumer Protection Act ("HICPA"). Judge Tunnell, however, gave Plaintiff leave of court to file an Amended Complaint to seek damages for *quantum meruit*, and ordered that the trial be continued for the Court to determine the reasonable value of the services requested by Defendant Jang.

An Amended Complaint seeking damages for *quantum meruit* and other equitable relief was filed by ABI on or about January 27, 2020. Defendant filed preliminary objections which were sustained in part and overruled in part. Specifically, the Court determined that the Pennsylvania Contractor and Subcontractor Payment Act ("PCSPA"), 73 Pa.C.S.§500 *et seq*. did not apply to a single home renovation and struck that claim. The Court further permitted the claim for *quantum meruit* to proceed.

In addition to the foregoing, found as facts, the court finds the following to be true:

1. The court made clear in its order of January 14, 2020 what it wanted:

"In order for the court to determine what the reasonable value of services that were requested by defendant, So Young Jang, the court will continue the matter to a future date."

- 2. The second day of testimony occurred on June 10, 2020.
- 3. Defendant Jang withdraw the related case entitled *Jang v. Artisan Builders, Inc.*, Chester County, CCP, Docket No: 2018-05914. (N.T. at 107).
- 4. The total amount claimed to be due from Defendant Jang to ABI for services performed on the Jang home is \$35,371.47. (Exhibit P-1, N.T. at 10).
- The \$35,371.47 figure was determined by Mr. McClain after running a QuickBooks report tracking the costs, expenses and comparison of the original estimates with the invoices billed out. This is something he does in the regular course of business. (N.T. at 11).
- 6. The new amount of damages claimed by ABI is \$43,525.06. (N.T. at 107).
- Mr. McClain is familiar with the amounts of money paid to subcontractors and other work ers. (N.T. at 110).
- 8. He told the court that the prices he charges for the services he provides are fair and reason able, if not lower than average for the "Main Line". (N.T. at 112-113).
- 9. The cost of the renovations requested by Defendant Jang totaled \$167,131.30. Defendant Jang had paid the bulk of the costs before ABI was fired. However, ABI claimed it was still owed \$30,091.47 in labor and materials, plus an additional \$5,280.00 in administrative fees as follows:

 ABI produced over five hundred (500) pages of receipts, time sheets, invoices, documents signed by Defendant Jang, emails, and other evidence of the work ABI performed.

#### **DISCUSSION**

But that is not what the court was looking for.

The parties are agreed that an action in *quantum meruit* sounds in *quasi* contract or contract implied in law and seeks the equitable remedy of restitution where one person has been unjustly enriched by the services of another. Where unjust enrichment is found, the law implies a contract, which requires the defendant to pay to the plaintiff <u>the value of the benefit conferred</u>. *Mitchell v. Moore*, 729 A.2d 1200 (Pa. Super. 1999). (Emphasis added.)

However, the plaintiff cannot merely submit its own loss, i.e., the value of labor and materials expended, as the measure of recovery, but must instead demonstrate that the defendant has in fact been benefitted, as the Supreme Court of Pennsylvania held in 1963, in *Meehan v. Cheltenham Twp.*, 189 A.2d 1593 (Pa. 1963). For example, in *D.A. Hill Co. v. Cleve Trust Realty Investors*, 573 A.2d 1005 (Pa. 1990), certain subcontractors who worked on a mall until foreclosure attempted to establish enrichment by evidence of their unpaid invoices. They also had evidence of the value of the mall as determined by an appraisal which was done about seven (7) months before the mortgage foreclosure. Quoting *Meehan*, the Supreme Court again said "the value of the invoices is not a proper measure of enrichment." The court went on to say that the appraised value of the mall, on the other hand, is velevant to the question of enrichment. However, there was a problem in that case with the appraisals. Ultimately, neither the amount of the invoices nor the appraisals were sufficient to establish the value of the benefit conferred "for the invoices were irrelevant to the question of enrichment." *Id.* at 433.

Here, although ABI went to considerable trouble to amass all its invoices, estimates, contracts and other such documents in a thick file, this court has no idea of whether there was a benefit to the Jang property and, if so, in what amount. Such a benefit could have been shown by, for example, appraisals secured by knowledgeable individuals. In *D.A. Hill Co.*, the figures were a wash, so no enrichment resulted.

Consequently, the court must find in favor of the Defendant Jang.
