# COMMONWEALTH OF PENNSYLVANIA VS. TERRY W. LOGUE

1. A police officer must have either reasonable suspicion or probable cause to perform a traffic stop of a motor vehicle. [W]hen considering whether reasonable suspicion or probable cause is required constitutionally to make a vehicle stop, the nature of the violation has to be considered.

2. In this matter, Trooper Howell required probable cause to stop Defendant's vehicle because the traffic stop did not serve an investigatory purpose. Officer Howell testified that the Camry had illegal window tint; he did not state that the tint required additional investigation.

3. Here, Trooper Howell did not have the requisite probable cause under *Prizzia* to stop Defendant's vehicle because it was possible for Trooper Howell to see inside the Camry despite the presence of window tint. *Prizzia* dictates that probable cause to stop a vehicle for illegal window tint exists only if "the tint on the vehicle's windows is so dark that it prohibits the officer from seeing inside the car."

# OPINION ON DEFENDANT'S OMNIBUS PRETRIAL MOTION

Presently before this Court is Defendant Terry W. Logue's Omnibus Pre-Trial Motion to Suppress, filed January 14, 2022. A hearing was held on February 15, 2022. The issue before the Court is whether Trooper Logan Howell had probable cause to stop Defendant's vehicle for illegal window tint. For the reasons set forth herein, Defendant's Motion to Suppress is granted.

## FINDINGS OF FACT

- 1. Trooper Logan Howell ("Trooper Howell") has been employed with the Pennsylvania State Police for two and a half years. Trooper Howell received 27 weeks of training at the Pennsylvania State Police Academy, which included instruction concerning window tint in motor vehicles. Trooper Howell's duties as a Pennsylvania State Police Trooper include routine patrol.
- 2. Trooper Howell has experience relating to violations of the Vehicle Code and has performed 30 or more traffic stops for

window tint violations during his career as a Pennsylvania State Police Trooper.

- 3. On May 27, 2021, at approximately 5:13 p.m., Trooper Howell was on routine patrol in an unmarked police vehicle in the vicinity of York Road and Swift Run Road in Mount Pleasant Township, Adams County, Pennsylvania. Trooper Howell's vehicle was stationary near Swift Run Road and was facing York Road.
- 4. At this time, Trooper Howell observed a tan Toyota Camry heading eastbound on York Road with what appeared to be illegal tint on its driver's side windows. The Camry's driver's side windows were facing Trooper Howell as the Camry passed his location. The window tint obstructed Trooper Howell's view from outside the Camry to inside the Camry.
- 5. As a result of his observations, Trooper Howell began to follow the Camry. Trooper Howell followed the Camry for approximately one to one and a half miles before he pulled directly behind it. Part of Trooper Howell's pursuit of the Camry was captured on an MVR video.
- 6. After Trooper Howell pulled directly behind the Camry, he ran its registration and initiated a traffic stop because of the apparent window tint violation.
- Trooper Howell made contact with the driver of the Camry, whom he identified as Defendant Terry W.Logue ("Defendant"). The MVR video shows that Trooper Howell explained to Defendant that the Camry's windows were illegally tinted.
- 8. Trooper Howell subsequently arrested Defendant on suspicion of DUI.
- 9. The MVR video shows that oncoming traffic and roadside objects were visible through the rear and front windshield. A silhouette of Defendant's head, the Camry's seats and rearview mirror were visible through the Camry's rear windshield. However, the tint on the Camry's rear windshield made it more difficult to see inside the Camry.

# CONCLUSION OF LAW

1. Trooper Howell did not have probable cause to stop Defendant's vehicle.

## LEGAL STANDARD

In a suppression hearing, the Commonwealth has the burden to establish, by a preponderance of the evidence, the admissibility of those items the accused seeks to preclude. *Commonwealth v. Ruey*, 892 A.2d 802, 807 (Pa. 2006). Moreover, "it is the sole province of the suppression court to weigh the credibility of the witnesses. Further, the suppression court judge is entitled to believe all, part or none of the evidence presented." *Commonwealth v. Benton*, 655 A.2d 1030, 1032 (Pa. Super. 1995) (internal citations omitted).

A police officer must have either reasonable suspicion or probable cause to perform a traffic stop of a motor vehicle. *Commonwealth v. Salter*, 121 A.3d 987, 993 (Pa. Super. 2015). As the Superior Court of Pennsylvania has explained,

when considering whether reasonable suspicion or probable cause is required constitutionally to make a vehicle stop, the nature of the violation has to be considered. If it is not necessary to stop the vehicle to establish that a violation of the Vehicle Code has occurred, an officer must possess probable cause to stop the vehicle. Where a violation is suspected, but a stop is necessary to further investigate whether a violation has occurred, an officer need only possess reasonable suspicion to make the stop.

Id. Thus,

[a] vehicle stop based solely on offenses not 'investigatable' cannot be justified by a mere reasonable suspicion, because the purposes of a *Terry* stop do not exist—maintaining the status quo while investigating is inapplicable where there is nothing further to investigate. An officer must have probable cause to make a constitutional vehicle stop for such offenses.

*Commonwealth v. Landis*, 89 A.3d 694, 703 (Pa. Super. 2014) (footnote omitted).

Reasonable suspicion exists if the police officer reasonably believes "that the individual is engaging in criminal conduct." *Commonwealth v. Ulman*, 902 A.2d 514, 518 (Pa. Super. 2006). However, probable cause requires a greater quantum of suspicion: "Probable cause exists where the facts and circumstances within the knowledge of the officer are based on reasonably trustworthy information and are sufficient to warrant a man of reasonable caution in the belief that the suspect 'has committed or is committing a crime.'" *Commonwealth v. Joseph*, 34 A.3d 855, 863 (Pa. Super. 2011) (quoting *Commonwealth v. Thompson*, 985 A.2d 928, 931 (Pa. 2009)). When a non-investigable vehicle offense has occurred, an officer must "articulate specific facts possessed by him at the time of the questioned stop, which would provide probable cause to believe that the vehicle or the driver was in violation of some provision of the [Vehicle] Code." *Commonwealth v. Feczko*, 10 A.3d 1285, 1291 (Pa. Super. 2010) (emphasis in original). Probable cause is evaluated based on the totality of the circumstances. *Id.* 

### **DISCUSSION**

The facts of this case and the applicable law require the Court to grant Defendant's motion. Trooper Howell did not have probable cause to conduct a traffic stop of Defendant's vehicle even though his view into its interior was obstructed by window tint. The reasons for this determination are elaborated herein.

Under Section 4524(e)(1) of the Vehicle Code, "[n]o person shall drive any motor vehicle with any sun screening device or other material which does not permit a person to see or view the inside of the vehicle through the windshield, side wing or side window of the vehicle." 75 Pa.C.S. § 4524(e)(1). The quantum of suspicion necessary for a police officer to stop a vehicle for a suspected "window-tint violation under section 4524(e)(1)" varies according to the nature of the officer's observation of the window tint. *Commonwealth v. Prizzia*, 260 A.3d 263, 269 n.2 (Pa. Super. 2021). If the "window-tint violation was immediately apparent to the officer, and no further investigatory purpose was served by the traffic stop," the traffic stop must be supported by probable cause. *Id.* By contrast, "if the specific facts of the case demonstrate that an investigatory purpose was served by the stop," reasonable suspicion may be the applicable standard. *Id.* 

"[T]o possess probable cause that a vehicle is in violation of section 4524(e)(1), an officer must only observe that the tint on the vehicle's windows is so dark that it *prohibits the officer from seeing inside the car.*" *Id.* at 270 (emphasis added); see also *Commonwealth v. Harris*, 176 A.3d 1009, 1019–20 (Pa. Super. 2017); *Commonwealth*  *v. Scales*, No. 283 MDA 2021, 2021 WL 5027403, at \*4 (Pa. Super. Oct. 29, 2021). Although Section 4524(e)(2) provides exceptions to the rule established by Section 4524(e)(1), "an officer who observes a window-tint violation under section 4524(e)(1) has no burden to confirm that an (e)(2) exception does *not* apply before he or she has probable cause to stop the vehicle." *Prizzia*, 260 A.3d at 270 (emphasis in original).

In this matter, Trooper Howell required probable cause to stop Defendant's vehicle because the traffic stop did not serve an investigatory purpose. Officer Howell testified that the Camry had illegal window tint; he did not state that the tint required additional investigation. Trooper Howell's remarks to Defendant during the traffic stop, which were recorded on the MVR video, also indicate the traffic stop did not serve an investigatory purpose: before the DUI investigation began, Trooper Howell informed Defendant that the Camry had illegal window tint. Because Trooper Howell did not conduct further investigation of the Camry's window tint, Trooper Howell required probable cause to stop Defendant's vehicle.

Here, Trooper Howell did not have the requisite probable cause under *Prizzia* to stop Defendant's vehicle because it was possible for Trooper Howell to see inside the Camry despite the presence of window tint. Prizzia dictates that probable cause to stop a vehicle for illegal window tint exists only if "the tint on the vehicle's windows is so dark that it prohibits the officer from seeing inside the car." 260 A.3d at 270. Here, Trooper Howell testified that the tint on the Camry's windows "obstructed" his view into the vehicle but also acknowledged that he could see the silhouette of Defendant's head despite the window tint. This Court's review of the MVR video confirms Trooper Howell's testimony that the Camry's window tint "obstructed" but did not prohibit an observer's view into the Camry's interior. Moreover, although the MVR video primarily depicts the view through the Camry's rear windshield and front windshield, the Commonwealth presented no testimony that the tint on the rear and front windshields was less severe than the tint on the side windows first observed by Trooper Howell. Thus, on the evidence presented at the suppression hearing, the Court cannot conclude the Commonwealth has met its burden to show Trooper Howell had probable cause to stop Defendant's vehicle.

Therefore, for the reasons set forth above, the attached Order granting Defendant's Omnibus Pre-Trial Motion to Suppress is entered.
