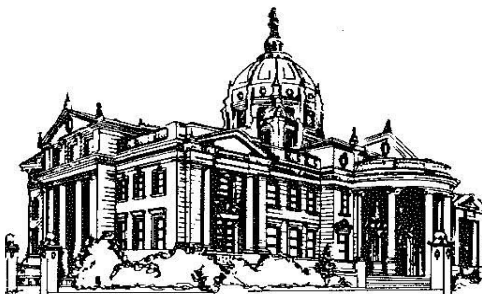

## OBITER DICTUM

From the ABA Journal Daily Newsletter: [1] The U.S. Supreme Court recently allowed the Trump Administration to end, for now, a policy under which people can self identify their gender on passports. The Justices' decision revives an executive order by President Trump that required passports to reflect a persons sex as listed on their birth certificate. A lower court had blocked Trump's policy. The high court's order will remain in effect while the legal fight over the Trump policy plays out in the lower courts. [2] Disclosure of client information in support of a withdrawal motion must be narrowly tailored, according to a new ethics opinion from the ABA's standing Committee on Ethics and Professional Responsibility. Recently published, formal Opinion 519 notes that Model Rule 1.6 of the ABA Model Rules of Professional Conduct protects all information relating to the representation, and Model Rule 1.16 addresses a lawyer's termination of a representation. According to the opinion, neither rule authorizes lawyers to disclose client information nor "establish an explicit exception to the duty of confidentiality." Lawyers may be able to obtain client consent to withdraw, which will obviate the need to explain the basis for withdrawal. Also, the client may further give informed consent to disclosures that the lawyer deems to be necessary to make in the withdrawal motion. Otherwise, if a lawyer has to explain the basis of the withdrawal, they first should use a formulaic reference to "professional considerations" or similar language, according to the opinion. If the judge requires more information, the attorney should seek "to persuade the court to rule on the motion without requiring the disclosure of confidential information, asserting all non-frivolous claims for maintaining confidentiality." If the court still requires more information, according to the opinion, the lawyer should seek permission to provide the necessary information "in camera and ex-parte." Or, the lawyer can try to provide the information under seal. Other News: Seller has no duty to disclose tile floor in residential property that incorporated both a swastika and what appeared to be a Nazi eagle, both of which were covered by rugs before purchase, since otherwise functional floor incorporating those symbols does not constitute material defect under the Real Estate Seller Disclosure Law. *Wentworth v. Steinmetz*, 2025 PA Super 253 (Nov. 12, 2025).

Effective 11/7/25: Line rate calculated as follows: 10-point font (Times New Roman), approximately 57 lines per column, three columns per page.

Per line notices cancellations: If after first insertion, refund 50% of original invoice less \$40 set-up fee; if after second insertion, refund 34% of original invoice less \$40 set-up fee. If canceled after line-rate for sale has already determined, full amount of original invoice less \$40 set-up fee (full refund if line-rate not yet calculated).

Advertiser-generated Inserts: **\$1,700** flat rate for advertiser-generated inserts that do not conform to publication size and are published as an insert; in addition, the Legal Notice (“header”) included with the insert must be published separately in the journal's main section at an additional cost, calculated based on the Per Line Rate established above.

Digital/Email Subscription rate: \$85 [included in dues for WCBA members].

Single-issue copies: **\$5** (+postage, if mailed).

**PUBLISHING POLICIES:**

- All legal notices must be pre-paid unless approved by publisher. An account past due more than 60 days or in excess of \$500 is not eligible for a discretionary waiver of pre-payment until that account is paid in full.
- Publisher has the right to decline to publish any material.
- Publisher does not edit for content or substance and is not responsible for errors made by the advertiser.
- Price deviations in exceptional circumstances regarding individual notices are at the discretion of WCBA administrative staff in consultation with the legal journal editor and/or the Publisher’s authorized designee.
- Placement and categorization of items submitted for publication: A.) Items which may have legal ramifications, such as those having publication deadlines, or which may be required to be published by law, statute, rule or Court Order, are considered a “legal notice,” which must be paid in advance (unless pre-payment is waived by publisher) by the advertising party, and for which advertiser will receive an Affidavit. B.) Items of general information or relevance to the profession or Bar Association that are not required by law, statute, rule, or Court Order to be published may be inserted in the format selected by, and at the sole discretion of, the Publisher. These notices will not receive an Affidavit and are generally published at no charge but may be published as a paid display ad if advertiser chooses to do so. C.) Communications from the Court pertaining to the profession generally, as opposed to required publication notices, may be published at the discretion of Publisher as a “Notice to the Profession,” which will generally be deemed to be a public service at no charge.
