

Every Pennsylvania Judge must make a decision of whether or not to become a candidate for retention in the final months of the year prior to the expiration of his elected term.

Now that has been professionally recommended that I take a Leave for an additional thirty (30) days, it is time for me to make that decision, and do what is right for the Court, and right for my own wellness. I will not be a candidate for Retention in 2021.

It follows then, that this is also the right time for me to voluntarily resign as President Judge, which I do now, to become effective at the close of October 31, 2020.

In reversing our roles, President Judge Dayich and I will have a year to work together as a fully informed Court that is ready, willing and able to welcome a new Judge in 2022. Within the judiciary, this trading of places at this time, is a best practice.

In whatever capacity, it is a privilege to be able to continue to serve the Court. And by voluntarily making these decisions now, I hope to be honoring the highest Court standards, and its many traditions.
