## Trautman vs. CBS Broadcasting Inc, et al

Motion to quash subpoena - Criminal History Records Information Act – Investigative information

- 1. The Pennsylvania Criminal History Records Information Act (CHRIA) applies to criminal justice agencies, which includes, courts, state and municipal police departments, and prosecuting attorneys.
- 2. CHRIA provides that investigative information shall not be disseminated to non-criminal justice agencies.
- 3. Investigative information shall only be provided to a criminal justice agency if the agency requests the information in connection with its duties, and the request is based upon a name, fingerprints, modus operandi, genetic typing, voice print or other identifying characteristic.
- 4. Violations of CHRIA are subject to administrative penalties and civil penalties pursuant to various statutes.
- 5. Investigative information is defined in the CHRIA as information assembled as a result of the performance of any inquiry, formal or informal, into a criminal incident or an allegation of criminal wrongdoing and may include modus operandi information.
- 6. Pa.R.C.P. No. 4003.1(a) provides that a party may obtain discovery regarding any matter, not privileged, which is relevant to the subject matter involved in the pending action.
- 7. CHRIA's penalties for improper disclosure do not include an exception for production via discovery in a civil case.
- 8. By its express terms, CHRIA does not provide a privilege but a duty of confidentiality.
- 9. CHRIA protects information gathered as a result of an investigation into criminal activity.
- 10. The current Right to Know Law excepts from public records a record of an agency relating to or resulting in a criminal investigation, including investigative materials, notes, correspondence, videos and reports and any records, that, if disclosed, would reveal the institution, progress or result of a criminal investigation, except the filing of criminal charges.
- 11. There are explicit carveouts from CHRIA for court dockets, police blotter information, and announcements of executive clemency but there are no carveouts for materials already produced from other sources, materials used at trial, bodycam footage, etc. or because the information is possessed or even created by a third party.
- 12. No express language exists allowing for the waiver of the confidentiality by any party.
- 13. The provisions of CHRIA create a duty of confidentiality on the police that is

only eliminated with its specific carveouts or, in criminal prosecutions, the due process concerns of a criminal defendant.

- 14. CHRIA creates an evidential privilege for purposes of Pa.R.C.P. No. 4003.1 although no party expressly holds the privilege for purposes of waiver.
- 15. CHRIA creates both a confidentiality prohibition on disclosure and a privilege for protected materials. The statute defines investigative information as information assembled as a result of the performance of any inquiry, formal or informal, into a criminal incident or an allegation of criminal wrongdoing and may include modus operandi information.
- 16. Motor Vehicle Recordings (MVRs) do not, generally, constitute *per se* protected investigative information, and therefore the question of whether information captured on a particular MVR is to be excluded from public access under CHRIA must be determined on a case-by case basis.
- 17. The analysis applicable to bodycam footage should be the same as the analysis applicable to MVR footage.
- 18. A common-sense rule is that footage captured during an active, known, and ongoing crime scene contains footage, when possessed by a criminal justice agency, is investigative information pursuant to CHRIA.
- 19. That the U.S. Constitution requires disclosure of any information favorable to a criminal defendant, which would by necessity include information protected by CHRIA, does not apply to a private party plaintiff bringing a claim against a private defendant.
- 20. The underlying case is a civil defamation and false light action arising out of statements publicized via an online print news article and live video news broadcast. CBS Broadcasting and its employee, Defendant Matthew Petrillo, broadcast a news report arising out of a "barricade situation" involving the barricade suspect and the Chester County Regional Emergency Response Team, which includes Detective Trautmann, the Plaintiff in the underlying civil action. At issue currently are the subpoenas served which sought the video/audio footage taken at the scene of the barricade, including bodycam footage. The basis for the motions to quash centers on the CHRIA. Objectors suggest CHRIA protects a criminal justice agency from disclosing its methods, strategies, or the like. The interest of the police in preserving their methods in response to an ongoing barricade situation, evidence collection methods, and the like, weigh in favor of finding a privilege in the present matter. The Downingtown Borough Police Department's filed a Motion to Quash Defendants' Subpoena Served upon the police department and its Chief of Police and the Chester County District Attorney's Office filed a Motion to Quash Paragraph 12 of Defendant CBS's Subpoena to Attend and Testify and to Produce Documents. The Court Held the Motions to Quash were granted.

#### MEMORANDUM

The underlying case at issue involves a civil defamation and false light action arising out of statements publicized via an online print news article and live video news broadcast. In brief, on July 6, 2020, Defendant CBS Broadcasting, Inc., t/a CBS3, through its employee, Defendant Matthew Petrillo (collectively "Defendants"), broadcast a news report arising out of a "barricade situation" that occurred on Christmas Day, 2018, involving the barricade suspect Nathaniel Lewis (Lewis) and members of the Chester County Regional Emergency Response Team (aka "RRT" or "ERT") who responded to the situation, including Detective Paul A. Trautmann (Trautmann). Trautmann is a member of the Downingtown, Pennsylvania, police force and the Plaintiff in this action.

At issue currently are the subpoenas served by Defendants upon Downingtown Borough Police Chief Howard Holland,<sup>1</sup> the Downingtown Borough Police Department (Downingtown P.D.), and the Chester County District Attorney's Office (Chesco DA) (collectively, Downingtown P.D., Chief Holland, and Chesco DA are "the Objectors"). All three subpoenas sought, inter alia, the video/audio footage taken at the scene of the December 25, 2018 barricade situation to which RRT responded. According to testimony by Detective Ciliberto with the Chesco DA, that footage captured the standoff, shots being fired at the police, the suspect's surrender, and the RRT walk-through of the crime scene afterwards. The Downingtown Borough Police Department, Chief Holland, and the Chester County District Attorney's Office moved to quash the subpoenas. The basis for the motions to quash centers on the Pennsylvania Criminal History Records Information Act (CHRIA), 18 Pa.C.S. § 9101, et. seq.

The materials requested include and focus on bodycam footage.<sup>2</sup> As a preliminary issue, Defendants acknowledged that they are in possession of approximately one hour and thirty-eight minutes of footage and Defendants are not requesting the production of duplicative video footage. Further, Defendants advised that they will send the footage they possess, or identifying markers (time stamps and the like), so that all parties are aware of the universe of footage being sought.

#### **CHRIA Background**

CHRIA applies to criminal justice agencies, which includes, among others, courts, state and municipal police departments, and district or prosecuting attorneys. 18 Pa.C.S. § 9102 (definition of criminal justice agency). Presently, as the parties agree, the Downingtown Police Department and Chester County District Attorney's

office meet the explicit definition of a criminal justice agency for CHRIA.

Section 9106 provides, inter alia, that investigative information shall not be collected in a central repository and that it shall not be disseminated to noncriminal justice agencies - and even then only with certain conditions being met. 18 Pa.C.S. § 9106 (a), (c)(4).<sup>3</sup> Violations of CHRIA are subject to administrative penalties and civil penalties pursuant to 18 Pa.C.S. §§ 9181 and 9183.

Accordingly, one of the primary issues in this matter is the definition of "investigative information" that CHRIA defines as, "Information assembled as a result of the performance of any inquiry, formal or informal, into a criminal incident or an allegation of criminal wrongdoing and may include modus operandi information." 18 Pa.C.S. § 9102. This issue shall be discussed further below.

#### **Confidential Information, Privileged Information, or Both?**

Before addressing the issue of whether or not the video footage in question is investigative information, a question that remains unanswered in Pennsylvania is whether or not the prohibition on the release of investigative information pursuant to CHRIA is a matter of a confidentiality or a privilege. If it is a privilege, the question remains as to by whom it is held and whether it can be waived.

Defendants argue primarily that CHRIA does not establish an evidential privilege as it relates to discovery. Defendants state that Pa.R.C.P. No. 4003.1(a) provides that "a party may obtain discovery regarding any matter, not privileged, which is relevant to the subject matter involved in the pending action." Defendants note that there is no Pennsylvania precedent whether CHRIA can be used to block civil discovery but argue that CHRIA does not establish privilege and thus any information must be disclosed in discovery. Moreover, Defendants cite to federal precedent that no privilege is created. Objectors agree that it is unclear whether CHRIA creates a privilege or confidential information or who would hold that privilege but suggest that CHRIA protects a suspect or defendant from the dissemination of scandalous information as well as the criminal justice agency from disclosing its methods, strategies, or the like.

Of relevance to Objectors, CHRIA contains penalties for improper disclosure and, as such, is meant as an express bar on dissemination. Those penalties include being denied access to some criminal history record information for a period of time at the discretion of the Attorney General, civil penalties, or discipline for any employee including termination, suspension, reduction in grade, transfer, or the like. 18 Pa.C.S. § 9181. Any individual or agency who improperly releases information may be subject to a civil action including actual damages of not less

than \$100 for each violation, costs and attorney's fees, and exemplary/punitive damages of \$1,000 to \$10,000 per willful violation. 18 Pa.C.S. § 9183. No carveout for civil discovery production exists to relieve a possessor of such information of fear of penalty in the event he/she/it produces CHRIA-protected information.<sup>4</sup>

No directly on-point precedential case law exists; however, the issue of privilege and confidentiality has been discussed. In Curtis v. McHenry, 172 F.R.D. 162, 163 (W.D. Pa. 1997), the Western District of Pennsylvania noted that CHRIA "prohibits the 'dissemination' of documents containing 'investigative information' to anyone who is not a 'criminal justice agency.'" (citing 18 Pa.C.S. § 9106(c)(4)). The court noted that defendants in that matter were claiming a privilege (including against civil discovery), and the court assumed that the privilege existed for its analysis, but the court doubted both the privilege and the federal court's obligation to recognize it. Id. Ultimately, the Curtis court opined that a federal court is not required to recognize a state privilege unless so many states have created it that it can be called a principle of common law. Id. at 164 (citing Jaffe v. Redmond, 518 U.S. 1 (1996) (finding a federal psychotherapist privilege should extend to licensed social worker in part because the psychotherapist privilege has been codified by all fifty states). As of 1997, no such widespread privilege in investigative information existed and thus the court declined to shield police reports as privileged when a federal question is involved. Id. at 164-65. See also Zielinski v. Mega Mfg., 2019 WL 6353203 (E.D.Pa. 2019) (holding that CHRIA does not create a privilege, but instead a duty of confidentiality, while ultimately limiting the use and dissemination of any documents falling within CHRIA's categories).

In contrast, two Eastern District cases came to the opposite conclusion: <u>Brooks–Bey v. Reid</u>, 1992 WL 22234 (E.D.Pa. 1992) and <u>McCrery v. Mark</u>, 1992 WL 208980 (E.D.Pa. 1992). In <u>Brooks-Bey</u>, the court held that a prior version of CHRIA rendered certain treatment information privileged. <u>Brooks-Bey</u>, 1992 WL 22234 at \*2. "The Transfer Memorandum . . . is **privileged** pursuant to the Pennsylvania Criminal Record Information Act, 18 Pa.C.S. § 9101 et seq., and **is not discoverable**." <u>Id</u>. at \*3 (emphasis added).

In <u>McCrery</u>, the court noted that the privilege that exists is statutory in nature and codified by law accordingly no weighing of the importance of documents is necessary for the privilege to exist and the plaintiff (a prison inmate) could not discover treatment information in a civil Section 1983 action. The court further stated that there is no provision for a defendant to waive the privilege. <u>McCrery</u> <u>v. Mark</u>, 1992 WL 208980 at \*1 ("[T]he privilege protecting criminal history information is codified by law. . . . Nor does the statute provide for defendant's waiver of the privilege.").

Moreover, Defendants argue an inequity in allowing one party to select supposedly confidential or privileged information to use in civil proceedings while barring an opposing party from discovery, examination, or use of the source of that information. Those questions are not before this court at this time and this court offers no opinion presently on the ability of Trautmann to use information barred from dissemination by CHRIA or the remedy if any such information has already been used.

The Third Circuit has weighed-in to state that "[t]he appropriateness of deference to a state's law of privilege is diminished, however, in cases in which a defendant state actor alleged to have violated citizens' federal rights is asserting the privilege." <u>Pearson v. Miller</u>, 211 F.3d 57, 68 (3rd Cir. 2000). In addition, the <u>Pearson</u> court noted that the statute at issue (the Mental Health Procedures Act, 50 P.S. § 7111(a)) provides for a duty of confidentiality but lacks an express provision of an evidentiary privilege. Similarly, by its express terms, CHRIA does not provide a privilege but a duty of confidentiality. However, the <u>Pearson</u> Court noted that such a duty of confidentiality has been interpreted as creating an evidentiary privilege:

It does not follow, however, that a statute providing for a duty of confidentiality-but lacking an express provision for an evidentiary privilege, per se-could not also be interpreted as creating such a privilege. Indeed, Pennsylvania courts have described each of the statutes here at issue as creating an evidentiary privilege of one kind or another. See Commonwealth v. Moyer, 407 Pa.Super. 336, 595 A.2d 1177, 1180 (1991) ("[T]he first sentence of [section 7111 of the MHPA] confers a statutory privilege of confidentiality on the patient's records.");12 V.B.T. v. Family Servs., 705 A.2d 1325, 1334 (Pa.Super. 1998) (noting that the CPSL creates a privilege, albeit one that is "not absolute and disclosure of otherwise confidential information is therefore permitted where compelled by sufficiently weighty interests") (citing Commonwealth v. Ritchie, 509 Pa. 357, 502 A.2d 148 (1985), rev'd on other grounds, 480 U.S. 39, 107 S.Ct. 989, 94 L.Ed.2d 40 (1987)); id. at 1331 ("[T]he privilege created by the Juvenile Act is qualified, i.e., creates, by its own terms, exceptions to the confidentiality of juvenile court records.").

<u>Id</u>. Ultimately, the <u>Pearson</u> court found that the MHPA created an absolute confidentiality privilege that was held by the patient and waivable and that third party rights pursuant to the Child Protective Services Law, 23 Pa.C.S. § 6340, and Juvenile Act, 42 Pa.C.S. § 6307(2), may be addressed by protective orders while weighing concerns of all involved. <u>Id</u>. at 70-71.

Turning to Pennsylvania state court cases, the federal lack of recognition of a privilege regarding investigative information has been rejected by our sister court of Common Pleas in Allegheny County. In <u>In re Pittsburgh Citizen Police</u> <u>Review Bd.</u>, 16 Pa.D.&.C. 5th 435, 448 (2010), the court stated that "the General Assembly has established a statewide statutory scheme governing the collection and dissemination of information of criminal justice agencies. . . . the city may not alter the statewide statutory scheme through an ordinance, which provides for law enforcement agencies to disseminate information that cannot be disseminated under state law[.]" Ultimately, the <u>In re Pittsburgh Citizens Police Review Bd.</u> court held

that investigative materials could not be turned over to a citizen police review board despite a confidentiality agreement as such dissemination was absolutely barred by CHRIA given that the review board was not a criminal justice agency.

The Superior Court has addressed the issue in In re Subpoenas in Case of Mielcarz v. Pietzsch, 2018 WL 3113916 (2018) (unpublished opinion). In Mielcarz, two civil defendants (Toyota and an individual, Pietzsch) subpoenaed the Bucks County District Attorney's Office for records related to a DUI-related car crash resulting in various guilty pleas by Pietzsch. Id. at \*1. The Superior Court analyzed the plain language of CHRIA and prior case law (including Pennsylvania State Police v. Grove, 161 A.3d 877 (Pa. 2017)) and concluded that CHRIA did supply an absolute bar over investigative information. It further compared CHRIA to the Right to Know Law, 65 P.S. §§ 67.101-67.3104, which prohibits public access to records of an agency relating to a noncriminal investigation as well as records of an agency relating to or resulting in a criminal investigation. Id. at \*5 (citing 65 P.S. §§ 97.708(b)(16),(17)). CHRIA only restricts access to information pertaining to criminal investigations and noncriminal investigative information may be disseminated. Id. "CHRIA protects information based on the circumstances under which it was gathered. Information obtained as a result of an investigation into criminal activity is protected. Information gathered as a result of a different inquiry or for a different reason is not protected." Id. at \*6.

The Superior Court in <u>Mielcarz</u> turned to the specific facts and found that some of the information (e.g., blood alcohol tests) was investigative but that it was unclear if other information, such as measurements and photographs, was obtained as part of an investigation into criminal activity. If taken during the course of a criminal investigation then CHRIA would bar disclosure but if taken during a routine non-criminal investigation, then CHRIA is inapplicable. <u>Id</u>. at \*6. As such, the Superior Court barred the disclosure of the blood alcohol test and remanded to determine if the remaining information was investigative or not. <u>Id</u>. at \*7. It should be noted that <u>Mielcarz</u> is not fully informative to the issue at hand because the Superior Court chose to "explicitly decline to opine on whether CHRIA's nondisclosure requirement is a privilege or whether it merely ensures confidentiality of information." <u>Id</u>. at \*3, fn 9.

Although not directly on point, an analogous situation is when information is requested from government agencies in the course of a civil trial pursuant to the then-current Right to Know Law, 65 P.S. § 66.1, et. seq.<sup>5</sup> In <u>Commonwealth v.</u> <u>Kauffman</u>, 605 A.2d 1243, 1246 (Pa. Super. 1992), the Superior Court opined that RTKL does not bar a party in a civil action from discovering relevant information from a government agency. "To hold otherwise, would insulate from discovery all information possessed by governmental agencies, no matter how relevant the

information might be, unless the same information were also available upon request to any and all citizens of the Commonwealth." The <u>Kauffman</u> Court opined that, "[s] uch a result clearly was not contemplated by the legislature when it enacted the Right to Know Law. Indeed, such a result would not only emasculate the discovery provisions of the rules of civil procedure, but would also represent an unsound departure from established law." <u>Id</u>. The <u>Kauffman</u> Court did recognize that an executive or governmental privilege may exist regarding the information but the Kauffman Court did not address the issue as it found that argument waived. <u>Id</u>. at 534-37. Importantly, the <u>Kauffman</u> Court did not address CHRIA or its rationale. <u>See also Starr</u> <u>v. State Bd. of Medicine</u>, 720 A.2d 183, 192 (Pa. Cmwlth. 1998) (holding that the Pennsylvania Department of Insurance investigative file was an exclusion to the definition of public records as it would "disclose the institution, progress or result of an investigation undertaken by an agency in the performance of its official duties" and denying a doctor the right to the records) (quoting <u>Pastore v. Insurance Department</u>, 558 A.2d 909, 913-14 (Pa. Cmwlth. 1989)).

Further muddying the waters, the Superior Court in <u>Martin v. Villa</u>, 2017 WL 3484141 (Pa. Super. 2017) (unpublished opinion) reviewed a request in a civil case pursuant to Pa.R.C.P. No. 4003.1 for matters that are potentially criminal investigative matters and opined that CHRIA is an evidential privilege. "[T]here is no indication that the trial court reviewed any materials to render a determination as to whether **CHRIA or a separate evidentiary privilege** would apply. . . . whether the matters contained in the files are **protected from disclosure under CHRIA or another evidentiary privilege.**" <u>Id</u>. at \*7 (footnote deleted) (emphasis added). "In sum, we conclude that the trial court abused its discretion when failing to consider **CHRIA and the other privileges** raised by the parties." <u>Id</u>. at \*12 (emphasis added).

The Superior Court in another unpublished opinion, TomBev Restaurant Services, LLC v. Certain Underwriters at Lloyd's of London, 2017 WL 384128 (Pa. Super. 2017), addressed a request in a civil matter for portions of a Pennsylvania State Trooper report regarding a fire being criminally investigated. After finding the records in question were squarely within the definition of those prohibited from disclosure by CHRIA, the Superior Court turned to "whether CHRIA creates evidentiary privilege during a discovery proceeding in which PSP is not a party." Id. at \*5. The TomBev Court further noted that "[a]lthough CHRIA contains . . . penalties for disclosures against its provisions, its status as an absolute privilege under the circumstances of the instant case is not entirely clear." Id. at \*6. Ultimately, in an abundance of caution, the Court analyzed a common law executive or governmental privilege pursuant to Ben v. Schwartz, 729 A.2d 547 (Pa. 1999) (finding RTKL is not applicable to discovery proceedings pursuant to the Pa. Rules of Civil Procedure). Id. Looking at a ten-factor test laid out by Frankenhauser v. Rizzo, 59 F.R.D. 339 (E.D. Pa. 1973), the TomBev Court ultimately held that the report of the troopers was an evaluative summary in an ongoing criminal investigation and that the documents should not be disclosed. Id. at \*7-8.

## CHESTER COUNTY REPORTS [70 Ches. Co. Rep. Trautman vs. CBS Broadcasting Inc, et al

Suggestively, although there are no carveouts for civil discovery, there are explicit carveouts from CHRIA. These include, for example, court dockets, police blotter information, and announcements of executive clemency. 18 Pa.C.S. § 9104. Notably, no carveout exists for materials already produced from other sources, materials used at trial, bodycam footage, etc. The mere fact that information is possessed or even created by a third party is not sufficient to remove the prohibition on disclosure of investigative information. See Commonwealth v. State Police, 146 A.3d 814, 817-18 (Pa. Cmwlth. 2016) (holding that the Pennsylvania state police are "statutorily prohibited" from turning over to the Office of Open Records, a non-criminal justice agency, surveillance video received from a third-party casino (Mt. Airy) when gathered as part of its criminal trespass investigation). See also Pennsylvania State Police v. Kim, 150 A.3d 155 (Pa. Cmwlth. 2016) (holding that video gathered by the state police from a different incident at Mt. Airy Casino was investigative information that the police were prohibited from disclosing).

Presumably, there is no restriction on a non-criminal justice agency possessing video recordings, e.g., the casino in <u>Commonwealth v. State Police</u>, from turning over their own video footage to whomever it pleases. CHRIA's restrictions apply only to criminal justice agencies. Moreover, no express language exists allowing for the waiver of the confidentiality by any party – police, criminal suspect in an investigation, ultimate defendant in an investigation, individual officer, etc.

From this court's review of all applicable case law and potentially persuasive non-binding case law, given the lack of carveout for previously produced materials as well as the lack of any express authority for any party to waive the privilege or confidentiality, the provisions of CHRIA create a duty of confidentiality on the police that is only eliminated with its specific carveouts or, in criminal prosecutions, the due process concerns of a criminal defendant. Moreover, this Court adopts the rationale of the <u>Pearson</u> court to state that it creates an evidential privilege for purposes of Pa.R.C.P. No. 4003.1 although no party expressly holds the privilege for purposes of a common law governmental privilege, the interest of the police in preserving their methods in response to an ongoing barricade situation, evidence collection methods, and the like, weight in favor of finding a privilege in the present matter.

## Public Notice Appointment of New Magistrate Judge in the United States District Court for the Eastern District of Pennsylvania

The Judicial Conference of the United States has authorized the appointment of a full-time United States magistrate judge for the Eastern District of Pennsylvania at Reading or Philadelphia. The appointee may be required to preside at court sessions to be held at Reading, Philadelphia, Allentown, and Easton. The essential function of courts is to dispense justice. An important component of this function is the creation and maintenance of diversity in the court system. A community's belief that a court dispenses justice is heightened when the court reflects the community's diversity.

The duties of the position are demanding and wide-ranging, and will include, among others: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from a district judge; and (4) trial and disposition of civil cases upon consent of the litigants. The basic authority of a United States magistrate judge is specified in 28 U.S.C. § 636.

To be qualified for appointment an applicant must:

- Be, and have been for at least five years, a member in good standing of the bar of the highest court of a state, the District of Columbia, the Commonwealth of Puerto Rico, the Territory of Guam, the Commonwealth of the Northern Mariana Islands, or the Virgin Islands of the United States, and have been engaged in the active practice of law for a period of at least five years;
- Be competent to perform all the duties of the office; be of good moral character; be emotionally stable and mature; be committed to equal justice under the law; be in good health; be patient and courteous; and be capable of deliberation and decisiveness;
- 3. Be less than seventy years old; and
- 4. Not be related to a judge of the district court.

A merit selection panel composed of attorneys and other members of the community will review all applicants and recommend to the district judges in confidence the five persons it considers best qualified. The court will make the appointment following an FBI full-field investigation and an IRS tax check of the applicant selected by the court for appointment. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 90 Stat. 1824 (1978) (codified at 5 U.S.C. app. 4 §§ 101-111) as implemented by the Judicial Conference of the United States. An affirmative effort will be made to give due consideration to all qualified applicants without regard to race, color, age (40 and over), gender, religion, national origin, or disability. The current annual salary of the position is \$205,528.00. The term of office is eight (8) years.
