#### Mercedes-Benz Financial Services v. Pommerer's Collision Center

Declaratory Judgment – Storage fees – Garageman's lien – Conversion – Replevin – Unjust enrichment

- 1. A garageman's lien is a common law possessory lien.
- 2. Once a vehicle owner offered to and was willing to pay a reasonable storage fee and a fee for towing, a garageman's lien cannot be asserted by the defendant.
- 3. No garageman's lien may be asserted in the absence of express or implied authorization for the service or repair.
- A common law possessory lien may be asserted for storage of as well as repairs to a vehicle.
- 5. A possessory lien on goods has priority over a security interest in the goods unless the lien is created by a statute which expressly provides otherwise.
- 6. Conversion is the deprivation of another's right of property in, or use or possession of, a chattel, or other interference therewith, without the owner's consent and without lawful justification.
- 7. Where a defendant to a replevin action asserts a possessory lien as a defense, a court must determine the validity of the lien. If the lien is valid, the court can nonetheless enter a verdict for the plaintiff by determining the amount of the lien and then ordering the defendant to surrender possession upon payment of that amount.
- 8. In order to sustain a claim of unjust enrichment, a plaintiff is required to prove that it conferred benefits on the defendant, the defendant has an appreciation of such benefit, and the defendant will accept and retain that benefit under such circumstances that it would be inequitable for defendant to retain the benefit without payment of value.
- 9. After a non-jury trial, the Court entered an order in favor of defendant and against the plaintiff on the various counts of the plaintiff's complaint and the defendant's counterclaim.

#### MEMORANDUM AND ORDER

A non-jury trial was held in this matter on January 9, 2025. The parties submitted post-trial memoranda of law and the matter is now ripe for decision.

#### **DISCUSSION**

In March or April of 2023, Victor M. Ford left his 2018 Mercedes-Benz GLE 350, VIN 4JGDA5HB9JB041150 (Vehicle), with Defendant, Pommerer's Collision Center (PCC), to repair damage to the front driver's side of the Vehicle. (Exh. D-1, D-4). PCC's owner, Fred Pommerer, testified that the vehicle was repaired. (Exh. D-3, D-5). Mr. Pommerer testified that the work performed was invoiced in the amount of \$8,916.93, but Mr. Ford never responded to his calls that work on the Vehicle had been completed. Some months later, Mr. Pommerer discovered that Plaintiff, Mercedes-Benz Financial Services (Mercedes), had an ownership interest in the Vehicle. (Exh. P-1). The court found Mr. Pommerer's testimony to be credible and persuasive.

The parties stipulated that Mr. Pommerer made a telephone call to Mercedes on October 4, 2023, informed it that he was in possession of the Vehicle and that fees were due and owing for the repair and storage of the Vehicle. (Exh. P-4). Mercedes's representative on the October 4, 2023, call represented that Mercedes would "would pay for repairs or storage, but not both & we would need more docs to confirm repairs." (Exh. P-4). Mercedes's representative made a similar representation to Mr. Pommerer on October 5, 2023. (Exh. P-4).

There is no credible evidence that Mercedes demanded the return of the Vehicle until it filed a Complaint on January 8, 2024. In the Complaint, Mercedes seeks relief in the form of a declaratory judgment, damages for conversion, and replevin. PCC filed its Answer and included a counterclaim for unjust enrichment. Mercedes filed an Answer to the counterclaim.

#### Declaratory judgement.

In its Complaint, Mercedes averred, in part, that "[w]ithout a declaration as to the amount owed (if any), the parties will not resolve their differences." Complaint ¶ 24. Mercedes argues that PCC has no cognizable possessory lien on the Vehicle because it did not consent to the work on nor the storage of the Vehicle. Mercedes cites State Farm Mut. Auto. Ins. Co. v. Jim Bowe & Sons, Inc., 539 A.2d 391 (Pa.Super. 1988), in support of its position that it has no liability for storage fees and, therefore, PCC may not assert a garageman's lien on the vehicle. In that case, a vehicle had been stolen, recovered, and stored on the defendant's lot. The defendant in that case claimed he was owed storage fees and had a garageman's lien on the vehicle in question. However, the holding in State Farm is inapposite to Mercedes's position.

The Court in State Farm was unequivocal in stating that "we hold that State Farm is liable to Bowe for a storage fee from the date when State Farm was notified that Bowe was storing the vehicle." Id. at 394. It also made clear that the defendant "had a legitimate garageman's lien against State Farm's vehicle only after State Farm learned that the vehicle was being stored." Id. The Court went on to find that once the vehicle owner offered to and was willing to pay a reasonable storage fee and a fee for towing, a garageman's lien could not be asserted by the defendant.

In the present matter, and similar to the facts in State Farm, Mercedes was notified on October 4, 2023, that PCC was in possession of the Vehicle and that it wanted to be paid for storage fees and repairs. (Exh. P-4). Thereafter, on January 8, 2024, Mercedes filed its Complaint. Unlike the *State Farm* case, Mercedes did offer to pay a reasonable storage fee, but instead offered a choice of payment of the storage fee or repairs, but not both. (Exh. P-4). Under the facts of this case, the court finds that Mercedes was liable for storage fees at \$75.00 per day from the October 4, 2023, when it was notified by PCC that it was in possession of the Vehicle and wanted to be paid for storage, and January 8, 2024, when Mercedes filed its Complaint (96 days) for a total of \$7,200.00. Id. In addition, because Mercedes equivocated on paying storage fees by offering to pay one or the other, but not both, the court finds that PCC has a valid possessory garageman's lien on the Vehicle. Id.; see Trustees of Reading Company v. Smith, 24 Ches. Co. Rep. 216 (J. Sugarman, April 5, 1976) (finding a garageman's lien appropriate where owner was advised of possession of the vehicle, storage fees, and provided a bill for service).1

A garageman's lien is a common law possessory lien. See Saxton v. Gemehl, 72 PA Super. 177 (1919) (finding that a common law possessory lien may be asserted for storage of as well as repairs to a vehicle); 13 Pa.C.S. § 9333(a) (defining possessory lien). Having determined that PCC has a valid possessory garageman's lien, the court must next determine whether that lien has priority over a perfected security interest. "A possessory lien on goods has priority over a security interest in the goods unless the

lien is created by a statute which expressly provides otherwise." 13 Pa.C.S. § 9333(b). PCC's common law possessory garageman's lien, has priority over Mercedes's secured interest in the Vehicle. *Id.* 

#### B. Conversion.

Mercedes claims that PCC is liable for damages resulting from PCC's conversion of the Vehicle. "Conversion is the deprivation of another's right of property in, or use or possession of, a chattel, or other interference therewith, without the owner's consent and without lawful justification." *Acme Markets, Inc. v. Seltzer*, 244 A.3d 469, 474 (Pa. Super. 2020) (internal quotes omitted) (so stating in addressing, *inter alia*, the alleged conversion of a lottery ticket). In the present matter, PCC possessed the Vehicle first with Mr. Ford's consent prior to Mercedes being notified of the location of the Vehicle. Thereafter, PCC maintained a valid possessory garageman's lien on the Vehicle as to Mercedes.

Because PCC possessed the car first with the owner's consent and then with lawful justification in the form of a possessory garageman's lien, Mercedes's claim for damages based on conversion must fail.

#### C. Replevin.

Mercedes also seeks relief in the form of an order directing PCC to surrender possession of the Vehicle. This court has determined that PCC has asserted a possessory garageman's lien on the Vehicle and that the lien is valid. Where, as here, "a defendant to a replevin action asserts a possessory lien as a defense, a court must determine the validity of the lien. If the lien is valid, the court can nonetheless enter a verdict for the plaintiff by determining the amount of the lien and then ordering the defendant to surrender possession upon payment of that amount." *See R & R Cap.*, *LLC v. Merritt*, 632 F. Supp. 2d 462, 485 (E.D. Pa. 2009).

Because PCC maintains a valid possessory garageman's lien on the Vehicle, Mercedes may take possession of the Vehicle upon payment of the \$7,200.00 storage fee due and owing to PCC.<sup>2</sup>

#### D. Counterclaim for unjust enrichment.

PCC has asserted a counterclaim for unjust enrichment to recover the charges for repairing the Vehicle, including tax. (Exh. D-1, D-2). The court found Mr. Pommerer's testimony regarding the work performed and charges for repairing the Vehicle to be credible and persuasive. Mercedes offered no credible evidence that the repairs were unnecessary, deficient, or defective. Mercedes provided no credible evidence that the amount charged for the repairs was excessive or otherwise not in conformity with

charges for the same work performed by other collision repair businesses.

Mercedes attempted to develop a record and argue that PCC could not recover on its counterclaim because it failed to comply with the contractual requirements set forth in the Pennsylvania's Unfair Trade Practices and Consumer Protection Law (UTPCPL). See Act of December 17, 1968, P.L. 1224, No. 387, as amended, 73 P.S. § 201-1 et seq. Mercedes did not set forth any reference to UTPCPL in its Complaint or Answer to Counterclaim. Mercedes "acknowledges that it has not (and may not be able to) assert a claim for damages under the UTPCPA[sic]." Mercedes's Post-Trial Memorandum of Law, unnumbered page 9. Despite the foregoing and without benefit of legal citation, Mercedes argues that any contract between Mr. Ford and PCC would be unenforceable under the UTPCPL and therefore, it cannot be found liable for the charges. There is no evidence that Mr. Ford assigned his rights under the UTPCPL to Mercedes. Therefore its transmogrification argument is unsupported by the law and baseless. See Volkswagen Grp. of Am., Inc. v. Kimmel & Silverman, 74 A.3d 1042, 1046 (Pa.Super. 2013) (finding that law firm did not have standing to bring UTPCPL claim absent assignment of rights). The court finds that the charge of \$8,916.92, which included tax, is valid and appropriate.

In order to sustain a claim of unjust enrichment, PCC is required to prove that it conferred benefits on Mercedes, Mercedes has an appreciation of such benefit, and Mercedes will accept and retain that benefit "under such circumstances that it would be inequitable for defendant to retain the benefit without payment of value." *Spolar v. Spolar Fam. Tr.*, 326 A.3d 995, 1003 (Pa.Super. 2024) (affirming trial court's award based on claim of unjust enrichment). In the present matter, Mercedes seeks possession of the repaired vehicle. PCC will confer the benefits of the repaired vehicle when it surrenders the vehicle to Mercedes. Mercedes has an appreciation of the benefit conferred as it has been provided with documentation of damage to the Vehicle and the repair of such damage. Upon taking possession of the Vehicle, Mercedes will be accepting and retaining the benefit and value of the repairs.

Under these circumstances, it would be inequitable for Mercedes to take possession of the Vehicle and retain the benefit of the repairs without payment of value in the amount of \$8,916.92. *Id*.

After consideration of the foregoing, and for all of the reasons stated, we enter this

#### **ORDER**

AND NOW, this 30th day of January, 2025, following a non-jury trial, it is ORDERED and DECREED that as to Count I – Declaratory Relief, Pommerer's Collision Center has a valid possessory garageman's lien in the amount of \$7,200.00, against the 2018 Mercedes-Benz GLE 350, VIN 4JGDA5HB9JB041150.

It is FURTHER ORDERED, that Pommerer's Collision Center shall surrender the 2018 Mercedes-Benz GLE 350, VIN 4JGDA5HB9JB041150, to Mercedes-Benz Financial Services upon its payment of \$7,200.00, to Pommerer's Collision Center.

It is FURTHER ORDERED, that as to Count II - Conversion, a decision is entered in favor of Pommerer's Collision Center and against Mercedes-Benz Financial

Services, in no amount.

It is FURTHER ORDERED and DECREED, that as to Count III – Replevin, a decision is entered in favor of Pommerer's Collision Center and against Mercedes-Benz Financial Services.

It is FURTHER ORDERED, that as to Pommerer's Collision Center's counterclaim, a decision is entered in favor of Pommerer's Collision Center and against Mercedes-Benz Financial Services, in the amount of \$8,916.92.
