If you cannot afford to hire a lawyer, pursuant to the Adoption Act, 23 PA. C.S Sec. 2313(a.l), the court shall appoint counsel for a parent whose rights are subject to termination in an involuntary termination preceeding if, upon petition of the parent, the court determines that the parent is unable to pay for counsel or if payment would result in substantial financial hardship.
