

### Obiter Dictum

From the ABA Journal Daily Newsletter: [1] Mississippi's lifetime bans on voting by felons convicted of certain crimes serve no legitimate penological purpose and violates their rights under the 8th Amendment. In a 2-1 decision, the U.S. Court of Appeals for the 5th Circuit struck down a provision of the Mississippi Constitution known as Section 241. The provision, with current amendments, mandates lifetime disenfranchisement for people convicted of "murder, rape, bribery, theft, arson, obtaining money or goods under false pretense, perjury, forgery, embezzlement or bigamy." The appeals court said Mississippi shall be barred from enforcing Section 241 against six plaintiffs who had completed their sentence in a class of similarly situated people. According to the 5th Circuit, the Mississippi Constitution as enacted in 1890, had a goal "to ensure the political supremacy of the white race," and Section 241 targeted crimes thought to be more often committed by black men. [2] More than 1,700 California lawyers have failed to comply with new trust account rules, leading to their administrative suspensions. The State Bar of California adopted the Client Trust Account Protection Program after an attorney was accused of stealing more than 18 million dollars from clients and the Bar had opened over 205 disciplinary matters spanning over four decades against the attorney, with only three leading to disbarment. The new program requires lawyers to report whether they are responsible for client trust accounts, to provide basic account information, to complete manual self-assessment and to certify that they comply with ethics rules relating to safeguarding client funds. The deadline for compliance was April 3rd. Those that didn't comply were fined \$75.00 and informed that they had until June 30th to come into compliance. The administrative suspension began in July. The new rules are intended to help the State Bar prevent attorneys' theft. Other News: The Superior Court of Pennsylvania recently affirmed the judgment of sentence for numerous counts of arson endangering persons, concluding, in part, that the prosecution for the offense is not merely starting a fire but intentionally starting a fire that recklessly places another person in danger of death or serious bodily injury; that the statute was written with regard to an individual person being placed in danger of death or serious bodily injury and that a defendant may be convicted of and sentenced on separate counts when there is one arson but more than one victim.

### NOTICE TO THE PROFESSION

### Washington County Correctional Facility Attorney-Client Privileged Mail Policy Change

Due to the ongoing safety and security concerns associated with sender verification and processing the privileged mail for our incarcerated population, this institution is implementing a new system to keep our staff and the incarcerated person population safe. This new system is called TextBehind DOCS. It is designed to achieve the following objectives:

- 1) Mitigate potential exposure to life-threatening contraband smuggled through bogus legal mail
- 2) Provide a reliable sender identity verification process
- 3) Allow the attorney to request a Video Evidence Recording of the mailprocessing activity
- 4) Enhance the transparency and credibility of mail handling process for all corresponding parties
- 5) Allow a dynamic file access management system to the attorney to prevent unauthorized access to the data

All privileged mail content will remain encrypted in the system at all times. The system will require the attorney's permission whenever the data is to be accessed and processed for the incarcerated person(s).

Starting October 1, 2023, any privileged mail sent directly to this institution through the postal service will be returned to sender unless it meets the following criteria:

- 1) The privileged mail envelope must display a valid MOVE (Mail Origin Verification) QR Code that you can download at no cost from the TextBehind DOCS web portal by taking the following steps:
  - a. Please go to the https://docs.textbehind.com website to register for an account
  - b. Add your desired incarcerated person contact(s)
  - c. Provide the identification documents (if required)
  - d. Download your MOVE QR Code to print on the OUTSIDE OF THE EN-VELOPE. Please note that this QR Code may be dynamically generated based on various rules set up by the institution. These rules may be revised from time to time.

Therefore, please follow the current rules specified on the TextBehind DOCS portal to avoid mail rejection.

2) You are also encouraged to utilize the same TextBehind DOCS web portal to send the privileged mail online. There may be a nominal fee for the electronic option. Privileged mail sent electronically will be delivered to the inmate through tablets/kiosks. It may also be possible to print the same documents onsite in the presence of an incarcerated person(s). If you would like us to record a video of this process, please include the Video Evidence Recording request at the time of submitting the privileged mail order online.

### **OPINION**

IN THE COURT OF COMMON PLEAS OF WASHINGTON COUNTY, PENNSYLVANIA ORPHANS COURT DIVISION No. 63-23-0517

IN RE: Adoption of M.J.L., Adoptee

**SYNOPSIS** 

In the context of private termination proceeding, where evidence clearly and convincingly demonstrated that natural mother failed to perform parental duties for two years, court, sua sponte, directed that the record be reopened. J. Lucas, ruled that because the record was not fully developed regarding the subject child's individual developmental, physical and emotional needs, the record would be reopened with a direction to the parties to present additional evidence.

In proceeding to involuntarily terminate parental rights, the party seeking termination, must prove their burden by "clear and convincing" evidence the grounds for doing so.

A court may terminate parental rights under Section 2511(a)(1) where a parent fails to perform parental duties for at least the six months prior to the filing of the termination petition.

A court, in a termination of parental rights case, is barred from considering any efforts by parents to remedy the conditions that led to the removal or filing of a termination petition, if those efforts occurred after the parent received notice that a termination petition has been filed.

The focus under Subsection 2511(a)(1) is not the degree of success a parent may have had in reaching the child, but examines whether, under the circumstances, the parent has utilized all available resources to preserve the parent-child relationship.

The law regarding termination of parental rights should not be applied mechanically but instead always with an eye to the best interests and the needs and welfare of the particular children involved.

Once evidence establishes failure to perform parental duties or settled purpose of relinquishing parental rights, a trial court must engage in three lines of inquiry when determining whether to terminate parental rights: (1) parent's explanation for his conduct; (2) post-abandonment contact between parent and child; and (3) consideration of effect of termination of parental rights on child. 23 Pa.C.S.A. § 2511(b).

While trial courts must appoint legal counsel to represent the preferred outcome of children in contested involuntary termination of parental rights matters, a child's preferred outcome is not controlling, especially where that child is under 12, and his or her consent is not necessary to effectuate an adoption.

A trial court must ensure that as full and complete record as possible is created when a decision on the welfare of child is at issue.

Trial courts have the inherent discretion to reopen the record on their own and to grant the parties leave to supplement it with evidence regarding a particular issue, as long as neither party is prejudiced.

### MEMORANDUM AND ORDER

In this case, a natural mother's parental rights to her five-year-old son (MJL) are at issue. Natural Father (WEL) and his wife (BML) seek to terminate the rights of natural mother (TPK). WEL and BML assert that grounds for termination exist under two sections of the Adoption Act, 23 Pa.C.S.A. § 2511(a)(1) and (2). Their petition and the hearing evidence, that the parties provided on June 12, 2023, are now considered.

[1] WEL and BML have the burden to establish their claims by "clear and convincing" evidence. Matter of Adoption of G.T.M., 506 Pa. 44, 483 A.2d 1355, 1356 (1984); In re T.R., 502 Pa. 165, 465 A.2d 642, 642-43 (1983) as cited in In re Adoption of C.M., 255 A.3d 343, 358 (Pa. 2021).

[2] [3] A court may terminate parental rights under Section 2511(a)(1) where a parent fails to perform parental duties for at least the six months prior to the filing of the termination petition. See 23 Pa.C.S.A. § 2511(a) (1) and In re Z.P., 994 A.2d 1108, 1117 (Pa. Super. 2010). For purposes of determining the Petition regarding subsection (a) (1), this trial court may not consider a parent's efforts initiated after TPK was given notice that a termination petition had been filed. See In re Z.P., 994 A.2d 1108, 1121 (Pa. Super. 2010).

Here, the competent evidence of record clearly and convincingly established that TPK has failed to perform parental duties in the six (6) month period prior to the filing of the Adoption Petition. WEL and BML filed their termination petition on March 24, 2023. TPK last tried to exercise custody rights, pursuant to a court order, as to MJL, in September of 2020. She last saw MJL on Thanksgiving in 2021, while her son was visiting the home of his maternal grandmother. She has provided no financial support for MJL. She does not call or text MJL. She does not regularly send him cards, gifts or presents on his birthday or holidays. She did not attend the parties' last custody proceeding in July of 2022.

[4] [5] [6] The Pennsylvania Supreme Court has emphasized the need for a parent to "exercise reasonable firmness" in resisting obstacles placed in the path of maintaining the parent-child relationship, or his "rights may be forfeited." In re Adoption of C.M., 255 A.3d 343, 364 (Pa. 2021). Communication, association and exerting oneself to maintain a place of importance in a child's life are necessary. Id. "The focus under Subsection 2511(a)(1) is not the degree of success a parent may have had in reaching the child, but examines whether, under the circumstances, the parent has utilized all available resources to preserve the parent-child relationship. Id.

Since the time when WEL filed the termination petition, TPK has attempted to exercise her custody rights to MJL. On May 10, 2023, she provided 72 hours' notice and requested a visit with MJL. Such post-petition efforts, however, may not be considered because WEL and BML's petition assert grounds pursuant to 23 Pa.C.S.A. 2511(a) (1). The Supreme Court has reiterated that "we may not ignore that the General Assem-

bly has drawn focus to the six months immediately preceding the filing of the termination petition. <u>In re Adoption of L.A.K.</u>, 265 A.3d 580, 592 (Pa. 2021).

Thus, TPK's failure to perform parental duties or have any significant contact with MJL for over two years may not be mitigated by her recent attempt to exercise a custodial visit with him. The competent evidence of record clearly establishes TPK's failure to perform parental duties pursuant to 23 Pa.C.S.A § 2511(a)(1).

[7] To terminate parental rights pursuant to 23 Pa.C.S.A. § (a)(2), the burden of proof is somewhat different. Section 2511(a)(2) provides for the termination of parental rights where the continued incapacity, abuse, neglect or refusal of a parent has caused a child to be without essential parental care, control or subsistence, and the cause of the incapacity, abuse, neglect or refusal cannot or will not be remedied by the parent. Id. In other words, for section (a)(2), WEL and BML must show, by clear and convincing evidence, that: (1) TPK demonstrated repeated and continued incapacity, abuse, neglect or refusal; (2) that such conduct by TPK caused MJL to be without essential parental care, control or subsistence; and (3) that causes of TPK's incapacity, abuse, neglect or refusal cannot or will not be remedied. In re Adoption of L.A.K., 265 A.3d at 600.

WEL and BML have not met their burden as to an (a)(2) termination. No party contests that TPK's drug addiction led to a prolonged period of her parental incapacity. However, as in <u>L.A.K</u>, the competent evidence of record does not indicate that MJL experienced a period of time where he was without essential parental care custody and control. To the contrary, the evidence supports the conclusion that TPK's mother, WEL and more recently BML have provided essential care, control and subsistence for MJL, and have done so in an optimal manner. The testimony of A.H., maternal grandmother, and the parties, along with the Home Study completed by investigator Rega well establishes the adequacy of the care that MJL has received. Further, TPK's recent efforts at gaining her sobriety, support the conclusion that her parental incapacity will be remedied. WEL and BML did not meet their burden as to an (a)(2) termination.

[8] Therefore, WEL and BML have proven grounds for termination under section (a)(1), alone. Indeed, TPK readily admitted that she has no evidence that she has attempted to perform any parental act in "the last couple of years." This honest concession by TPK, however, is not the end of the analysis that this court must perform. As Justice Baer explained "the law regarding termination of parental rights should not be applied mechanically but instead always with an eye to the best interests and the needs and welfare of the particular children involved."

<u>In re T.S.M.</u>, 620 Pa. 602, 631, 71 A.3d 251, 268–69 (2013).

[9] More specifically, where evidence establishes a failure to perform parental duties or a settled purpose of relinquishing parental rights, a trial court must engage in three lines of inquiry: (1) the parent's explanation for his or her conduct; (2) the postabandonment contact between parent and child; and (3) consideration of the effect of termination of parental rights on the child pursuant to Section 2511(b). See In re Z.S.W., 946 A.2d 726, 730 (Pa. Super. 2008) (citations omitted) as cited in Interest of C.G.C., 1 EDA 2023, 2023 WL 3862467, at \*3–4 (Pa. Super. Ct. June 7, 2023).

As to the first line of inquiry, TPK readily acknowledges that the later parts of her longstanding battle with addiction have coincided with her absence from MJL's life. She indicated that she has had a drug addiction since age 13, and that her substance abuse struggle escalated "in the last couple of years."

She reports that when MJL was an infant and she was living with WEL, she

was using drugs. TPK and WEL separated. Her drug usage continued while she worked and resided with MJL and her mother. Her circumstances got "worse and worse." She recognized that she should not expose MJL to anything "drug related."

In January 2020, MJL went to live with WEL. At that time, TPK voluntarily chose to see MJL, less and less. Since that time, she addressed her addiction by going to two (2) rehabilitation centers, Spirit Life and Clear Day Detox. She relapsed after attending these short-term programs. More recently, she attended Gateway. Through Gateway and an aggressive aftercare program she has maintained sobriety since August of 2022. She goes to 5 (five) NA meeting per week, resides in a ¾ house, attends therapy, and is subjected to regular drug screens.

During this period of rehabilitation, TPK did not directly maintain contact with MJL. She explained that she did not want to be coming in and out of his life. She recognized that she had to get herself "together to be a better mother for MJL."

Meanwhile, MJL began to forge a close relationship with BML, who became his primary caregiver. On a daily basis, BML gets MJL ready in the morning for school, sees him off to the school bus and is there to meet him when he returns. BML helps MJL with his homework, makes his favorite foods, takes him to the doctor, and knows firsthand his progress with his speech difficulties. The evidence does not present any serious dispute that BML has loved and cared for MJL as if he were her own son. This evidence supports the finding that a beneficial bond has developed between MJL and BML.

Nevertheless, despite her extended absence from MJL's life, TPK offered testimony indicating that her bond with MJL remains. She testified credibly that she and MJL forged a bond during his first years of life. At that time, she provided direct care for him, played with him and took him to safe places that included the mall. AH, maternal grandmother, credibly testified that during these early years, TPK provide direct parental care to MJL in AH's home. According to AH, when she went to work, TPK, alone, provided that care and she performed those duties adequately. AH stated that when MJL sees TPK's picture he asks about her.

Indeed, WEL confirmed that when MJL returns from visits with AH, MJL asks questions about TPK. In particular, WEL stated that MJL will sometimes ask "why she (TPK) is sick?" WEL, however, maintains that no bond exists between MJL and TPK.

Unfortunately, the opinions of parties who have been engaged in custody litigation, may well be, in part, a product of their own confirmation bias. In other words, the opinions regarding MJL's bond with TPK appear to be consistent with the view from the "side of the fence" each witness is firmly standing upon.

MJL's appointed legal counsel did provide testimony from Investigator Rega. However, that testimony focused on the physical safety of WEL and BML's home and their clean history regarding criminal offenses and child abuse. Though helpful on important issues, Investigator Rega's testimony did not address MJL's particular individual developmental, emotional and physical needs.

Under the specific circumstances of this case, the abbreviated amount of record evidence does not allow this court to decide the effect that terminating TPK's parental rights will have on MJL. In <u>LAK</u>, the Supreme Court reiterated that:

It cannot be denied that significant and permanent consequences for both parent and child can follow the termination of parental rights, as there is an undeniable importance in a child's relationship with a biological parent.

<u>LAK</u>, 265 A.3d at 591-592. Further, this is not a case where MJL has been removed from parental care and placed into the foster care system. The concerns over foster care drift, well-articulated in <u>TSM</u>, supra., are not present in this case. MJL's permanency has been assured by his father, WEL, his stepmother, BML and his maternal grandmother, AH.

[10] Instead, this is a circumstance where a five-year-old child, who is the subject of a custody order providing for primary physical custody in his natural father, faces the prospect of having his ties to his natural mother permanently changed. Admittedly, at the outset of the hearing, MJL's legal counsel informed this court that MJL wished "to remain where he is at and to have the adoption go forward." A child's preferred outcome is not controlling, especially where that child is under twelve, and his or her consent is not necessary to effectuate an adoption. Interest of D.R.-W., 227 A.3d 905, 916 (Pa. Super. 2020).

MJL's best interests require this court to insist upon more evidence regarding his developmental, physical and emotional needs and welfare. Indeed, if grounds for termination under subsection(a) are met, as they are here, "a court shall give primary consideration to the developmental, physical and emotional needs and welfare of the child." 23 Pa.C.S. § 2511(b) and In re Adoption of C.D.R., 111 A.3d 1212, 1219 (Pa. Super. 2015) as cited in Interest of C.G.C., supra at 9. In other words, the focus of the subsection(b) inquiry is not on TPK who has unquestionably fallen short, but on MJL, his individual needs and welfare. In re Adoption of C.L.G., 956 A.2d at 1008.

Here, unlike those cases where a children and youth agency has obtained custody of a child, no record of a series of permanency review hearings addressing MJL's particular needs and welfare is available. (Contrast with Interest of D.R.-W., 227 A.3d at 915 where the parental rights of a father were terminated and the orphans court relied upon a record that included an adjudication of dependency, an emergency removal from father's care and several subsequent permanency review hearings.)

[11] In this instance, not requiring that the parties provide more evidence would be a miscarriage of justice for MJL. A trial court must ensure that as full and complete a record as possible is created when a decision as important as the welfare of a child is at issue. Moore v. Moore, 535 Pa. 18, 26, 634 A.2d 163, 167 (1993).

[12] MJL's individual needs and welfare were not fully developed for this court to make an informed ruling on the subsection(b) issue. As a matter of general discretion afforded to a trial court under the rules of evidence and this court's dual role in a non-jury proceeding, this court possesses the inherent discretion to demand more. In other words, this court, sua sponte, may reopen the record and direct the parties to supplement the record with additional evidence. Com. v. Safka, 636 Pa. 169, 186–87, 141 A.3d 1239, 1249–50 (2016). Further, such reopening of the record, here, does not prejudice either party but instead permits each side an equal opportunity to make a complete record.

For these reasons, this court issues the following order.

### **ORDER**

AND NOW, this 18<sup>th</sup> day of July, 2023, having conducted a non-jury hearing on June 12, 2023, and having considered the briefs of the parties and legal counsel for the child, this court finds:

That grounds for the termination of Taylor Paige Kemp's parental rights as to Mason James Lancaster has been proven by clear and convincing evidence, pursuant to 23 Pa.C.S.A. § (a)(1); and

That grounds for the termination of Taylor Paige Kemp's parental rights as to Mason James Lancaster has not been proven by clear and convincing evidence, pursuant to 23 Pa.C.S.A. § (a)(2);

Further, this court finds that the record shall be reopened to permit the parties and Legal Counsel for the child to submit additional evidence relevant to the child's individual developmental, emotional, and physical needs and welfare, to include but not be limited to a bonding assessment and an interactional evaluation of the child and the parties. The parties shall have a period of ninety (90) days to gather that additional evidence. A further hearing for this matter shall occur on October 19, 2023, at 9:30 a.m. in Courtroom Number 6.
