BUTLER COUNTY DOMESTIC RELATIONS COURT-APPOINTED ATTORNEY INFORMATION, QUALIFICATIONS AND REQUIREMENTS INFORMATION

The Butler County Domestic Relations Section conducts Contempt Court, also referred to as Support Court, two times per month. These hearings are generally scheduled to address a petition for contempt generated by the Domestic Relations Section. Contempt petitions are typically generated as a result of a non-custodial parent's failure to comply with the terms of a child support obligation; i.e. they've failed to pay their child support. As there is a potential for the non-custodial parent to be found in contempt and possibly incarcerated, the Butler County Courts provide counsel for non-custodial parents who would like to have legal representation at this hearing.

When the court's calendar is published (generally in November for the following year), a representative from the Domestic Relations Section will coordinate with the court-appointed attorneys to develop a schedule, typically scheduling two attorneys to be present for each court day.

Domestic Relations completes a summary sheet for each case that is scheduled for court. The summary sheet provides case information, payment information, and a brief summary as to why the case has

been scheduled. Court lists are emailed to the court appointed attorneys three weeks prior to the schedule hearing date; this permits sufficient time to review for conflicts. Summary sheets are emailed to the court-appointed attorneys two days prior to the hearing so that they may be aware of the specifics for each case prior to the hearing.

Contempt Court is usually scheduled for Wednesday mornings. Attorneys are encouraged to be present no later than 9:00 a.m. Non-custodial parents arrive at 8:45 a.m., and hearings typically begin at 9:30 a.m. Before court begins, the expectation is for court-appointed attorneys to meet with non-custodial parents and representatives from the Domestic Relations Section. The goal is to reach a resolution or agreement to resolve the contempt petition before court begins. If this can be achieved, the agreement is put on the record once the case is called. The volume of cases impacts when contempt court is finished for the day, but usually court is ended by 12:00 p.m.

There are times when a Probation or Parole Violation Hearing is scheduled on a separate date. When this happens, the Domestic Relations Probation Officer will contact a DRS court- appointed attorney to represent the non-custodial parent at the violation hearing.

Pursuant to Administrative Order MsD. No. 012-22, court-appointed attorneys

are paid at the rate of \$75.00 per hour. Domestic Relations prepares invoices for court-appointed attorneys to sign when they appear for court. In order to receive payment, court-appointed attorneys must be an approved vendor with the County of Butler. For information on how to become an approved vendor, contact the Family Court Administrator.

Court appointment responsibilities are limited only to those activities done during contempt court or at a probation/parole violation hearing. Any additional work performed on a case outside of this scope cannot be invoiced to the County of Butler, nor will the County of Butler compensate for any work performed outside of these venues.

Qualifications

Attorneys must meet the following qualifications to be a court-appointed attorney:

- 1. Must be a Pennsylvania licensed attorney in good standing.
- 2. Must maintain professional liability insurance at a minimum coverage of \$100,000.00 per occurrence and \$300,000.00 in the aggregate per year.

Requirements

Prior to receiving any court appointments, attorneys must provide the following information to the Family Court Administrator.

- 1. Proof of being a licensed attorney in Pennsylvania in good standing.
- 2. Proof of having professional liability insurance as set forth in the qualifications listed above.
- 3. Be an approved vendor with the County of Butler.
- 4. Provide a telephone number and email address to be able to receive court appointment information. Court-appointed attorneys must also be able to communicate with the DRS and other court-appointed attorneys via email in instances of conflicts and schedule changes.

Appointments

The Domestic Relations Section shall maintain a list of attorneys who meet the requirements set forth above. Any attorney interested in receiving DRS court appointments shall submit their information to the Family Court Administrator either in person, via mail, or by emailing their information to CSButler@PACSES.com.

This *Administrative Order of Court* shall remain in effect until further *Order of Court*.
