1. Plaintiff claims that in purchasing the home, he relied upon representations provided to him in October 2015 through a Seller's Property Disclosure Statement. He further alleges that on February 25, 2016, following a torrential rainfall, the basement of his new home was flooded. He brought suit against the Defendants claiming negligent misrepresentation and fraud.

2. Plaintiff's causes of action were initiated by issuance of a Writ of Summons on December 11, 2017. There is no proof in the record that the Writ of Summons was ever served on Defendants.

3. Nevertheless on October 3, 2018, Plaintiff filed a Complaint against Defendants. On December 31, 2019, a Praecipe to Reinstate the Complaint was filed with the Prothonotary's Office.

4. Currently before the Court is Defendant's Motion for Judgment on the Pleadings seeking dismissal of the cause of action as barred by the statute of limitations.

5. Instantly, there is no evidence in the record or alleged in the pleadings that Plaintiff took any action to serve the writ following its issuance on December 11, 2017. Pursuant to *Lamp*, issuance of the writ without further service is insufficient to toll the statute. As Plaintiff's next act of record was the filing of the Complaint on October 3, 2018, more than seven months following expiration of the statute of limitations, judgment on the pleading in favor of the Defendants will be granted.

OPINION

Plaintiff, Kevin A. Gass, claims he purchased a home from the Defendants, David and Marcia Forsythe, which settled on December 18, 2015.¹ Plaintiff claims that in purchasing the home, he relied upon representations provided to him in October 2015 through a Seller's Property Disclosure Statement. He further alleges that on February 24, 2016, following a torrential rainfall, the basement of his new home was flooded. He has brought suit against the Defendants claiming negligent misrepresentation and fraud.

Plaintiff's causes of action were initiated by issuance of a Writ of Summons on December 11, 2017. There is no proof in the record that

the Writ of Summons was ever served on Defendants. Nevertheless, on October 3, 2018, Plaintiff filed a Complaint against Defendants.² On December 31, 2018, a Praecipe to Reinstate the Complaint was filed with the Prothonotary's Office. On February 26, 2019, Defendants filed an Answer to the Complaint and alleged in New Matter that the suit was barred by the statute of limitations provisions of 42 Pa. C.S.A. § 5524(7)³. Currently before the Court is Defendants' Motion for Judgment on the Pleadings seeking dismissal of the cause of action as barred by the statute of limitations.

As Plaintiff's causes of action sounds in negligence and fraud, the applicable statute of limitations for initiating the litigation is two years from the date of discovery. 42 Pa. C.S.A. § 5524(7); *see also* **Brooks v. Sagovia**, 636 A.2d 1201, 1203 (Pa. Super. 1994) (under "discovery rule" statute of limitations does not run while plaintiff is unaware of injury). According to Plaintiff's Complaint, he became aware of his injury on February 24, 2016 when he discovered his flooded basement. As such, the statute of limitations required Plaintiff to initiate his cause of action on or before February 24, 2018. As Plaintiff failed to properly initiate a cause of action prior to that date, judgment on the pleadings in favor of the Defendants will be granted.

It is not in dispute that Plaintiff requested the issuance of a writ of summons well within the statutory time period on December 11, 2017. However, that action standing alone was insufficient to toll the statutory time limit. In addition to the Rules of Civil Procedure permitting the commencement of an action by either the filing of a praecipe for writ of summons or complaint, Pa. R. Civ. P. 1007, the rules also impose a duty on the plaintiff to effectuate original service of the pleading within 30 days after issuance of the writ or filing of the complaint. Pa. R. Civ. P. 400, 401. In *Lamp v. Heyman*, 366 A.2d 882 (Pa. 1976), the Pennsylvania Supreme Court weighed the

² The original cause of action initiated by writ included Jason Masters and Masters Home Inspections, LLC as Defendants, however, these parties were not included as parties in Plaintiff's Complaint. Plaintiff's Complaint also included his realtor who was dismissed from this action by Order of Court dated April 11, 2019 sustaining the realtor's Preliminary Objections.

interaction of these rules and concluded that the commencement of a civil action pursuant to the Rules of Civil Procedure is only effective to stay the statute of limitations "if the plaintiff then refrains from a course of conduct which serves to stall in its tracks the legal machinery...just set in motion." *Lamp*, *supra*, A.2d at 889. Specifically, the Court found that where a plaintiff brings a cause of action but does not make a good faith effort to notify the defendant within the time period identified in the Rules of Civil Procedure, the statute of limitations is not tolled. *Id.*; *see also Trivitt v. Serfass*, 56 Adams County L. J. 125 (2014) 2013-S-873 affirmed 1596 MDA 2014 (Pa. Super. 2015) (petition for allowance of appeal denied March 24, 2016).

Instantly, there is no evidence in the record or alleged in the pleadings that Plaintiff took any action to serve the writ following its issuance on December 11, 2017. Pursuant to *Lamp*, issuance of the writ without further service is insufficient to toll the statute. As Plaintiff's next act of record was the filing of the Complaint on October 3, 2018, more than seven months following expiration of the statute of limitations, judgment on the pleadings in favor of the Defendants will be granted.

For the reasons set forth hereinabove, the attached Order of Court is entered.

ORDER OF COURT

AND NOW, this 7th day of February, 2020, it is hereby Ordered that judgment on the pleadings is granted in favor of the Defendants and against the Plaintiff in this matter. Accordingly, the Adams County Prothonotary's Office is directed to enter judgment in favor of the Defendants. As no remaining causes of action are viable, the Prothonotary's Office is directed to mark this matter closed.
