District Attorney's Office — Press Release

COUNTY AND LOCAL EMERGENCY RESPONDERS RECEIVE TRAINING AND BLEEDING CONTROL KITS

March 30, 2022 — Wayne County District Attorney A.G. Howell announced today that thirteen Wayne County emergency responders received training called "Stop The Bleed". The free training was conducted by nurses from Geisinger trauma services. The training is designed to be used by anyone to help control bleeding during a traumatic incident. Each student received a bleeding control kit at the end of the training.

The kits supplement the nationwide Stop the Bleed training program. Launched as a collaboration between the Department of Homeland Security, the White House and other agencies, Stop the Bleed trains ordinary citizens – and



potential bystanders – how to help during a severe-bleeding incident before medical professionals arrive on scene.

"Uncontrolled bleeding is the number one cause of preventable death in someone who is injured," said Dr. Brian Frank, Geisinger Community Medical Center trauma surgeon and co-chair of Geisinger's Stop the Bleed program. "A

person can bleed to death from an arterial bleed in 3 to 5 minutes. Being able to control or stop blood loss greatly increases a victim's survival chance."

"No one expects to be involved in a traumatic incident," said Dr. Denise Torres, trauma services director for Geisinger. "Trauma from vehicle crashes, industrial accidents and deep cuts or wounds at home are far more common than trauma from violent acts. Being able to recognize traumatic bleeding and controlling or slowing blood loss until emergency crews arrive is critical."

Geisinger trauma services offers free Stop the Bleed classes to organizations throughout the year. Geisinger's Stop the Bleed program is a joint effort of Geisinger emergency medicine, trauma services, trauma outreach, Life Flight and Geisinger EMS. To learn more about Stop the Bleed, contact Geisinger at stopthebleed@geisinger.edu.

Members of the Wayne County Sheriff's Department, Wayne County 9-1-1, Honesdale Borough Police Department, Damascus Volunteer Ambulance and Wayne County Detectives attended the training. In addition to receiving personal bleeding control kits, the County received two wall-mounted bleeding control stations, containing eight bleeding control kits each. These kits will be placed prominently in the County buildings.

PRESS RELEASE

March 31, 2022 — K9 officers and their handlers visited Honesdale High School and Middle School on Tuesday, March 29, 2022, to conduct a proactive narcotic sweep at the request of the district administration.

The search was requested to "maintain a safe and secure learning environment," said District Attorney A.G. Howell.

"When a school district requests a search, law enforcement will work with the district to schedule and assist with the search. We know that increased access to drugs and other substances are a concern for school districts, parents, and law enforcement."

DA Howell said all lockers were searched but no narcotics were located.

Due to the number of lockers, three K9 officers were required to complete the search. Wayne County Sheriff's Department K9 deputy "Manfred," Lackawanna County District Attorney's Office K9 Detective "Riggs," and City of Scranton K9 Officer "Gunnar" along with their handlers, Deputy Ronald Kominski, Lackawanna County Detective Vince Butkiewicz, and Scranton Police Officer Jerry Tallo searched the high school and middle school.

"Keeping students safe and drug-free remains a priority for area school districts, the district attorney's office, and area law enforcement," Howell said.

The K9s are specially trained to detect narcotics. They signal their handlers when they sense a presence of a narcotic. K9 handlers go through extensive training with their K9s to learn the animals' behaviors as well as to stay current on drug trends and concealment methods.

The Wayne Highlands School District Police were present, along with the District Attorney, Wayne County Detectives, Wayne County Sheriff and Honesdale Police accompanying the K9s.

Wayne County District Attorney A.G. Howell announced the following case was addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — March 31, 2022

ALYSSA M. BRIGGS, age 36 of Lake Ariel Pa, was sentenced to 15 months probation for one count of Possession of Controlled Substance-Delta 9 THC (M), and one count of Possession of Drug Paraphernalia (M). She was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, continue compliance with Healthy Moms Program, and obtain employment within 30 days of medical release or provide documentation from a doctor precluding her from employment. The incident occurred on June 25, 2021 in Honesdale Borough.

DOUGLAS S. BRENNAN, age 66 of Newfoundland Pa, was placed on the Accelerated Rehabilitation Disposition Program for a period of 6 months related to a DUI. He was also ordered to pay all costs, complete 20 hours of community service, complete the Alcohol Highway Safety Program, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, and have his operator's license suspended for a period of 30 days. The incident occurred on January 31, 2022 in Dreher Township.

ANTHONY G. BUNEVITCH, age 47 of Browndale Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 1 month nor more than 23 1/2 months for one count of Theft by Unlawful Taking or Disposition (F3). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$9,763.39, undergo a mental health evaluation and comply with any recommendations for treatment, and obtain employment within 30 days of parole or provide documentation from a doctor precluding him from employment. The incident occurred between April 11, 2021 and June 5, 2021 in Waymart Borough.

TRAVIS J. CARNEY, age 40 of Beach Lake Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 15 days followed by 36 months probation with 90 days House Arrest with Electronic and Alcohol Monitoring through the SCRAM program for one count of DUI-Highest Rate (M1). He was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of \$1,500.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and complete 20 hours of community service. The incident occurred on July 30, 2021 in Damascus Township.

SEAN CLINTON, age 41 of Lake Ariel Pa, was sentenced to undergo incarceration in a State Correctional Institution for a period of not less than 18 months nor more than 60 months for one count of Possession of Controlled Substance with Intent to Deliver (Cocaine)(F). He was also ordered to pay the costs of prosecution. The incident occurred between October 14, 2020 and November 19, 2020 in Paupack Township.

CODY KIZER, age 30 of Lake Ariel Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 33 days nor more than 12 months for one count of Possession of Controlled Substance-Methamphetamine (M) and one count of Defiant Trespass (S). He was also ordered to pay the costs of prosecution, pay a fine of \$100.00, continue with mental health and drug and alcohol treatment and comply with all recommendations for treatment, comply with and participate in Certified Recovery Services provided by Wayne County Drug and Alcohol, and maintain employment while on parole or provide documentation from a doctor precluding him from employment. The incident occurred on August 8, 2021 in Salem Township.

BRANDY MARIE MARIENSCHEK, age 39 of Jermyn Pa, was sentenced to undergo incarceration in a State Correctional Institution for a period of not less than 4 years nor more than 8 years for two (2) counts of Possession with Intent to Deliver-Heroin (F), one count of Endangering the Welfare of Children (M2), one count of Possession with Intent to Deliver-Methamphetamine (F), one count of Buying/Exchanging Supplemental Nutritional Assistance Program Benefits (M1). She was also ordered to pay the costs of prosecution, and pay restitution in the amount of \$30.00. The incidents occurred on August 27, 2020 in Berlin Township, between November 19, 2020 and December 5, 2020 in Waymart Borough, between December 14, 2020 and December 21, 2020 in Waymart Borough, and on December 21, 2020 in Texas Township.

WILFREDO C. SANTOS, age 49 of Beach Lake Pa, was sentenced to 6 months probation with 72 hours House Arrest with Electronic Monitoring through the SCRAM program, for one count of DUI: Controlled Substance/Combination Alcohol (M). He was also ordered to pay the costs of prosecution, pay the mandatory minimum fine of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and maintain employment or provide documentation from a doctor precluding him from employment. 
