PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE

DRUG DELIVERY RESULTING IN DEATH TRIAL ENDS IN GUILTY VERDICT

November 19, 2020 — A Pike County jury rendered a guilty verdict in a drug delivery resulting in death trial on Wednesday November 18, 2020. The jury found Lisa Schmidt, age 50, of Bushkill guilty of the charges of Delivery of a Controlled Substance Resulting in Death, Criminal Conspiracy of Delivery of a Controlled Substance Resulting in a Death, and Delivery of a Controlled Substance, all Felonies. Schmidt will face sentencing on January 7, 2021, where she faces a maximum sentence of up to 40 years in prison on the drug delivery resulting in death charge.

The original investigation began in November 2017 with the overdose death of Jennifer Bosch in Westfall Township. After Eastern Pike Regional Police Department originally responded to the scene, the Pike County District Attorney's Office Criminal Investigation Division joined the investigation.

Soon detectives joined forces with Pennsylvania State Police investigators who were investigating two other overdose deaths in Pike County. After a joint investigation, investigators arrested three individuals, Katie Woolsey, Gianna Rose and Lisa Schmidt. Woolsey and Rose previously entered guilty pleas and were sentenced to state prison sentences.

Pike County President Judge Gregory H. Chelak presided over the trial in a social distanced main courtroom at the Pike County Courthouse. The court made different seating arrangements in the courtroom for jurors, witnesses and the parties in the case.

After the verdict District Attorney Tonkin complimented the jury and the Court saying "The jury carefully listened to all of the evidence and rendered the proper verdict and court officials did an outstanding job working to insure a safe environment to conduct the trial. These times are definitely different and we appreciate the jurors who served on the jury during these times of some uncertainty."

Tonkin went on further to express that investigators and his office will continue to aggressively pursue cases where drugs have caused the death of an individual and someone unlawfully provided them. Tonkin stated "these drug deaths leave an enormous hole in the heart of the families and in the community and we will do our best to seek justice in these cases."

District Attorney Tonkin and Assistant District Attorney Jamie Wagenhoffer prosecuted the case for the District Attorney's Office.


