Civil Action - Defamation/Gross Negligence/Fraud

The Court granted Defendants TSG and Michael Levine's Preliminary Objections to Plaintiffs' Complaint and Defendant Mount Airy's Motion for Judgment on the Pleadings. The Court found that Plaintiff failed to state a claim for defamation, gross negligence and fraud because Defendants were protected by the quasi-judicial privilege for the statements that were made.

- Mount Airy is a gaming license holding company that contracts with codefendant TSG to provide iGaming websites and apps, including a website and app called "PokerStars." Plaintiff filed a complaint regarding certain gameplay features of PokerStars with the Pennsylvania Gaming Control Board ("PGCB"), which prompted an investigation by the PGCB into the gameplay of PokerStars. As part of that investigation, the PGCB corresponded by email with Defendant Levine, who is a TSG employee. Plaintiff brought the instant action for allegedly defamatory statements that Defendant Levine made in an email to a PGCB representative.
- Defendants argued that they were protected by the quasi-judicial privilege as the statements were made during the course of the PGCB's investigation into PokerStars.
- In order for a communication to be protected by the quasi-judicial privilege, the communication "would need to have been pertinent and material and would need to have been issued in the regular course of preparing for contemplated proceedings." <u>Post v. Mendel</u>, 510 Pa. 213, 223, 507 A.2d 351, 356 (1986).

MEMORANDUM OPINION

Presently pending before this Court are Preliminary Objections to Plaintiff's Complaint that were filed by Defendants TSG Interactive US Services Limited (hereinafter "TSG") and Michael Levine (hereinafter "Levine") as well as the Motion for Judgment on the Pleadings that was filed by Defendant Mount Airy #1, LLC (hereinafter "Mount Airy"). The background of this case is as follows: Mount Airy is a gaming license holding company that contracts with co-defendant TSG to provide iGaming websites and apps, including a website and app called "PokerStars." Plaintiff filed a complaint regarding certain gameplay features of PokerStars with the Pennsylvania Gaming Control Board ("PGCB"), which prompted an investigation by the PGCB into the gameplay of PokerStars. As part of that investigation, the PGCB corresponded by email with Defendant Levine, who is a TSG employee. Plaintiff brings the instant action for allegedly defamatory statements that Defendant Levine made in an email to a PGCB representative.¹

Plaintiff filed his Complaint on March 1, 2023 alleging three counts as follows: Count I – Defamation; Count II – Gross Negligence; and Count III – Fraud. Defendant Mount Airy filed an Answer with New Matter to Plaintiff's Complaint on April 18, 2023. Defendants TSG and Levine filed Preliminary Objections to Plaintiff's Complaint on June 12, 2023. Thereafter, on July 13, 2023, Mount Airy filed a Motion for Judgment on the Pleadings, which essentially reiterated the arguments that Defendants TSG and Levine made

in their Preliminary Objections. We heard oral argument on October 24, 2023, and the matter is now ripe for a decision.

Initially, Plaintiff argues that Defendants' Preliminary Objections are untimely. However, it does not appear as if Plaintiff properly served Defendant TSG, and he never served Defendant Levine. As a result, their Preliminary Objections cannot be deemed untimely because they were never properly served. Moreover, Defendants TSG and Levine acknowledge that they have waived any arguments of improper service by filing their Preliminary Objections. As such, we may consider Defendants' Objections as timely filed.

Defendants first argue that Plaintiff's alleged defamation claim and derivative tort claims are barred because Levine's statements are covered by the quasi-judicial privilege.

Pennsylvania, like many other jurisdictions, recognizes a judicial privilege providing immunity for communications which are made in the regular course of judicial proceedings and are material to the relief sought. The privilege covers statements by a party, a witness, an attorney, or a judge. Furthermore, the privilege is absolute, meaning that, where it attaches, the declarant's intent is immaterial even if the statement is false and made with malice.

Schanne v. Addis, 632 Pa. 545, 553–54, 121 A.3d 942, 947 (2015) (internal citations omitted). This judicial privilege applies to quasi-judicial proceedings as well. "The test to determine if a function is 'quasi-judicial' is whether it involves the exercise of discretion and requires notice and a hearing." Greenberg v. McGraw, 161 A.3d 976, 983–84 (Pa. Super. Ct. 2017) (citations omitted). More specifically, courts look to whether there is "the presence and exercise of discretionary decision-making authority" as well as "procedural safeguards in the administrative proceeding similar to the safeguards afforded at a judicial proceeding. Id. at 984 (citations omitted). The Pennsylvania Supreme Court has previously held that the PGCB is a quasi-judicial body with fact-finding and deliberative responsibilities. Riverwalk Casino, LP v. Pennsylvania Gaming Control Bd., 592 Pa. 505, 520–21, 926 A.2d 926, 935 (2007).

The quasi-judicial privilege doesn't just protect communications made in open court. Rather, it "encompasses pleadings and even less formal communications such as preliminary conferences and correspondence between counsel in furtherance of the client's interest." <u>Pawlowski v. Smorto</u>, 403 Pa.Super. 71, 81, 588 A.2d 36, 41 (1991)

(citations omitted). For communications that are made prior to the institution of proceedings, in order to be protected, the communication "would need to have been pertinent and material and would need to have been issued in the regular course of preparing for contemplated proceedings." <u>Post v. Mendel</u>, 510 Pa. 213, 223, 507 A.2d 351, 356 (1986).

In the instant matter, the parties have agreed that the PGCB was investigating a complaint made by Plaintiff about the gameplay in PokerStars, which is a website and app that is provided by Defendants Mount Airy and TSG. It is also undisputed that Plaintiff did not experience the problems with the PokerStars gameplay about which he complained. In fact, at the time of his Complaint to the PGCB, Plaintiff did not even have an active profile on PokerStars. Finally, there is no question that Defendant Levine made the allegedly defamatory statements to one PGCB employee during the course of their investigation into the Plaintiff's Complaint.

Since the Pennsylvania Supreme Court has previously held that the PGCB is a quasi-judicial body, it cannot be disputed that their investigations into Plaintiff's complaint would constitute a quasi-judicial proceeding. As such, the quasi-judicial privilege would apply to protect the allegedly defamatory statements made by Defendant Levine as long as such statements were pertinent and material to the investigation. To that end, the Pennsylvania Superior Court has previously stated that:

It is not necessary that the defamatory matter be relevant or material to any issue before the court. It is enough that it have some reference to the subject of the inquiry. Thus, while a party may not introduce into his pleadings defamatory matter that is entirely disconnected to the litigation, he is not answerable for defamatory matter volunteered or included by way of surplusage in his pleadings if it has any bearing upon the subject matter of the litigation. The fact that the defamatory publication is an unwarranted reference from the alleged or existing facts is not enough to deprive the party of his privilege, if the inference itself has some bearing upon the litigation.

Milliner v. Enck, 709 A.2d 417, 420-21 (Pa. Super. Ct. 1998).

Upon review of the allegedly defamatory statements made by Defendant Levine, we find that they are protected by the quasi-judicial privilege. Although Plaintiff was not, himself, the subject of the investigation, he was the person who initiated the investigation. Therefore, Plaintiff is integral to the investigation because there would not have been an investigation but for Plaintiff's complaint. As a result, any allegedly defamatory

statements made about Plaintiff by Defendant Levine have some bearing on the investigation in that they refer to Plaintiff's proposed motives in filing the complaint with the PGCB. Plaintiff's motives in filing the complaint with the PGCB about an issue with the PokerStars software that he never experienced does have a bearing on the PGCB's investigation. For these reasons, we find that the allegedly defamatory statements made by Defendant Levine are absolutely protected by the quasi-judicial privilege, and Plaintiff cannot maintain any cause of action against any of the Defendants based on those statements.²

For the above reasons, we hereby enter the following Order:

ORDER

AND NOW, this 1st day of November, 2023, upon consideration of Defendants TSG Interactive US Services Limited's and Michael Levine's Preliminary Objections" and Plaintiff's response thereto as well as Defendant Mount Airy #1 LLC's Motion for Judgment on the Pleadings and Plaintiff's response thereto, and having heard oral argument on October 24, 2023, it is hereby ORDERED, for the reasons set forth in the attached Memorandum Opinion as follows:

- Defendants TSG and Levine's Preliminary Objections and Defendant Mount Airy's Motion for Judgment on the Pleadings are GRANTED;
 - 2. Plaintiff's Complaint is hereby DISMISSED with prejudice.
