NOTICE IS HEREBY GIVEN that the Borough Council of Boswell, Somerset County, Pennsylvania, will act on the adoption of an Ordinance as hereinafter set forth at the regular meeting of Borough Council to be held at the Boswell Borough Municipal Building, 504 Hower Avenue, Boswell, Pennsylvania, on Monday, October 9, 2023, at 6:30 p.m. The title and summary of the

Ordinance is as follows:

ENTITLED " AN ORDINANCE OF THE BOROUGH OF BOSWELL CREATING A PERMITTING PROCESS FOR AMUSEMENT GAMBLING DEVICES."

Said Ordinance shall be cited as the "Amusement Gambling Devices Permitting" and provides that an Amusement Gambling Device shall be defined as any mechanical or electronic device, that, upon Insertion of currency or the like, operates or may be operated as a game or contest of skill, amusement or entertainment of any kind or description, and that provides the opportunity to acquire or earn additional money than what was originally placed In said device, and further sets forth the process for obtaining a permit to operate an Amusement Gambling Device, the discretion of the Borough Council to limit the number of permits Issued per year and per establishment, and sets forth penalties for violations of any provision of said Ordinance.
