The initial fee shall be \$150 per ERU per calendar year subject to adjustment based upon a study of impervious areas of properties served by the Borough system completed by the Borough Engineer not later than the end of April 2019. Subsequent years' fees shall be set by the Authority and all years' fees shall be subject to appeal to the Borough Manager pursuant to procedures established not later than the end of April 2019 and amended from time to time by the Authority. Fees shall be billed without discount concurrently with real estate tax bills sent by the Borough, collected by the Borough, and collections allocated to the Authority which shall use the proceeds only for the purposes set forth in §5607(d)(9), (18) and (34) including, in calendar year 2019 and thereafter, stream bank stabilization as mandated by the Pennsylvania Department of Environmental Protection.
