#### JAMES P. ANDERSON VS. LISA ANDERSON

1. Wife was served with the Complaint and Husband's §3301(d) Affidavit via certified mail on September 7, 2021.

2. On October 12, 2021, Wife filed a Counter-Affidavit pursuant to §3301(d) of the Divorce Code.... On her Counter-Affidavit, Wife checked the box numbered "(1) (b)" indicating that she opposed the entry of a divorce decree because "there are economic claims pending." Wife also checked the box numbered "(2)(b)" indicating, "I wish to claim economic relief, which may include alimony, division of property, lawyer's fees, costs and expenses, or other important rights." Of significant import, Page 2 of Wife's Counter-Affidavit clearly states:

I UNDERSTAND THAT IN ADDITION TO CHECKING (2)(b), I MUST ALSO FILE ALL OF MY ECONOMIC CLAIMS IN WRITING AND SERVE THEM ON THE OTHER PARTY. IF I FAIL TO DO SO BEFORE THE DATE SET FORTH ON THE NOTICE OF INTENTION TO FILE THE PRAECIPE TO TRANSMIT THE RECORD, THE DIVORCE DECREE MAY BE ENTERED WITHOUT FURTHER NOTICE TO ME, AND I MAY BE UNABLE TO THEREAFTER FILE ANY ECONOMIC CLAIMS.

3. This effectively placed Wife and her counsel on notice that, if economic claims were not properly raised before February 10, 2022, a decree would be entered foreclosing those claims.

4. Upon receipt of Husband's Praecipe to Transmit Record, the Court reviewed the record, determined the legal requirements were met, and entered a final decree on March 2, 2022, granting the divorce on the grounds of irretrievable breakdown under \$3301(d) of the Divorce Code. No appeal was filed. Husband's spousal support obligation was terminated by operation of law.

5. Wife maintains that her prior counsel's failure to property file and preserve her claims for economic relief due to mistake of fact and mistake in understanding divorce law caused her to suffer direct and significant financial harm and serve as a basis to open or rescind the decree.

6. The inadvertent exclusion of economic claims due to Wife's counsel's oversight does not constitute "extraordinary cause" which permits a trial court to grant relief from a final judgment entered in a contested action.

#### **OPINION**

This case arises from Defendant's (hereinafter "Wife") Petition to Open Divorce Decree filed on March 31, 2022.

Plaintiff (hereinafter "Husband") filed a Response to Defendant's Petition to Open Divorce Decree on April 27, 2022. This Court directed both parties to file briefs prior to the date of hearing. The hearing on Wife's Petition was held on May 18, 2022. This case is now ready for disposition.

#### GENERAL BACKROUND

On September 21, 2021, Husband filed a Divorce Complaint under Section 3301(c) and 3301(d) of the Divorce Code and an Affidavit pursuant to Section 3301(d) of the Divorce Code. On September 7, 2021, Wife accepted service of the Complaint and Affidavit via certified mail. On October 7, 2021, Matthew R. Battersby, Esquire, entered his appearance to represent Wife in the divorce action. On October 12, 2021, Wife filed a Counter-Affidavit pursuant to Section 3301(d) of the Divorce Code, which was signed by Wife. On the Counter-Affidavit, Wife checked the box indicating that economic claims were pending. The Counter-Affidavit contained the following provision:

I UNDERSTAND THAT IN ADDITION TO CHECKING (2)(b), I MUST ALSO FILE ALL OF MY ECONOMIC CLAIMS IN WRITING AND SERVE THEM ON THE OTHER PARTY. IF I FAIL TO DO SO BEFORE THE DATE SET FORTH ON THE NOTICE OF INTENTION TO FILE THE PRAECIPE TO TRANSMIT RECORD, THE DIVORCE DECREE MAY BE ENTERED WITHOUT FURTHER NOTICE TO ME, AND I MAY BE UNABLE TO THEREAFTER FILE ANY ECONOMIC CLAIMS.

However, at the time Wife filed the Counter-Affidavit, neither party had raised economic claims. On January 18, 2022, Husband properly served a Notice of Intention to File the Praecipe to Transmit Record on Wife's counsel. As of that date, neither party filed to raise economic claims. In the Notice, Husband informed Wife that he intended to file a Praecipe to Transmit Record on or after February 10, 2022, which would request that the Court enter a final decree in divorce. Wife was aware, based on the signed Counter-Affidavit filed, that if economic claims were not raised before February 10, 2022, she would be foreclosed from pursuing those claims.

On February 25, 2022, Husband properly filed a Praecipe to Transmit Record. As of that date, no economic claims had been raised. On February 28, 2022, Wife's counsel, Attorney Battersby, filed a Petition to Withdraw. The Court granted this Petition on March 14, 2022.

On March 2, 2022, this Court entered a final Decree of Divorce. On March 31, 2022, Wife filed a Petition to Open the Divorce Decree as well as an Answer to the Divorce Complaint with Counterclaims. Wife's main reason for filing the Petition to Open the Divorce Decree was because she thought that her prior counsel had filed economic claims on her behalf when he in fact did not. On April 5, 2022, a Rule to Show Cause was issued by this Court regarding Wife's Petition, which was 34 days after the final Divorce Decree was entered. No other action was taken by this Court from the date the Divorce Decree was entered until the date the Rule to Show Cause was issued.

At the hearing, Wife testified that she requested her previous counsel, Matthew R. Battersby, Esquire, file economic claims on her behalf, prior to the entry of the Divorce Decree. Attorney Battersby testified that he made a mistake in failing to file economic claims on Wife's behalf.

#### **DISCUSSION**

"Except as otherwise provided or prescribed by law, a court upon notice to the parties may modify or rescind any order within 30 days after its entry, notwithstanding the prior termination of any term of court, if no appeal from such order has been taken or allowed."

#### § 5505. Modification of orders, PA ST 42 Pa.C.S.A. § 5505

A motion to open a decree of divorce or annulment may be made only within the period limited by 42 Pa.C.S. § 5505 (relating to modification of orders) and not thereafter. The motion may lie where it is alleged that the decree was procured by intrinsic fraud or that there is new evidence relating to the cause of action which will sustain the attack upon its validity. A motion to vacate a decree or strike a judgment alleged to be void because of extrinsic fraud, lack of jurisdiction over the subject matter or a fatal defect apparent upon the face of the record must be made within five years after entry of the final decree. Intrinsic fraud relates to a matter adjudicated by the judgment, including perjury and false testimony, whereas extrinsic fraud relates to matters collateral to the judgment which have the consequence of precluding a fair hearing or presentation of one side of the case.

#### § 3332. Opening or vacating decrees, PA ST 23 Pa.C.S.A. § 3332

The trial court's broad discretion is lost, however, if the court fails to act within 30 days. After this 30-day period, an order can only be opened or vacated if there is fraud or some other circumstance so grave or compelling as to constitute 'extraordinary cause' justifying intervention by the court. An oversight by counsel in failing to appeal does not constitute "extraordinary cause" which permits a trial court to grant relief from a final judgment entered in a contested action.

*Justice v. Justice*, 612 A.2d 1354, 1357, 417 Pa.Super. 581, 586–87 (Pa.Super.,1992)(citations omitted)

By the expression 'extrinsic or collateral fraud' is meant some act or conduct of the prevailing party which has prevented a fair submission of the controversy. Among these are the keeping of the defeated party away from court by false promise of compromise, or fraudulently keeping him in ignorance of the action. Another instance is where an attorney without authority pretends to represent a party and corruptly connives at his defeat, or where an attorney has been regularly employed and corruptly sells out his client's interest. The fraud in such case is extrinsic or collateral to the question determined by the court.

*Fenstermaker v. Fenstermaker*, 502 A.2d 185, 188, 348 Pa.Super. 237, 243 (Pa.Super.,1985)(emphasis added)

Wife asserts that because she **filed** her Petition to Open the Decree within thirty days from the Decree being entered, then **PA ST 42 Pa.C.S.A. § 5505** should apply. However, for § **5505** to apply, the

Court must **act** within thirty days of the Decree being entered. The Decree was entered on March 2, 2022. Wife filed her Petition to Open Divorce Decree on March 31, 2022. This gave the Court until April 1, 2022, one day past Wife filing her Petition, to act or the Court would lose its broad authority. The Court did not act on Wife's Petition by April 1, 2022.

The only other avenue that this Court could vacate the Divorce Decree would be through **PA ST 23 Pa.C.S.A. § 3332**. However, **§ 3332**, requires that Wife prove extrinsic fraud existed in her case. Wife's previous counsel, Matthew R. Battersby, Esquire, testified at the hearing that he made a mistake in failing to file economic claims on Wife's behalf, despite her requesting that he do so. Wife has made no allegations that Husband, or Husband's attorney on behalf of Husband, committed fraud of any kind.

*Fenstermaker*, *supra*, indicates that extrinsic fraud can be when an "attorney has been regularly employed and corruptly sells out his client's interest." Justice, supra, indicates that an attorney's failure to file an appeal, does not constitute extrinsic fraud. Similarly, an attorney's mistake wherein the attorney fails to file economic claims on his client's behalf, despite the client requesting that the attorney file economic claims, does not amount to extrinsic fraud, which would permit this Court to vacate the Decree.

Accordingly, the attached Order is entered.

#### ORDER OF COURT

AND NOW, this 16th day of June, 2022, in accordance with the attached Opinion, IT IS ORDERED that the Defendant's Petition is DENIED.
