- 1. On appeal from a Zoning Hearing Board decision, the standard of review of a trial court is whether the Zoning Hearing Board made an error of law or abused its discretion.

In order for a variance to be granted, an applicant must show that: (a) an unnecessary hardship will result if the variance is denied due to the unique physical circumstances or conditions of the property; (b) because of such physical circumstances or conditions the property cannot be developed in strict conformity with the provisions of the zoning ordinance and a variance is necessary to enable the reasonable use of the property; (c) the hardship is not self-inflicted; (d) granting the variance will not alter the essential character of the neighborhood nor be detrimental to the public welfare; and (e) the variance sought is the minimum variance that will afford relief.
- 4. The reasons for granting a variance must be substantial, serious and compelling, and the party seeking the variance bears the burden of proving unnecessary hardship and absence of injury to the public interest.
- 5. The court does not sit as a super zoning hearing board so as to impose its own preferences on local municipalities.
- 6. Applicant church received use variances to construct signs on its property, including a free-standing LED changeable copy message sign. The township appealed. The trial Court <u>Held</u> that the zoning hearing board's decision was reversed and the variances were denied.

Opinion

The Board of Supervisors of Sadsbury Township appeals from the Decision and Order of the Zoning Hearing Board of Sadsbury Township issued on July 2, 2012 granting the Application of Gateway Grace Community Church (the "Applicant") for variances from Sections 1404 and 1410 of the Sadsbury Township Zoning Ordinance (herein "Zoning Ordinance"). The original Applicant, Gateway Grace Community Church, has not filed a Notice of Intervention as would ordinarily be required under the Pennsylvania Municipalities Planning Code (herein "MPC") and is not participating in this appeal.

The court took no additional evidence.

The standard of review of this court is whether the Zoning Hearing Board made an error of law or abused its discretion. *Valley View Civic Assoc. v. Zoning Hearing Board of Adjustment*, 462 A.2d 637, 640 (Pa. 1983). See also, *Allegheny W. Civic Council, Inc. v. Zoning Hearing Board of Adjustment of the City of Pittsburgh*, 689 A.2d 225, 227 (Pa 1997). An abuse of discretion is determined by whether the Zoning Hearing Board made a reasonable application of the facts as presented in this case. See, *Valley View Civic Assoc.*, 462 A.2d at 640.

The facts of the case indicate that the Applicant is the legal owner of an improved lot located at 160 Cowan Road, Parkesburg, Sadsbury Township, Pennsylvania, specifically Chester County Tax Parcel No. 37-2-16-E (herein the "Property"). The Applicant sought a use variance for its land in order to place a sign on the front face of a church building. It also sought a variance in order to install a free-standing electronic message board sign on the property.

It should be noted that the Applicant is allowed under Sadsbury Township's regulations to install a free-standing message board sign that was not

electronic, meaning that someone from the Church would have to go out on a routine basis and replace by hand the various letters that make up the sign's message in order to inform the community of events (much akin to a movie theater's signs for movies currently playing). There is no limitation to how often the message could be changed. The Applicant agreed as a condition, if it were given permission to put up an electronic sign (as opposed to the permitted sign that was done by hand), that the LED message would only change once daily and that the sign would be turned off between the hours of 11:00 p.m. and 6:00 a.m. In other words, other than the electronic portion of the sign, this sign would do no more, and arguably considerably less, sign clutter than the hand-lettered sign already permitted.

The Applicant sought variances from the signage requirements of the Sadsbury Township Zoning Ordinance. Section 910.2 of the Pennsylvania Municipalities Code ("PaMPC"), 53 P.S. Section 10910.2 and Section 115-85 of the Ordinance provide the legislative basis for granting a variance. An applicant must show that: (1) an unnecessary hardship will result if the variance is denied due to the unique physical circumstances or conditions of the property; (2) because of such physical circumstances or conditions the property cannot be developed in strict conformity with the provisions of the zoning ordinance and a variance is necessary to enable the reasonable use of the property; (3) the hardship is not self-inflicted; (4) granting the variance will not alter the essential character of the neighborhood nor be detrimental to the public welfare; and (5) the variance sought is the minimum variance that will afford relief. Arter v. Philadelphia Zoning Hearing Board of Adjustment, 916 A.2d 1222 (Pa.Cmwlth. 2007). The reasons for granting a variance must be substantial, serious and compelling, and the party seeking the variance bears the burden of proving unnecessary hardship and absence of injury to the public interest. Valley View Civic Association v. Zoning Board of Adjustment, 501 Pa. 550, 462 A.2d 637 (1983).

The Ordinance already allows for the usage of both a hand-lettered sign that must be manually changed every time a new message is put up, along with separate temporary signs that can be put out to advertise further upcoming events. It may seem almost silly to allow all of that but not allow one electronic sign with LED lights instead. Not only would this allow the Church to change the sign from inside the building, but it removes the clutter of signage that would happen if temporary signs and a hand-lettered sign were allowed instead. This prompts the court to consider whether *Hertzburg v. Zoning Board of Adjustment of the City of Pittsburgh*, 554 Pa. 249, 721 A.2d 43 (1998) is applicable.

The *Hertzburg* case discusses a relaxed standard that allows for a dimensional variance within reason, but does not speak at all to any relaxed standard for

use variances. While it is arguable that using an electronic message board sign is ultimately no different than a hand-lettered sign, the problem here turns on the fact that the electronic sign, if allowed, would mean an increase in size from what is currently permitted under the Ordinance. Section 1404 of the Zoning Ordinance allows only one sign of up to 24 square feet in the Rural Residential District. The Applicant proposed two signs with a combined size of 168 square feet. In Society Created to Reduce Urban Blight v. Zoning Board of Adjustment of the City of Philadelphia (Appeal of Keystone), 771 A.2d 874, 877 (Pa. Cmwlth.), alloc. denied, 786 A.2d 991, (Pa. 2001), the court observed: "While Hertzburg eased the requirements for granting a variance for dimensional requirements . . . 'free-fire zones' for which variances could be granted when the party seeking the variance merely articulated a reason that it would be financially 'hurt' if it could not do what it wanted to do with the property . . ." In that case, the Commonwealth Court held that a variance to increase the size of a sign from 1,500 square feet to 2,400 square feet so it could be seen from the road was not justified, stating that: "requiring a larger sign just means that the lot on which the sign is located is too far from the road." Id. at 878. In this case, no severe unnecessary hardship was articulated because even using the Hertzburg standard, no compelling reason exists to warrant the grant of even a dimensional variance, given how much larger the proposed size of the new signage is, as demonstrated in the case just referenced.

Section 1410 of the Ordinance prohibits a "sign that contains a display using light emitting diodes". It is clear from this language that a sign with LED lights used to create messages falls under this umbrella. A variance from this restriction could not really be construed as a dimensional variance, but must be a use variance no matter how arguably small the difference from one use to the next may be. It might be argued that for all parties involved an unnecessary hardship is incurred by making the Applicant use a small hand-lettered sign that must be changed every time a new message is created as well as temporary signage to additionally inform the community of events. It might be easier to simply allow one larger sign that can constantly change messages without any of the hassle would decrease hardship; the gap between the two methods constitutes the unnecessary part of that hardship. Therefore, the elements that need to be established to grant a use variance, an admittedly high standard, have simply not been met here to allow the use of an LED sign.

This court does not sit as a super zoning hearing board so as to impose its own preferences on local municipalities. *Kadi v. Zoning Hearing Board of Lynn Township*, 73 Pa.Cmwlth. 295, 457 A.2d 1042 (1983). Ultimately, while it might seem that granting the variance hurts no one, helps the Applicant in its pursuit of being as efficient as possible and also helps the community to stay informed in a more streamlined manner, this court concludes that the Zoning Hearing Board committed an error of law in granting a dimensional variance with regard to Ordinance
